It would require a laborious task of an able calculator, to ascertain how many of the public defaulters owe, would cover, spread out in silver dollars. We entertain but little doubt, that if extended along the four sides of the District of Columbia, the dollars would considerably over-run the measure. From this we may gather something like an idea of the waste and corruptions, that have taken place. We may add by way of similar illustration, that it would have required a team with four good horses, heavy the bribe given to John Henry. He had chosen to take it in silver. His money was more than thrown away, because Henry had nothing of importance to tell, and so just an apprehension had he of public resentment, that he made it a part of his bargain to immediately transport to France a public vessel, to avoid indignation and vengeance.

A special court could be organized with power to punish, by one cent's fine, every falsehood uttered or printed by the democrats, or even those of Baltimore alone, since the commencement of this electioneering campaign, what a large proportion would not pay of the land tax and stamp tax, that is collected to pay the annual pensions of 15000 voted to themselves by the democrats of the last congress, at the so called election of the President, as is now loudly asserted, by those who probably have the means of knowing.

The democratic scribblers in the pay of administration, boldly assert, that the federalists obtained the late election in this state by sheer bribery, and the assertion has been repeated by every basing, wealthy demagogue of the party. Pray, if the election was carried by bribery, who were the persons bribed? Were they federalists? Reason says no; because federalists would have the federal ticket without a bribe? Were they rich or poor men, who were bribed? One would suppose they were poor men, because rich men do not want money, and of course would not be influenced by it. Then every body must conclude, that the democrats, who declare the election was carried by bribery, mean nothing less than that, the poor men of the democratic party, sold their votes to the federalists for money. Now, what poor man, who possesses common feeling and pride, would remain attached to the democratic party, which, when it is fairly defeated at an election, accuses him of having been the cause of it, by suffering himself to be bribed? This shows how poor men, how low their honour and integrity is valued by the leading demagogues.

From the formidableness of the force which Lord Exmouth, before this, appeared off Algiers, and the union of the Dutch squadron, which has so long remained inactive in the Mediterranean; it would appear that these powers are determined upon humbling and reducing to their own level, the nations of the Barbary Coast. That the nations of the Barbary Coast should so long have borne with the insults offered their flags, and the insults inflicted upon their citizens, when their great ability to avenge

them is considered, is both matter of astonishment and speculation; and especially so as relates to England, who can advance nothing in palliation of her forbearance, but the late bloody wars in which she has been engaged, and which for so many years afflicted the European Continent, and occupied the whole attention of her cabinet, as well as her naval and military forces. Those wars have now terminated, and she has no longer an excuse for delaying to administer to this miscreant race that correction which it seems her peculiar province to apply; for in addition to the immense naval force which she has at her command, she, holding Gibraltar, which would ever be a convenient rendezvous for her squadrons and troops, possesses as it were, the key to the Mediterranean. With these obvious and important advantages over the rest of the world, she, by a proper use of them, may do much towards, if she does not completely succeed in, bringing these disciples of Mahomet to a sense of their littleness and vileness. If America could boast of such advantages, new lustre would soon be added to the unfolding chaplets with which her triumphs on the ocean have encircled the brows of her naval heroes.

THE COMPENSATION BILL.
The passage of this Bill in the last Congress, accompanied as it was by an undue degree of hurry and precipitancy, has excited no small proportion of irritation, and even angry passions, among the constituents of those members who voted in its favour. In the Western States, particularly, it has been deemed so obnoxious to censure as to induce a call upon the respective candidates to pledge themselves, previous to election, to use their utmost efforts to effect a repeal of this, as they term it, "unconstitutional law." Major General Harrison has met this censure; & publicly proclaims, if he should be chosen to represent his district, he will consider it his duty immediately to move for the repeal of this offensive law. But it is rather ludicrous, in the General, when he adds, "perhaps, such a proposition could not proceed from a more influential and disinterested source than myself."

The federal members, who voted for the Compensation Bill, and who, like the Administration associates on this question, are threatened with the Bull of Excommunication certainly reckoned without their Host: for it is manifest, from the tally of the Clerk of the House of Representatives, if every federal member had been mute on the vote, the administration members had not only voted, but wills to carry the measure. We will barely add, that those who oppose the Bill so violently, ought to recollect that President Madison and Mr. Monroe, his intended successor, never interposed an official feather in the way of its passage. It was, in fact, a measure of the administration; and the Administration party in the next Congress will be compelled, with disgrace, to repeal it. It will be one of their first acts. [Ibid.]
