AN ACT

To alter and change such parts of the constitution and form of govern-ment, as relates to the division of Anne-Arundel county into election districts, and to change the place of holding elections in the second election district of said county.

[Passed Feb. 4, 1822.]

Bec. 1. Be it enacted, by the Ge neral Assembly of Maryland, That all that part of the constitution and form of government which relates to fixing the place of holding the elections in the second election district of Anne-Arundel county, be and the same s hereby repealed.

2. And be it enacted, That the elec-tion shall be held in the said election district, at such places as shall hereafter from time to time be provided by law, for the holding thereof.

3. And be it enacted, That the words "and the electors of the senate of this state" in the third section of the act confirmed at December session eigh teen hundred and seventeen, entitled, An act to alter and change such parts of the constitution and form of government as relate to the division of Anne Arundel county into election districts, and to change the place of holding elections in the second district of said county," be and the same are hereby rendered null, void, and of no effect.

4 And be it enacted. That if this act shall be confirmed by the General Assembly, after the next election of Delegates, in the first session after such new election, as the constitution and form of government direct, that insuch case, this act, and the alterations and amendments of the constitution and form of government therein con tained, shall be taken and considered, and shall constitute and be valid, as a part of the said constitution and form of government, any thing in the said constitution and form of government to the contrary notwithstanding.
