In all our great cities, the females are more numerous than the males. The average of our six largest cities, Boston, New York, Philadelphia, Baltimore, Charleston and New Orleans, gives 109 females to every 100 males, while the average of the whole United States gives but 97 females to every 100 males, making the females in our cities about 12 per cent more numerous than in the country at large.
