#### QUEBEC.

Extract of a letter from an American Gen tleman on a tour through a part of New York and Canada, to his friend in South Carolina.

"The city of Quebec, thus confined by precipices, where the rock is steep, and hy lofty walls, where there is a slope towards the banks of the St Charles is shut in by the works, which cross the isthmus of what the works, which cross the isthmus of what is now a peninsula, and can never occupy more ground than at present; but there is a lower town on made land round two sides of the rock, and there is the, populous suburb of St. Roche. The lower town, thus crowded in between the river and the rock, is the place of husiness; vessels of various sorts and sizes lay before; and there are all the accommodations which compares all the accommodations which commerce requires. It is here that the traveller who arrives by water, necessarily lands. & from hence that he rurveys with a sort of dread the wrial batteries and buildings that are toweiing above him. He then follows a narrow winding street up a steep way, and passes under a fortified gate, and availing himself now and then of flights of steps which are prepared for the accommodation of foot passengers, he arrives at length, out of breath, in the upper town, where he can alone, he finds, be able to lodge with any comfort.

"A residence however short, at Montreal. prepares the traveller, in some measure, for the objects he finds in Quebec—where the large stone houses, and the roots and acceptes covered with tin, and the French appearance of every thing, except that the military are in British uniform, makes it seem hardly possible that he should be upon the same continent with Newport and Boston. I must now refer you well dish. Boston. I must now refer you, as I didbe-fore, so book of travels, lot, a description of the city and an account of its numbers, its trade, and its public buildings. A young gentleman, of the family of our new friends, accompanied us mily of our new friends, accompanied us on the ramparts of the works, which cross-ed the isthmus—the outer wall seems at least 50 feet high, and thick in proportion —and we then ascended Cape Diamond, the pinnacle of which is 3\$5 feet above the surface of the water. Below us, in front, that is to say, looking east, was the Bay of Quehec—shut in, to appearance, by the Island of Orleans; on the right was the point des Peres from which the rock we stood des Peres from which the rock we stood des Peres, from which the rock we stond on, seemed to have been separated, & lower down the precipitous cliff of Point Levi, crowned by a handsome Episcopal church.

crowned by a handsome Episcopal church. On the left, the sloping bank, which rises from the side of the riser St. Charles, ends in a range of mountains. It seemed as if we were looking down upon a large lake, into which the ships of the ocean had been by some contrivance admitted.

"The space last mentioned, I mean the sloping banks of the River St. Charles, after a short interval of meadow land, "seemed covered with villages, country houses & cottages extending from Loretto, where a miserable remnant of the once powerful nation of the Hurons live, as comfortably as Indians can be made to live, as comfortably as Indians can be made to live, along the thickly built environs of Beauport and the village itself to the great saw mills of Mont

On looking round to the west, we had the plains of Abraham before us, and so nearly on a level with Cape Diamond, that an enemy getting possession of them, and erecting batteries, might, apparently annoy the citadel itself, & would certainly command that part of the works, lofty as they are, which cross the Isthmus, extending as they do, into the hollow formed by the passage of the waters in formor extending as they do, into the hollow formed by the passage of the waters in formor times. There have been three or four strong martello towers erected as a protection to this part, but I question if they also might not be approached without much difficulty, and taken, and they would then become as injurious to the city, as they are now supposed to be useful. Calhoun—and our voice is for him.
