Sec. 7. And be it enacted, That it shall be the duty of the commanders of regiments within this state, both infantry and cavalry...

Sec. 8. And be it enacted, That it shall be the duty of the adjutant-general of this state, annually, to forward to each of the brigadier-generals, colonels and majors...

Sec. 9. And be it enacted, That the militia of Allegany county shall be exempt from the operations of this law only so far as is provided by the twenty-ninth section...

Sec. 10. And be it enacted, That all that part of the forty-first section of the original act to which this is a supplement...

Sec. 11. And be it enacted, That any field officer hereafter removing out of the district of his regiment, with an intention of making a permanent change of his residence...

Sec. 12. And be it enacted, That it shall be the duty of each and every commissioned officer of this state, within six months from and after the passage of this act...

Sec. 13. And be it enacted, That this act shall not be construed to extend to the militia of the city of Baltimore, nor shall any persons who are now attached to and in the habit of duty in any volunteer uniformed company...
