THE PRESIDENCY.

It could not have escaped the notice of the most superficial observer, althocertain partisans are attempting to disguise the fact, that during the late presidential election, Gen. ANDREW JACKSON was the choice of the PEOPLE. Of all the candidates, he alone was destitute of official patronage. The whole machinery of office, so far as it might be brought to bear on the hopes of the friends of either of the candidates, was entirely under the manage ment of the General's opponents. Near ly all the presses, too, were arrayed against him. But they could substantiate no charges against him, that in any respect detracted from his patriotism or political integrity. His character was unsullied; and the more it became known to his countrymen, the more they were satisfied of his fitness for the high and dignified station which those who knew him best considered him pre eminently qualified to occupy. The result of the election furnished the estimate in which the General's character and services are held by the American people. He received the great-est amount of votes, and from the greatest number of states. None of those sectional partialities or jealousies which were displayed in the support of each of the other gentlemen, were discoverable in the preference given to the General. It seemed to be the unbidden reward of genuine merit—the spontaneous gratitude of the nation to-

wards a great public benefactor.

But in defiance of this exhibition of the people's pleasure, one of the disappointed candidates turned his influence in the House of Representatives against the General: those servants of the people, who were personally attached to this rejected candidate, were induced to violate the representative charter, and to sacrifice, on the altar of private friendship, the interest, the hopes, and the strongly expressed wish-

es of their constituents. The malignant insinuation against the patriotism of General Jackson, which Mr. Clay has couched under the phrase "Military Chieftain," is happiy refuted by the whole tenor of the General's life. In no instance has he taken a part in public affairs, but for the honour and happiness of his country. And so well established was his spotless reputation, long before the late war, that he received the highest compliment from the illustrious Jefferson, that any man could desire or deserve. When that distinguished states-man was apprised by Gen. Wilkinson, in 1806-7, that Aaron Burr was plotting the dismemberment of the Union, and that some of the most popular men in some of the states had joined him, he thus replied to Wilkinson: "Be assured that Tennessee, and particularly General JACKSON are FAITHFUL." About the same period Gen. Jackson thus wrote to W. C. C. Claiborne then Governor of Orleans Territory "I fear there are plans on foot inimical to the union; whether they will be attempted to be carried into effect or not. I cannot say; but rest assured they are in operation, or I calculate badly, Beware of the month of December. I LOVE MY COUNTRY and GOVERNMENT I hate the Dons. I would delight to see Mexico reduced; but I will die in the last ditch, before I would yield a

united.! Is this the "Military Chiefrain" from whom the people of this country should apprehend danger? Is this the man who would curtail their rights? Let the conduct of those who have leagued to countervail the wishes of the people, be consulted for an exposition of the true source of danger. We have infinitely more to apprehend from the wiles of insidious and ambitious demagogues, than from the gallant and devoted defenders of the country. The charms and emoluments of office, have had no power to divert the gallant and patriotic Jackson from the straight line of duty to his countrymen. He would perish in the last ditch in defence of their rights. Can this be cor-

rectly said of his opponents? The people of the United States are too well acquainted with their rightstoo vigilant to be deceived by empty professions and too kind to the faithful defenders of their country's hon-our, to suffer the personal destouse of
