It is likely he has changed his clothes, as he had other and better clothes, which no doubt he has taken with him. George is about 27 years of age, five feet seven or eight inches high, pretty well made, is an active, cunning, crafty fellow, his colour is swarthy black, rather inclined to yellow, he is pitted with the small pox, has a very bad countenance, when spoken to hangs his head and looks down, and his voice generally low. Had on when he went away ticklenburg trousers and shirt, his other clothes not recollecting, but as he had other clothing no doubt he carried it with him. He has a wife in Baltimore living on Federal Hill. I am informed he can read and write, and it is likely will write a pass himself. Both of these negro men were seen in Baltimore on Sunday the 9th instant. All persons masters or captains or commanders of vessels, are forbidden to employ or receive either of those negro men on board their vessels. Whoever takes up the said negro men, and secures them in goal so that I get them again, shall receive the above reward if taken out of this state, or fifty dollars for each, and if taken in this state, and secured in goal so that I get them again, sixty dollars for the two; or thirty dollars for each.
