On these points the directors cannot decline to give information to which their access is so easy, and which is requisite also to clear them from the charge which is current in some quarters, of having connived at the retention of so important an office by Mr. Raikes without a legal qualification. If they knew of this, it is not possible to be affirmed without due investigation, they have made themselves parties to a conspiracy of fraud on the public, and may be held to be the cause of these losses sustained by persons not in the secret, and who gave credit to Mr. Raikes entirely through their credulity in his official character. The mode of proceeding which the creditors intend to adopt has not yet been ascertained.

FRANCE.  
The most important intelligence from the country is the commercial embarrassment caused by numerous failures of commercial houses.  
The Courier Francis announces that in the last two days the commerce of the city has been greatly agitated by the failure of three first-rate commission houses. The amount of their debts is said to be near millions of francs. In consequence of these disasters, which must have an effect on secondary firms, the bankers in Paris have discounted commercial bills, have retrenched their discounts, and a general crisis is expected at the end of the year.  
The panic is come to such a pitch that several of the first banking houses have entirely refused to make any advances on bills which fall due in December.  
The Journal des Tisens says on this subject—"The whole of the merchants in the quarter of the Rue du Sentier and the Gros Chenevet, have, for the last two days, been seriously occupied with the failure of a house which carried on a very extensive business with England and America. Loans in Paris amount in all to 1,000,000 francs, and the quarters above mentioned to 300,000 francs. The rest of the sufferers in Paris are divided between the Quarter of the Rue de Bourdonnais and the Rue St. Denis. The whole amount owing by this house is said to be not less than two millions of francs, half of which is due at St. Etienne and Lyons. It is at the same time reported, that assets are next to nothing in comparison with their debts."  
The inauguration of the Statue of Camille Desmoulles was to take place at Rouen on the 10th of October.  
SPAIN.  
The Queen Regent of Spain is likely to find a much more formidable enemy in authority in her so much vaunted Cortes, than in the arms of her son, Don Carlos. Christine's fate is uncertain. She, it would seem, has no choice but to surrender of her power to the Cortes, a tenure of it under the full control of the vigilant surveillance of the Chamber of Peers—an alternative in which we are sure she has far too much of the Bourbon in her to relish. If she does not consent to herself, she will do better than we expect her. So truly has it been said of Spain, that there should be no medium in its government between absolute despotism and anarchy.

"There has not arrived to-day any news from Navarre. The public wait with anxiety the result of the definitive vote of the Cortes, relative to the loans. All the news which arrived yesterday, speak of the general recognition by the Cortes of the 10 per cents, and the perpetual rent."
