**PETITIONS, &c.**

By Mr. Mann—from James Welsh, and others, of Clear Spring, to sell a lot of land.

Mr. Richardson—a memorial of sundry citizens of Baltimore for an alteration in the law relating to Coroners—Also a petition of Anne R. Cannon, to be divorced from her husband.

Mr. Matthews—from John A. Pyle, to bring certain negroes into the state.

**LEAVES GRANTED.**

**BILLS REPORTED.**  
By Mr. Ford—to amend the constitution and form of government of the state of Maryland.

Mr. Parran—for the relief of Walter S. King—twice read and passed.

Mr. Mann—to authorize the conveyance of a lot of ground near Clear Spring.

Mr. Ely—to incorporate the Mineral Company of Baltimore county.

Mr. Primrose—to regulate the appointment, and enlarge the powers of the levy court, and abolish the office of Commissioners of the tax in Kent county.

Mr. Eccleston, submitted the following message: Gentlemen of the Senate,

We propose with the concurrence of your honourable body to appoint a joint committee of five, three of whom to be taken from the house of delegates, and two from the Senate, whose duty it shall be, on oath, to make a search of and thorough investigation into the concerns and arrangement of the Chesapeake and Ohio Canal Company, and the Baltimore and Ohio Rail Road Company, from the earliest period of their operations, to the period of investigation, and report in detail to the next General Assembly, and in the course of the next six months after the rising of the General Assembly, and that the committee have full power to send for and examine on oath all persons, companies, or otherwise connected with either of their companies, and also to send for, and examine all papers, letters and documents official or private, belonging to or in anywise connected with the management of either of said companies.

The clerk of the senate returned the supplement to the act regulating the meeting of the Orphans' Court of A. Arundel, endorsed "will pass"

On motion of Mr. Handy, the house took up for consideration the report submitted by him, from the committee on coloured population, upon the petition of Bennet Gough, praying the privilege of selling beyond the limits of the State, a slave for a term of years.

The said report was then read the second time and concurred in.

On motion of Mr. Eccleston, the house took up for consideration, the report from the committee on the constitution, submitted on the 13th inst., upon the bill, entitled, an act to alter the constitution so as to disfranchise persons convicted of felony.

The said report was then read the second time and concurred in.

The bill reported by Mr. Rentsch, entitled, an act to incorporate the Williamsport Manufacturing Company, and the amendment reported thereto from the committee on corporations were taken up for consideration.

The amendments, having been read the second time, were assented to.

The said bill was then read the second time, as amended and passed.

The house then adjourned.

Mr. Eccleston submitted the following order, Ordered, That the committee on grievances and courts of justice, be instructed to enquire whether the laws of the State do not require the county Clerks and Registers of Wills, of the several counties of this State, to prove their several accounts against the county presented to the Levy courts or commissioners, as the case may be. And if the committee discover that such is not now the law of this State, they are hereby instructed forthwith, to report a bill making it the duty of all such officers to present their accounts drawn out in a fair and legible hand, and to prove the same, in the presence of said levy courts or commissioners as the case may be.

Ordered, That the committee on grievances and courts of justice enquire into the expediency of reporting a bill making it the duty of Sheriffs and constables to make presentations to the respective justice courts, at their monthly meetings, of all and every breach of the peace recognizable by said courts, which may in future come to their notice through information given to them by others, or which may come under their immediate notice.

Mr. Ghieslin, submitted the following preamble and resolutions.

Whereas, it is important to the interest and prosperity of a large portion of the people of the United States, and particularly to the people of the States of Maryland, Virginia, Ohio, Kentucky, and Missouri, that in the future adjustment by Congress of the tariff system, a just and equal regard should be had to the article of tobacco, an agricultural production of the Legislatures of their respective States to this subject.

Resolved, That the Senators and Representatives of this State, in the Congress of the United States, be requested to take under their especial care this highly important and much neglected interest, and that they be particularly requested to oppose all and every adjustment of the present tariff, without obtaining for the tobacco interest a fair and equal participation in the benefits to be derived from such adjustment.

Resolved, That the Governor be requested to transmit a copy of the foregoing preamble and resolutions to the Senators and Representatives in Congress from this State.
