If December is any barometer of the coming winter, it will be plenty cold and snowy. Please remember that when the County calls a snow emergency our Town emergency goes into effect too. This means we must get all cars off Main Street. Residents

who park on Main Street can park at the Grange Hall or community lot. They are both located on South Alley. When parking in the community lot, please keep the area clear in front of the cluster mailboxes. Also, please shovel vour sidewalks when the storm is over. You can contact Town Hall regarding Councilman Rossman's Good Neighbor Program if you

need help. Lastly regarding this subject, if you or any family member has any special needs during a weather related event (i.e. power outage) please inform Town hall in order that we can add you to our registry for our Emergency Operations Plan. For more information on the snow emergency plan, see page 3 of the newsletter.

The FY '10 audit was completed in November. Our revenues from FY'09 were up about \$50,000.00. This was mainly attributable to increases in real property and income taxes as well as new home permitting fees, developer contributions, and amusement taxes. Total revenue would have been more but this year's amusement tax while more than last year, was \$33,892.00 lower than we predicted in our budget. This is due to the bad economy.

Likewise expenses were up about \$9,000.00 from last year. This is mainly attributable to snow and ice removal from last year's storms. General services and other government operating expenses were down \$5,318.00 from the previous year. We can thank the girls in the office for keeping tight control over those items. Legal fees were unchanged from last year and \$5,000.00 under the FY '10 budget. Copies of the audit can be obtained in the Town Office.

Everybody Ready? Plan to be Safe (Plan 9)

Disasters can impact our County and our neighborhoods at any time. Being prepared can help you protect yourself, your family and your workplace when disaster strikes.

Frederick County experiences weather-related emergencies each year. Although our community is not at a high risk for hurricanes, we may experience other dangers as a result of hurricane forces such has high winds, heavy rains, flooding and tornados.

Now is the time to review the four national preparedness recommendations and take the necessary actions to ensure that you have prepared yourselves, your families, and workplaces to prevent, and when necessary, respond to an emergency.

- **Be Informed** of the weather-related hazards that face our community. Monitor changing weather conditions and be aware of the factors that prompt dangerous roadway travel. Read the local newspaper, watch the televised news and listen to the radio. Government officials will communicate emergency messages through the Emergency Alert System.
- **Develop an emergency plan** and discuss it with your family. Decide how you will communicate with others during an emergency. Should you need to leave your home, know what to take with you, what you need to do to secure your home and where you will go.
- Prepare an emergency supply kit for your family for three days. There is a copy of the Plan to Be Safe (Plan 9) campaign on the link here: <u>http://www.frederickcountymd.gov/plan9</u>. You may also download a copy of the Plan 9 brochure at <u>http://www.frederickcountymd.gov/documents/Emergency</u>
 <u>%20Management/Plan%209%20trifold.PDF</u>. The Plan 9 information will guide on the on the nine essential items for your emergency kit. As you plan for your family, also develop a plan and kit for your pet.
- **Get involved** with your community. Get to know your residential and business neighbors, the people in your school or community groups, faith-based friends and the parents of your child's friends. Emergencies won't seem as devastating if you have a support system available.

We know your family, community and workplace are important to you. Take the time now to better prepare for safety. Being prepared can save lives and property and improve your recovery time. Plan 9 Kit Essentials

For the complete Plan 9 refer to the county website but here are the essential 9 items that should be in your emergency preparedness kit:

- 1. Water -- One gallon of water per person per day for three days.
- 2. Food -- Non-perishable food such as canned or packaged food.
- 3. Clothes -- One change of clothes and footwear per person.
- **4.** Medications -- Three days' worth of prescription medications (if needed).
- 5. Flashlight and extra batteries



- 6. Can Opener -- manual type
- 7. Radio -- A battery-powered, solar-powered, or hand-crank radio.
- 8. Hygiene Items -- like soap, toilet paper and a toothbrush.
- **9.** First Aid -- basics like antiseptic, bandages and non-prescription medicine.

Snow & Ice Removal

Please remember that Main Street is designated a "Snow" Emergency Route". During a snow event, please move your vehicle off Main Street to allow the plows to clear all the way to the curbs. You may park in the the new community parking lot (next to the community park, Federal & South Alley) until Main Street has been plowed. The town has also made arrangements with the Grange Hall (located on South & Seventh Alley) to park in their lot.

Please clear off your sidewalks in front of your property within six (6) hours from the end of the snowfall or other precipitation, or if the snowfall or other precipitation occurred overnight, by 2:00 pm the following afternoon. If ice is not readily



removable, sufficient calcium chloride or similar commercially available product should be applied to effectively melt and remove the accumulation of ice. To assist with keeping water & ice pooling along the streets. please clean leaves, trash, etc. from your drains and gutters. If you have any questions on the snow policy, please contact Town Hall, 301.865.5544.
