Information About the Maryland Register and COMAR

MARYLAND REGISTER

The Maryland Register is an official State publication published every other week throughout the year. A cumulative index is published quarterly.

The Maryland Register is the temporary supplement to the Code of Maryland Regulations. Any change to the text of regulations published in COMAR, whether by adoption, amendment, repeal, or emergency action, must first be published in the Register.

The following information is also published regularly in the Register:

CITATION TO THE MARYLAND REGISTER

The Maryland Register is cited by volume, issue, page number, and date. Example:

- 19:8 Md. R. 815—817 (April 17, 1992) refers to Volume 19, Issue 8, pages 815—817 of the Maryland Register issued on April 17, 1992.

CODE OF MARYLAND REGULATIONS (COMAR)

COMAR is the official compilation of all regulations issued by agencies of the State of Maryland. The Maryland Register is COMAR's temporary supplement, printing all changes to regulations as soon as they occur. At least once annually, the changes to regulations printed in the Maryland Register are incorporated into COMAR by means of permanent supplements.

CITATION TO COMAR REGULATIONS

COMAR regulations are cited by title number, subtitle number, chapter number, and regulation number. Example: COMAR 10.08.01.03 refers to Title 10, Subtitle 08, Chapter 01, Regulation 03.

DOCUMENTS INCORPORATED BY REFERENCE

Incorporation by reference is a legal device by which a document is made part of COMAR simply by referring to it. While the text of an incorporated document does not appear in COMAR, the provisions of the incorporated document are as fully enforceable as any other COMAR regulation. Each regulation that proposes to incorporate a document is identified in the Maryland Register by an Editor's Note. The Cumulative Table of COMAR Regulations Adopted, Amended or Repealed, found online, also identifies each regulation incorporating a document. Documents incorporated by reference are available for inspection in various depository libraries located throughout the State and at the Division of State Documents. These depositories are listed in the first issue of the Maryland Register published each year. For further information, call 410-974-2486.

HOW TO RESEARCH REGULATIONS

An Administrative History at the end of every COMAR chapter gives information about past changes to regulations. To determine if there have been any subsequent changes, check the "Cumulative Table of COMAR Regulations Adopted, Amended, or Repealed" which is found online at www.dsd.state.md.us/CumulativeIndex.pdf. This table lists the regulations in numerical order, by their COMAR number, followed by the citation to the Maryland Register in which the change occurred. The Maryland Register serves as a temporary supplement to COMAR, and the two publications must always be used together. A Research Guide for Maryland Regulations is available. CITIZEN PARTICIPATION IN THE REGULATION-MAKING PROCESS

Maryland citizens and other interested persons may participate in the process by which administrative regulations are adopted, amended, or repealed, and may also initiate the process by which the validity and applicability of regulations is determined. Listed below are some of the ways in which citizens may participate (references are to State Government Article (SG), Annotated Code of Maryland):

- By submitting data or views on proposed regulations either orally or in writing, to the proposing agency (see "Opportunity for Public Comment" at the beginning of all regulations appearing in the Proposed Action on Regulations section of the Maryland Register). (See SG, §10-112)
- By petitioning an agency to adopt, amend, or repeal regulations. The agency must respond to the petition. (See SG §10-123)
- By petitioning an agency to issue a declaratory ruling with respect to how any regulation, order, or statute enforced by the agency applies. (SG, Title 10, Subtitle 3)
- By petitioning the circuit court for a declaratory judgment on the validity of a regulation when it appears that the regulation interferes with or impairs the legal rights or privileges of the petitioner. (SG, §10-125)
- By inspecting a certified copy of any document filed with the Division of State Documents for publication in the Maryland Register. (See SG, §7-213)

Under the COMAR codification system, every regulation is assigned a unique four-part codification number by which it may be identified. All regulations found in COMAR are arranged by title. Each title is divided into numbered subtitles, each subtitle is divided into numbered chapters, and each chapter into numbered regulations.

A regulation may be divided into lettered sections, a section divided into numbered subsections, a subsection divided into lettered paragraphs, and a paragraph divided into numbered subparagraphs.

Emergency Regulations

Under State Government Article, §10-111(b), Annotated Code of Maryland, an agency may petition the Joint Committee on Administrative, Executive, and Legislative Review (AELR), asking that the usual procedures for adopting regulations be set aside because emergency conditions exist. If the Committee approves the request, the regulations are given emergency status. Emergency status means that the regulations become effective immediately, or at a later time specified by the Committee. After the Committee has granted emergency status, the regulations are published in the next available issue of the Maryland Register. The approval of emergency status may be subject to one or more conditions, including a time limit. During the time the emergency status is in effect, the agency may adopt the regulations through the usual promulgation process. If the agency chooses not to adopt the regulations, the emergency status expires when the time limit on the emergency regulations ends. When emergency status expires, the text of the regulations reverts to its original language.

Chapter name and Regulations .01B(28) and .05C(3)(j): In Regulation .05, removed “intellectual disability,” as developmental disabilities includes “intellectual disability” along with “related conditions” and therefore already part of the regulation. Addressing it separately makes it appear that it is a separate condition in addition to “developmental disability,” which is inaccurate. This change required a change to the chapter name and to the definition of “developmental disability in Regulation .01B(28).

Regulation .01B(19): Added “person-centered,” planning for individuals is already person-centered, so adding this term, while required by federal regulations, does not change the existing regulation.

Regulation .01B(32) and Regulation .04I and .04I(1): The addition in Regulation .01B(32) is the definition of “service record,” which must be added because the term is being used in Regulation .04 and is not already defined. The term “participant record” in Regulation .04I is vague, as there is no specific record called a “participant record.” “Service record” is a better name for the record that is to be transferred. The record has not changed, only the name.

Regulation .05C(3): Removed “high level of skill” and replaced with “competency-based skills,” as the new language is merely a more accurate description of the intended term.

Regulations .06C and D(2)(d) and Regulation .08B(1): Added “business” to identify the type of day meant as “day” is not identified as “business” or “calendar.” This change clarifies what is intended.

Regulation .06D(1): Removed “ensure that each individual receives an” and replaced with “facilitate the.” This change clarifies the meaning of the phrase, which is that the coordinator will assist others to make sure the plan is created. The change does not alter the coordinator’s responsibilities, but rather, makes the description of the existing responsibilities clear.

Regulation .06F(2)(d): Added “calendar” to identify the type of day meant as “day” is not identified as “business” or “calendar.” This change clarifies what is intended.

Promulgation of Regulations

An agency wishing to adopt, amend, or repeal regulations must first publish in the Maryland Register a notice of proposed action, a statement of purpose, a comparison to federal standards, an estimate of economic impact, an economic impact on small businesses, a notice giving the public an opportunity to comment on the proposal, and the text of the proposed regulations. The opportunity for public comment must be held open for at least 30 days after the proposal is published in the Maryland Register.

Following publication of the proposal in the Maryland Register, 45 days must pass before the agency may take final action on the proposal. When final action is taken, the agency must publish a notice in the Maryland Register. Final action takes effect 10 days after the notice is published, unless the agency specifies a later date. An agency may make changes in the text of a proposal. If the changes are not substantive, these changes are included in the notice of final action and published in the Maryland Register. If the changes are substantive, the agency must repropose the regulations, showing the changes that were made to the originally proposed text.

Proposed action on regulations may be withdrawn by the proposing agency any time before final action is taken. When an agency proposes action on regulations, but does not take final action within 1 year, the proposal is automatically withdrawn by operation of law, and a notice of withdrawal is published in the Maryland Register.

The Secretary of Natural Resources proposes to amend Regulation **.04** under **COMAR 08.02.15 Striped Bass**.

Statement of Purpose

The purpose of this action is to make changes to the registration and transfer rules for the commercial striped bass fishery. The Commercial Striped Bass Industry Workgroup (SBWG) has recommended that the Department propose regulations to allow for the permanent transfer of a striped bass permit and/or quota shares. The Department does not currently allow for the permanent transfer of a striped bass permit and/or quota share without the inclusion of the seller's commercial fishing license (TFL, FIN, or HLI). Only temporary transfers/leases of permits and quota shares have been available to permit holders since the inception of the individual transferrable quota (ITQ) system in 2014. The Department is proposing these changes to allow a striped bass permit holder to manage their permit and quota share in a way that provides the most flexibility in their business due to the SBWG recommendation.

This action will extend the registration period for striped bass permits. Rather than being required to register from August 1 through August 31, permit holders will have until September 30 to register their permits, or the next business day if September 30 falls on a weekend. All permits will have to be renewed every year or be relinquished to the Department. Currently, permits are required to be registered every three years to maintain eligibility in the fishery. The

action also removes the late declaration period and modifies the exemption provision to create an appeal to the Tidal Fisheries Advisory Commission for those individuals who have missed the registration deadline.

This action will allow a permit holder to sell their permit and/or quota shares independently of the commercial fishing license. This action will allow individual permit holders to accumulate quota shares and hold more shares of the fishery than what was initially allocated to them. The most an individual will be able to hold permanently will be 1 percent of the Chesapeake Bay commercial fishery. On a temporary basis, there is a soft cap of 1.5 percent of the Chesapeake Bay commercial fishery, meaning that someone would be able to exceed the 1.5 percent cap if they have less than 1.5 percent prior to the last transaction. There will also be a yearly cap on share transfers that any individual may permanently acquire set at 0.2 percent of the Chesapeake Bay commercial quota. The limitation to 0.2 percent of the Chesapeake Bay commercial quota is equal to roughly 3,000 pounds under the current quota, which is the amount the SBWG felt should be the yearly maximum an individual should be able to acquire. This limitation would not apply to a buyer of an entire commercial fishing business, including the transferor's commercial fishing license.

In addition, this action will allow a permit holder to sell only quota shares and keep the permit (without any allocation) for future use, or to sell a striped bass permit without transferring away their commercial fishing license.

The time period for permanent transfers in the Chesapeake Bay fisheries will be during the registration period, August 1 through September 30. This time period will not apply in a transaction where the transfer includes the transferor's commercial fishing license.

This action will also require an individual to possess at least 0.0185 percent of the Chesapeake Bay fishery in order to declare for the Chesapeake Bay Common Pool fishery. This is the minimum baseline share amount that was initially distributed to permit holders in 2014. This is being done so that individuals without a share or with less than the minimum amount initially allocated are not taking advantage of individuals with the baseline amount or more who have contributed their share to the Common Pool. Also in the Common Pool, the transfer time periods will be adjusted. The March 1 through March 31 time period remains unchanged, but the current transfer

period from August 1 through August 30 will be extended to match the new registration period from August 1 through September 30. This action also clarifies that the transfer period in August and September is for the next quota year, not the current quota year.

Lastly, this action makes stylistic and grammatical clarifications and changes and reorganizes text.

Comparison to Federal Standards

There is no corresponding federal standard to this proposed action.

III. Assumptions. (Identified by Impact Letter and Number from Section II.)

A. Previous to this package, a striped bass permit in the Chesapeake Bay may only be transferred if the transferor is also transferring their tidal fish license to the transferee. By allowing striped bass permits to be transferred without an associated tidal fish license, the Department anticipates that more striped bass permits will be transferred. The transfer fee is \$50 per transfer. It is unknown how many additional transfers will be processed due to this change.

D(1). Striped bass permit holders with multiple permits will now be able to transfer their excess permits away while still being able to keep their tidal fish license. Assuming these permit holders are able to find purchasers for their individual permits, the current permit holders will benefit economically twofold: they will make money in the sale of the excess permits and they will no longer have to pay to renew their excess permits.

D(2). Striped bass permit holders who want to leave the striped bass fishery but keep their commercial license will now be able to do so. Previously, to leave the striped bass fishery but continue to commercially harvest other species, these individuals would have had to sell their entire license, along with the striped bass permit, then

find another license to buy that did not include a striped bass permit. This action will allow these individuals to make money selling their striped bass permit without the hassle of having to find a buyer for the entire license, in addition to finding someone else selling the license they would then be seeking.

D(3). By allowing current striped bass permit holders to sell their permits without being required to sell their tidal fish license, current tidal fish licensees without a striped bass permit are now going to be able to purchase a permit. Previously, since a striped bass permit was only able to be transferred along with a tidal fish license, these individuals would have had to either transfer away their current license to purchase the transferor’s license with the striped bass permit or wait on the permit waiting list, which could take many years. They will now potentially have much easier access to purchase a permit. This should allow additional licensees to enter the striped bass fishery. The magnitude of the impact is indeterminable, as it is not known how much money the new entrants will save by only having to purchase the permit, rather than both the permit and the license, or how much money they will now be able to make in the striped bass fishery.

[A.] B. Registration Procedures.

(a) An individual may register for a permit to participate in the next quota year’s striped bass fishery if they:

(i) Are currently authorized to commercially harvest striped bass in accordance with Natural Resources Article, §4-701, Annotated Code of Maryland;

(ii) Have received a striped bass permit from the Department in accordance with §C of this regulation; or

(iii) Have received a permanent transfer of a striped bass permit as described in §H of this regulation.

[(a)] (b) A commercial tidal fish licensee[, other than a fishing guide licensee,] shall register for a striped bass permit to participate in a commercial striped bass fishery in accordance with [§§A and B of] this [regulation,] *section* by [August 31] *September 30* of each year, *or the next business day if September 30 falls on a weekend.*

[(i)] (c) A *commercial* tidal fish licensee who has not registered by [August 31] of *September 30* of the current year, [and who has not registered late in any of the three preceding years,] *or the next business day if September 30 falls on a weekend,* may [apply up to September 14 of the current year to the Director of Fisheries Service if the licensee can show good reason why the application should be validated] *submit an appeal to the Tidal Fisheries Advisory Commission to be heard at their next meeting.*

[(ii)] An individual that does not register by September 14 of the current year, or the close of business the next business day when September 14 occurs on a weekend, is not eligible to participate in the striped bass fishery for the next calendar year.]

[(iii)] (d) An exception to the September [14] 30 deadline will *only* be considered by the Department [only for an individual who can provide satisfactory documentation of a physical or mental incapacity that prevented that individual from meeting the registration time period established in this subsection] *if the Tidal Fisheries Advisory Commission recommends to the Department that the individual who has made an appeal under §B(1)(c) of this regulation be allowed to register.*

(e) *Any permit that is not registered by the deadline established in §B(1)(b) of this regulation shall be relinquished to the Department.*

[(b)] (f) The Department shall:

(i) Make registration available to eligible *commercial* tidal fish [license holders] *licensees* not later than August 1 of each year; [and]

(ii) Use the registrations received as of September [14] 30 of each year, *or the next business day if September 30 falls on a weekend,* to determine allocations for the striped bass fishery permittees; *and*

(iii) *Issue any striped bass permit that is not registered by the deadline established in §B(1)(b) of this regulation in accordance with §C of this regulation.*

(2) Registration Type.

(a) When registering for a striped bass permit, a *commercial* tidal fish licensee shall specify and may be authorized to fish in one of the following fisheries:

(i)—(ii) (text unchanged)

(iii) Atlantic Ocean[, its coastal bays and their tidal tributaries].

(b) A *commercial* tidal fish licensee who had a striped bass permit registered in the Chesapeake Bay pound net or haul seine fisheries as of May 10, 2013 and receives shares and allocation from those permits shall register in the Chesapeake Bay individual transferrable quota fishery.

(c) A *commercial* tidal fish licensee may not possess striped bass permits registered in both the Chesapeake Bay common pool fishery and the Chesapeake Bay individual transferrable quota fishery.

(d) A *commercial* tidal fish licensee may not possess striped bass permits registered in both a [the] Chesapeake Bay fishery [and its tidal tributaries] and in the Atlantic Ocean[, its coastal bays and their tidal tributaries] fishery.

(e) (text unchanged)

[B. Striped Bass Permit.

(1) A tidal fish licensee, other than a fishing guide licensee, shall possess a striped bass permit while commercially fishing for striped bass.

F. Temporary Transfers.

(3) Except as provided in §G of this regulation, a *commercial* tidal fish licensee may not transfer shares.

(4) Chesapeake Bay Common Pool Fishery. A striped bass permit registered in the common pool fishery may only be temporarily transferred [during the periods March 1 through March 31, or the next business day if March 31 falls on a weekend, and]:

(a) *Prior to the start of the quota year, from August 1 through [August 31] September 30, or the next business day if [August 31] September 30 falls on a weekend; or*

(b) *During the quota year, from March 1 through March 31, or the next business day if March 31 falls on a weekend.*

(5) Chesapeake Bay Individual [Transferable] *Transferrable* Quota Fishery.

(a) Prior to the start of the quota year, during the period August 1 through September 30, or the next business day if September 30 falls on a weekend, a *commercial* tidal fish licensee:

(i) May complete up to four transactions where a permit or a portion of their allocation is temporarily transferred from the permittee to another *commercial* tidal fish licensee; and

(ii) (text unchanged)

(b) During the quota year, a *commercial* tidal fish licensee may only temporarily transfer a striped bass permit or allocation if the *commercial* tidal fish licensee transfers all remaining allocation and associated tags.

(c) (text unchanged)

(d) [Beginning January 1, 2014, a] A *commercial* tidal fish licensee may not receive an allocation transfer when the licensee possesses [1] 1.5 percent or more of the total commercial quota for the [state] Chesapeake Bay fisheries.

(6) Atlantic Fishery.

(a) Prior to the start of the quota year, during the period August 1 through September 30, or the next business day if

September 30 falls on a weekend, a *commercial* tidal fish licensee may temporarily transfer:

(ii) A permit or permits to a *commercial* tidal fish licensee; or

(iii) Both allocation and a permit or permits to a *commercial* tidal fish licensee.

(b) During the quota year, a *commercial* tidal fish licensee may only temporarily transfer a striped bass permit or allocation if the *commercial* tidal fish licensee also transfers all remaining allocation and associated tags.

(c) — (d) (text unchanged)

(e) A *commercial* tidal fish licensee registered in the Atlantic Ocean fishery may not [possess] *receive an allocation transfer that would result in the licensee possessing* more than 10 percent of the Atlantic Ocean quota [on a temporary basis].

(7) — (8) (text unchanged)

(9) For purposes of the license suspension criteria, if a *commercial tidal fish* licensee transfers the striped bass permit to another licensee, the transferee that committed the violation shall be held responsible.

(10) The registration type of a striped bass permit may not be changed under a temporary transfer [as described in §F(1)—(6) of this regulation].

G. Permanent Transfers.

(1) A commercial tidal fish licensee may permanently transfer a striped bass permit if:

[(2) If the permit is registered in one of the Chesapeake Bay fisheries, a commercial tidal fish licensee shall also:

(a) Transfer the licensee's commercial tidal fish license in accordance with Natural Resources Article, §4-701, Annotated Code of Maryland; and

(b) Transfer any remaining allocation and all shares associated with the striped bass permit in the manner specified by the Department.

(3) A transferee receiving a share of Chesapeake Bay fishery may not transfer that share to the Atlantic Ocean fishery.]

[(4)] (2) [If the permit is registered in the Atlantic Ocean fishery, a] A commercial *tidal* fish licensee may permanently transfer:

(a) (text unchanged)

(b) The licensee's share, or any portion of that share, without transferring the licensee's tidal fish license or striped bass permit; [or]

(c) A striped bass permit and a portion of the licensee's share without transferring the licensee's tidal fish license, so long as the licensee retains at least one striped bass permit; *or*

(d) *The licensee's share and all striped bass permits, along with the licensee's tidal fish license.*

[(5) A transferee receiving a share of the Atlantic Ocean fishery may not transfer that share to either of the Chesapeake Bay fisheries.]

(3) *The permanent transfer of a licensee's share or any portion of that share in the Chesapeake Bay fisheries may only be completed from August 1 through September 30, or the next business day if September 30 falls on a weekend.*

(4) *The time period described in §G(3) of this regulation does not apply to a transaction where the transferee also receives the transferor's commercial tidal fish license.*

(5) *A commercial tidal fish licensee registered in either of the Chesapeake Bay fisheries may not receive a share in a permanent transfer:*

(a) *That would result in the transferee possessing more than 1 percent of the total commercial quota for the Chesapeake Bay fisheries; or*

(b) *Equal to more than 0.2 percent of the Chesapeake Bay commercial quota in a single quota year.*

(6) *The transfer limit described in §G(5)(b) of this regulation does not apply to a transaction where the transferee also receives the transferor's commercial tidal fish license.*

Statement of Purpose

The purpose of this action is to:

- (1) Authorize the Board to assess a civil fine, not to exceed \$50,000 on a person who violates Health Occupations Article, §11-501 (practicing without a license), 11-502 (misrepresentation as an optometrist), or 11-504 (dispensing contact lenses or replacement contact lenses without a valid and unexpired prescription or replacement contact lens prescription), Annotated Code of Maryland;
- (2) Establish factors which the Board shall consider in assessing a fine and the amount of the fine; and
- (3) Require that a person who is assessed a civil fine pay the fine within 30 days of the Board’s order.

Comparison to Federal Standards

There is no corresponding federal standard to this proposed action.

 - (1) *The cost of investigating and prosecuting the case against the person;*

 - (5) *The willfulness of the improper conduct; and*

.01 Declaration of Public Policy.

A. The Commission declares that it is in the public interest for public service companies to implement diverse supplier programs to promote economical delivery of utility services and positively impact the economy of the State. Accordingly, the Commission has established a Supplier Diversity Program consisting of entry into a voluntary memorandum of understanding (MOU) with individual companies.

B. Under the Supplier Diversity Program, entities regulated by the Commission that voluntarily enter into an MOU will develop, implement, and consistently report on their activities and accomplishments in promoting a strategy designed to create viable and prosperous minority, women, and service-disabled-veteran-owned business enterprises by providing them with the maximum opportunity to participate in and compete for contracts and subcontracts in their supply chain for goods and services.

.02 Scope.

This subtitle applies to all public service companies, electricity suppliers, gas suppliers, and any other entities subject to regulation by the Commission.

.03 Establishment of Program.

A. There is a Maryland Public Service Commission Supplier Diversity Program.

B. Individual companies regulated or licensed by the Commission may voluntarily join the program by entering into an MOU with the Public Service Commission.

C. A signed MOU shall be filed publicly with the Public Service Commission.

.04 Definitions.

A. In this subtitle, the following terms have the meanings indicated.

B. Terms Defined.

(1) "Annual public conference" or "public conference" means a yearly Commission legislative style en banc review of the participating company filed reports and plans, attended by interested parties and executive representatives of all participating companies.

(2) "Commission" means the Public Service Commission of Maryland.

(3) "Company" means:

(a) A public service company as defined in Public Utilities Article, §1-101, Annotated Code of Maryland;

(b) Electricity supplier, as defined in Public Utilities Article, §1-101, Annotated Code of Maryland;

(c) Gas supplier, as defined in Public Utilities Article, §1-101, Annotated Code of Maryland; or

(d) Any other entity regulated by the Commission.

(4) "MOU" means a voluntary memorandum of understanding between the Commission and a company containing specific requirements and details of a company's diverse supplier program.

(5) "Participating company" means a company that has voluntarily entered into an MOU with the Commission.

(6) "Public determination" means a publicly available report prepared by the Commission on the status of the Supplier Diversity Program.

(7) "Staff" means the Commission's Office of External Relations and the Commission's technical staff.

(8) "Supplier Diversity Program" means the Maryland Public Service Commission Supplier Diversity Program encompassed in an MOU.

.05 Report; Public Conference; Addenda.

A. Staff Report. Staff shall review a participating company's annual report not more than 2 years after the annual report is filed. Staff may seek, pursuant to individual MOU and Commission statutory authority, source documents used to prepare the annual reports, while preserving the confidential and proprietary data. Upon completion of its review of participating companies' annual reports, staff shall file a staff report of its findings.

B. Public Conference.

(1) The Commission shall hold a public conference each year for the purpose of reviewing the annual reports and annual plans received from participating companies.

(2) Within 60 days of the public conference, the Commission shall issue a public determination as to whether continuation of the Supplier Diversity Program is in the best interest of the public.

C. Addenda to an MOU.

(1) Either the Commission, a participating company or the staff may propose addenda to one, several, or all MOUs at any time prior to an annual public conference.

26.11.38 Control of NO_x Emissions from Coal-Fired Electric Generating Units

*Authority: Environment Article, §§1-404, 2-103, and 2-301—2-303,
Annotated Code of Maryland*

Notice of Proposed Action

[15-141-P]

The Secretary of the Environment proposes to adopt new Regulations .01—.05 under a new chapter, **COMAR 26.11.38 Control of NO_x Emissions from Coal-Fired Electric Generating Units**.

Statement of Purpose

The purpose of this action is to establish new nitrogen oxides (NO_x) emission standards and additional monitoring and reporting requirements for coal-fired electric generating units (EGUs) in Maryland. The new standards for coal-fired electric generating units in Maryland and resulting reductions in NO_x emissions are needed to achieve attainment of, and maintain, the National Ambient Air Quality Standard (NAAQS) for ozone and will satisfy the requirements of §182 of the federal Clean Air Act.

This action will be submitted to the U.S. Environmental Protection Agency (EPA) for approval as part of Maryland's State Implementation Plan (SIP).

Background

In 2012, portions of Maryland were designated as nonattainment for the 75 parts per billion (ppb) ozone NAAQS. Ozone is produced when volatile organic compounds (VOCs) and NO_x react in the presence of heat and sunlight. The Department has found through a research partnership with the University of Maryland that NO_x reductions are more effective at reducing ozone levels than VOC reductions. Under the federal Clean Air Act, sources in ozone nonattainment areas classified as moderate and above are subject to a NO_x Reasonably Available Control Technology (RACT) requirement.

Sections 182 and 184 of the Clean Air Act require the Maryland Department of the Environment (the Department) to review and revise NO_x RACT requirements in Maryland's SIP as necessary to achieve compliance with new more stringent ambient air quality standards. EPA defines RACT as the lowest emissions limitation (e.g., on a part per million or pound per million Btu basis) that a particular source is capable of meeting by the application of control technology (e.g., installation and operation of low-NO_x burners) that is reasonably available considering technological and economic feasibility. In reviewing existing NO_x RACT requirements for adequacy, the Department considers technological advances, the stringency of the revised ozone standard, and whether new sources subject to RACT requirements are present in the nonattainment area. Maryland's RACT SIP for the new 75 ppb ozone standard must examine existing controls on major sources of NO_x to determine whether additional controls are economical and technically feasible.

The Department found, through its recent review of 2007 through 2013 emissions data from Maryland coal-fired EGUs equipped with SCRs, SNCRs and SACRs, many of the coal-fired EGUs were not consistently operating their previously installed controls to optimize

(2) Once proposed by any party, the Commission staff and any affected participating companies shall discuss the merits of the addenda and submit a written recommendation to the Commission.

(3) In a public determination prepared after an annual public conference, the Commission shall summarize and respond to any pending proposed addenda.

(4) Within 60 days after a public determination is issued, participating companies may submit a written response to any addenda proposed by the Commission, staff, or other participating company.

(5) No MOU amendment or other addendum to an MOU shall be of any force or effect unless it has been voluntarily accepted in writing by both an authorized representative of affected participating companies and by the Commission.

(6) All accepted addenda to an MOU shall be in effect at a time agreed upon by parties.

(7) The process in this section does not limit the Commission or any participating company's ability to propose changes to an MOU at any time.

.06 Compliance.

A. The Commission shall maintain on its website:

(1) A list of Companies participating in the Supplier Diversity Program;

(2) Copies of all public annual plan and annual report filings made by participating companies;

(3) Copies of all signed MOUs; and

(4) Copies of all agreed-to addenda.

B. An MOU may be terminated upon recommendation of staff, a participating company or the Commission for failure to:

(1) Submit an annual report or annual plan for 2 or more consecutive years;

(2) Provide source documents or data used to prepare the annual reports at the request of staff; or

(3) Comply with the terms of this subtitle or the participating company's MOU.

C. If a participating company fails to submit reports, plans, or data as requested by staff or comply with the terms of this subtitle or its MOU, the sole remedy shall be that the Commission may terminate the MOU.

D. A participating company may be reinstated upon recommendation by staff and approval by the Commission.

.07 Waiver of Regulations.

Upon written request, a regulation in this subtitle may be waived by the Commission for good cause shown.

.08 Limitations.

A. The provisions of this subtitle shall be of no effect and may not be enforced if the Commission issues a public determination that the Supplier Diversity Program is no longer in the best interest of the public, is no longer necessary, or does not positively impact the economy of the State.

B. The terms of an MOU are not themselves regulations of the Commission.

emission reductions—particularly during ozone season periods of high electricity demand when ozone levels are highest.

In 2015, the Department is required to submit an ozone attainment SIP that includes emission reduction strategies designed to achieve compliance with the 75 ppb ozone standard by 2017. Reductions in NO_x emissions from coal-fired EGUs on high electricity demand days during the ozone season are necessary to achieve compliance with the 75 ppb standard.

This proposed regulation, when effective, will result in immediate reductions in ozone season NO_x emissions from these sources, which are needed to achieve and maintain compliance with the 75 ppb ozone standard.

Sources Affected and Location

This action impacts coal-fired EGUs in Maryland, which account for more than 80 percent of the State’s power plant NO_x emissions. Affected EGUs include Brandon Shores (Units 1 and 2); C.P. Crane (Units 1 and 2); H.A. Wagner (Units 2 and 3) plants; Chalk Point (Units 1 and 2); Morgantown (Units 1 and 2); Dickerson (Units 1, 2 and 3); and AES Warrior Run.

Requirements

This action is part of a broader strategy to further reduce NO_x emissions from coal-fired EGUs in the State by requiring owners and operators of affected EGUs to comply with the following measures:

- No later than 45 days after the effective date of this regulation, submit a plan to the Department, for approval by the Department and EPA, that demonstrates how the EGU will operate installed pollution control technology and combustion controls to minimize emissions;
- Beginning May 1, 2015, and during the entire ozone season whenever the EGU is combusting coal, operate and optimize the use of all installed pollution and combustion controls consistent with the technological limitations, manufacturers’ specifications, good engineering, maintenance practices, and air pollution control practices to minimize emissions (as defined in 40 CFR §60.11(d));
- Demonstrate compliance by meeting a systemwide NO_x emission rate of 0.15 lbs/MMBtu as a 30-day rolling average during the ozone season. An EGU that is located at an electric generating facility that is the only facility in Maryland directly or indirectly owned, operated, or controlled by the owner, operator, or controller of the facility is exempt from the obligation to meet this NO_x emission rate;
- Continue to meet the ozone season and annual NO_x reduction requirements set forth in COMAR 26.11.27;
- Meet a NO_x emission rate of 0.10 lbs/MMBtu as a 24-hour block average on an annual basis if the EGU is a fluidized bed combustor; and
- Demonstrate compliance with the requirements and emission rates in the regulation in accordance with the prescribed procedures.

Expected Emissions Reductions

The Department projects that implementation of Regulation .03 requirements will result in an estimated daily NO_x emission reduction of 25 percent and 9 tons from average levels of 36 tons/day during the period from 2011 through 2013 as long as the two current systems remain intact. Additional emission reductions should be realized on peak days as the NO_x emission rate restrictions will achieve better performance from units that traditionally are operated only upon high electricity demand days. A more accurate estimate of daily reductions can be made after compliance plans from the affected sources are approved by the Department.

Comparison to Federal Standards

There is a corresponding federal standard to this proposed action, but the proposed action is not more restrictive or stringent.

Estimate of Economic Impact

I. Summary of Economic Impact. All of Maryland’s coal-fired EGUs are currently equipped with either the most efficient or the second most efficient available NO_x control technology, SCR and SNCR or SACR, respectively. Compliance with the 2015 requirements will require all coal-fired units to operate and optimize existing pollution and combustion controls to minimize NO_x emissions during the ozone season. There are no new control technologies required for this action. Optimization of existing controls will require control and maintenance practices, including adjustments to the amount of urea being utilized by certain units. The cost of optimizing operation of the existing control technologies (SCR and SNCR and SACR) annually for each affected unit individually is estimated to be in the range of \$430,000 to \$4,300,000 million for each affected unit.

There will be no expected impact on the Department, other State agencies, or local governments as a result of this action.

- A. The Department maintains both a compliance and permitting program for major sources as required by the Clean Air Act. These programs will implement these regulations.
- B. There are no anticipated tasks or compliance activities required of other State agencies due to these regulations.
- C. There are no anticipated tasks or compliance activities required of local governments due to these regulations.
- D. There are no new control technologies required for this action. Companies must optimize their existing control equipment to meet the 2015 requirements. The annual operating and maintenance cost for a single unit can range from \$430,000 to \$4,300,000. Optimization of the operation of the existing controls may push annual operating and maintenance costs toward the high end of the estimates or even add some additional costs, but the exact additional cost if any cannot be determined at this time.

- F. Health benefits are influenced by many factors and monetizing benefits is difficult. Implementation of these regulations will result in

a reduction of incidents in which Marylanders experience adverse health effects, including hospitalizations, illnesses, restricted activity days and other effects caused by air pollution and exposure to ground level ozone. Ozone season economic benefits from reduced incidents range from \$5 to \$37,000,000 (in 2010 dollars).

.01 Definitions.

A. In this chapter, the following terms have the meanings indicated.

B. Terms Defined.

(1) “Affected electric generating unit” means any one of the following coal-fired electric generating units:

- (a) Brandon Shores Units 1 and 2;
- (b) C.P. Crane Units 1 and 2;
- (c) Chalk Point Units 1 and 2;
- (d) Dickerson Units 1, 2, and 3;
- (e) H.A. Wagner Units 2 and 3;
- (f) Morgantown Units 1 and 2; and
- (g) Warrior Run.

(2) “Operating day” means a 24-hour period beginning midnight of one day and ending the following midnight, or an alternative 24-hour period approved by the Department, during which time an installation is operating, consuming fuel, or causing emissions.

(3) “Ozone season” means the period beginning May 1 of any given year and ending September 30 of the same year.

(4) System.

(a) “System” means all affected electric generating units within the State of Maryland subject to this chapter that are owned, operated, or controlled by the same person and are located:

(i) In the same ozone nonattainment area as specified in 40 CFR Part 81; or

(ii) Outside any designated ozone nonattainment area as specified in 40 CFR Part 81.

(b) “System” includes at least two affected electric generating units.

(5) “System operating day” means any day in which an electric generating unit in a system operates.

(6) “30-day systemwide rolling average emission rate” means a value in lbs/MMBtu calculated by:

(a) Summing the total pounds of pollutant emitted from the system during the current system operating day and the previous 29 system operating days;

(b) Summing the total heat input to the system in MMBtu during the current system operating day and the previous 29 system operating days; and

(c) Dividing the total number of pounds of pollutant emitted during the 30 system operating days by the total heat input during the 30 system operating days.

(7) “24-hour block average emission rate” means a value in lbs/MMBtu calculated by:

(a) Summing the total pounds of pollutant emitted from the unit during 24 hours between midnight of one day and ending the following midnight;

(b) Summing the total heat input to the unit in MMBtu during 24 hours between midnight of one day and ending the following midnight; and

(c) Dividing the total number of pounds of pollutant emitted during 24 hours between midnight of one day and ending the following midnight by the total heat input during 24 hours between midnight of one day and ending the following midnight.

.02 Applicability.

The provisions of this chapter apply to an affected electric generating unit as that term is defined in Regulation .01B of this chapter.

.03 2015 NO_x Emission Control Requirements.

A. Daily NO_x Reduction Requirements During the Ozone Season.

(1) Not later than 45 days after the effective date of this regulation, the owner or operator of an affected electric generating unit (the unit) shall submit a plan to the Department and EPA for approval that demonstrates how each affected electric generating unit will operate installed pollution control technology and combustion controls to meet the requirements of §A(2) of this regulation. The plan shall summarize the data that will be collected to demonstrate compliance with §A(2) of this regulation. The plan shall cover all modes of operation, including but not limited to normal operations, start-up, shut-down, and low load operations.

(2) Beginning on May 1, 2015, for each operating day during the ozone season, the owner or operator of an affected electric generating unit shall minimize NO_x emissions by operating and optimizing the use of all installed pollution control technology and combustion controls consistent with the technological limitations, manufacturers’ specifications, good engineering and maintenance practices, and good air pollution control practices for minimizing emissions (as defined in 40 CFR §60.11(d)) for such equipment and the unit at all times the unit is in operation while burning any coal.

B. Ozone Season NO_x Reduction Requirements.

(1) Except as provided in §B(3) of this regulation, the owner or operator of an affected electric generating unit shall not exceed a NO_x 30-day systemwide rolling average emission rate of 0.15 lbs/MMBtu during the ozone season.

(2) The owner or operator of an affected electric generating unit subject to the provisions of this regulation shall continue to meet the ozone season NO_x reduction requirements in COMAR 26.11.27.

(3) Ownership of Single Electric Generating Facility.

(a) An affected electric generating unit is not subject to §B(1) of this regulation if the unit is located at an electric generating

facility that is the only facility in Maryland directly or indirectly owned, operated, or controlled by the owner, operator, or controller of the facility.

(b) For the purposes of this subsection, the owner includes parent companies, affiliates, and subsidiaries of the owner.

C. Annual NO_x Reduction Requirements. The owner or operator of an affected electric generating unit subject to the provisions of this regulation shall continue to meet the annual NO_x reduction requirements in COMAR 26.11.27.

D. NO_x Emission Requirements for Affected Electric Generating Units Equipped with Fluidized Bed Combustors.

(1) The owner or operator of an affected electric generating unit equipped with a fluidized bed combustor is not subject to the requirements of §§A, B(1) and (2), and C of this regulation.

(2) The owner or operator of an affected electric generating unit equipped with a fluidized bed combustor shall not exceed a NO_x 24-hour block average emission rate of 0.10 lbs/MMBtu.

.04 Compliance Demonstration Requirements.

A. Procedures for Demonstrating Compliance with Regulation .03A of this Chapter.

(1) An affected electric generating unit shall demonstrate, to the Department's satisfaction, compliance with Regulation .03A(2) of this chapter, using the information collected and maintained in accordance with Regulation .03A(1) of this chapter and any additional documentation available to and maintained by the affected electric generating unit.

(2) An affected electric generating unit shall not be required to submit a unit-specific report consistent with §A(3) of this regulation when the unit emits at levels that are at or below the following rates:

(3) The owner or operator of an affected electric generating unit subject to Regulation .03A(2) of this chapter shall submit a unit-specific report for each day the unit exceeds its NO_x emission rate

under §A(2) of this regulation, which shall include the following information for the entire operating day:

- (a) Hours of operation for the unit;
- (b) Hourly averages of operating temperature of installed pollution control technology;
- (c) Hourly averages of heat input (MMBtu/hr);
- (d) Hourly averages of output (MWh);
- (e) Hourly averages of ammonia or urea flow rates;
- (f) Hourly averages of NO_x emissions data (lbs/MMBtu and tons);
- (g) Malfunction data;
- (h) The technical and operational reason the rate was exceeded, such as:
 - (i) Operator error;
 - (ii) Technical events beyond the control of the owner or operator (e.g. acts of God, malfunctions); or
 - (iii) Dispatch requirements that mandate unplanned operation (e.g. start-ups and shut-downs, idling, and operation at low voltage or low load);
- (i) A written narrative describing any actions taken to reduce emission rates; and
- (j) Other information that the Department determines is necessary to evaluate the data or to ensure that compliance is achieved.

(4) An exceedance of the emissions rate under §A(2) of this regulation as a result of factors including but not limited to start-up, shut-down, days when the unit was directed by the electric grid operator to operate at low load or to operate pursuant to any emergency generation operations required by the electric grid operator, including necessary testing for such emergency operations, or which otherwise occurred during operations which are deemed consistent with the unit's technological limitations, manufacturers' specifications, good engineering and maintenance practices, and good air pollution control practices for minimizing emissions, shall not be considered a violation of Regulation .03A(2) of this chapter provided that the provisions of the approved plan as required in Regulation .03A(1) of this chapter are met.

B. Procedures for Demonstrating Compliance with NO_x Emission Rates under this Chapter.

(1) Compliance with the NO_x emission rate limitations in Regulations .03B(1) and D(2) and .04A(2) of this chapter shall be demonstrated with a continuous emission monitoring system that is installed, operated, and certified in accordance with 40 CFR Part 75.

(2) For Regulation .03B(1) of this chapter, in order to calculate the 30-day systemwide rolling average emission rates, if 29 system operating days are not available from the current ozone season, system operating days from the previous ozone season shall be used.

.05 Reporting Requirements.

A. Reporting Schedule.

(1) Beginning 30 days after the first month of the ozone season following the effective date of this chapter, each affected electric generating unit subject to the requirements of this chapter shall submit a monthly report to the Department detailing the status of compliance with this chapter during the ozone season.

(2) Each subsequent monthly report shall be submitted to the Department not later than 30 days following the end of the calendar month during the ozone season.

B. Monthly Reports During Ozone Season. Monthly reports during the ozone season shall include:

- (1) Daily pass or fail of the NO_x emission rates under Regulation .04A(2) of this chapter;
- (2) The reporting information as required under Regulation .04A(3) of this chapter; and

(3) *The 30-day systemwide rolling average emission rate for each affected electric generating unit to demonstrate compliance with Regulation .03B(1) of this chapter.*

A. A facility operator shall maintain complete and accurate records that identify for each table game and type of game by daily, cumulative month-to-date, and cumulative year-to-date basis:

- (1) Statistical drop;
- (2) Statistical win; and
- (3) Statistical win-to-drop percentages.

B. A facility operator shall:

- (1) Prepare and distribute statistical reports to gaming facility management on at least a monthly basis;
- (2) Using a 95 percent confidence interval, investigate fluctuations outside of the standard deviation from:
 - (a) The facility operator's table game win-to-drop percentage for the previous business year; or
 - (b) In the initial year of operations, the previous month; and
- (3) Document the results of the investigation required under §B(2) of this regulation in writing and submit a copy of the written investigation results to the Commission.

36.05.06 Poker Rules

Authority: State Government Article, §§9-1A-02(b) and 9-1A-04(d), Annotated Code of Maryland

.21 Triple Draw Poker; Procedures for Dealing; Completion of Play.

A. A facility operator that offers Triple Draw Poker shall follow the procedures in this regulation.

B. Players.

(1) No more than seven players may participate in a Triple Draw Poker game.

(2) A player who elects to participate in a round of play may be required to place an Ante bet.

(3) The rules governing the placement of an Ante bet and the amount of the Ante bet, and the Kill or Half-kill option, shall be specified in the facility operator's Rules Submission under COMAR 36.05.03.19 and posted on a sign at each Poker table.

C. Order of Betting.

(1) Button Placement. The dealer shall use a button to indicate the order in which the cards shall be dealt and the order in which players shall bet in accordance with the following procedures:

(a) At commencement of play, the dealer shall place the button in front of:

- (i) The first player to the right of the dealer; or
- (ii) The player randomly determined by rank of a single card dealt.

(b) Thereafter, the dealer shall rotate the button around the table in a clockwise manner after each round of play.

(2) Blind Bet.

(a) Before any cards are dealt, the player to the immediate left of the button shall initiate the first betting round by placing a Blind Bet.

(b) A facility operator may require additional Blind Bets to be made immediately after the initial Blind Bet.

(c) The amount and number of all Blind Bets required must be specified in the facility operator's Rules Submission under COMAR 36.05.03.19 and posted on a sign at the table.

(3) Straddle Bet.

(a) If the facility operator offers the Straddle Bet, the player to the left of the player who placed a Blind Bet may place a Straddle Bet.

(b) The rules governing the placement of a Straddle Bet and the amount of the Straddle Bet shall be specified in the facility operator's Rules Submission under COMAR 36.05.03.19 and posted on a sign at each Poker table.

(c) No more than one Straddle Bet may be made during a round of play.

D. Procedures for Dealing Cards.

(1) Starting with the player to the immediate left of the button and continuing around the table in a clockwise manner, the dealer shall deal five rounds of cards face down to each player so that the player with the button shall be the last player to receive a card each time.

(2) After each player has been dealt five cards in accordance with §D(1) of this section, each player, starting with the player to the left of the player or players who were required to place a Blind Bet or the player who placed a Straddle Bet, and continuing around the table in a clockwise manner, may fold, call, or raise the bet.

(3) The option to raise also applies to a player who made a Blind Bet or Straddle Bet.

(4) After the last player has responded to the most recent bet, the betting is complete.

(5) The dealer shall then burn the top card of the deck.

(6) Starting with the player to the immediate left of the button and continuing in a clockwise rotation, a player who has not folded may draw new cards.

(7) A player may keep the player's original hand or discard as many cards as the player chooses.

(8) The dealer shall replace a discarded card with a new card from the deck, and if an insufficient number of cards remain in the deck for a player to draw new cards, the dealer shall reshuffle the discarded cards and deal new cards to the player.

(9) The first player to the left of the button who has not folded shall commence the next betting round and may bet or check.

(10) In clockwise rotation, each subsequent player may fold, call, raise or, if preceding players have not made a bet, make an opening bet or check.

(11) After the last player has responded to the most recent bet, the second betting round is complete.

(12) Upon completion of the second betting round, the dealer shall burn the top card of the deck, and commence and complete the next betting round as required under this section.

(13) Upon completion of the third betting round, the dealer shall burn the top card of the deck, and commence and complete the final betting round as required under this section.

E. Completion of Play.

(1) If more than one player remains in the round of play after the final betting round has been completed, the dealer shall use a showdown to determine the winner of the pot.

(2) Each player remaining in the game shall form a hand of five-cards from different suites and ranked in accordance with Regulation .06 of this chapter.

(3) The winner of the pot is the player with the highest ranking five-card low hand, counted from the highest card in the hand to the lowest card in the hand.

(4) If a tie exists between two or more players for the highest ranking low hand, the pot shall be divided equally among the tied players.

(5) If the pot cannot be divided equally among the tied players, the excess, which may not exceed \$1, shall be given to the player specified in the facility operator's Rules Submission under COMAR 36.05.03.21.

(6) 2-7 Lowball Poker.

(a) An ace is used only as a high card.

(b) The best possible 2-7 Lowball Poker hand is 7, 5, 4, 3, 2 with all five cards not of the same suit.

(c) A straight, flush, or pair shall be considered for purposes of determining a winning hand.

(7) Ace-5 Lowball Poker.

(a) An ace is used only as a low card.

(b) The best possible Ace-5 Lowball Poker hand is a 5, 4, 3, 2, A, regardless of suit.

(c) A straight or flush shall not be considered for purposes of determining a winning hand.

F. Splitting the Pot. Notwithstanding the requirements in §E of this regulation, if specified in its Rules Submission, the facility operator may offer Triple Draw Poker and split the pot awarded between players as follows:

(1) In 2-7 Lowball Poker, if Baducey is being offered:

(a) Half of the pot shall be awarded to the highest ranking 2-7 Lowball Poker hand and the other half of the pot shall be awarded to the player with the best Badugi hand.

(b) For purposes of Baducey, a Badugi hand is a hand in which four of the player's five cards are of a different suit from the others and rank in accordance with Regulation .06 of this chapter with the best Badugi hand being a 2, 3, 4, and 5.

(c) If the pot cannot be split evenly, the excess, which may not exceed \$1, shall be given to the player with the highest 2-7 Lowball Poker hand.

(2) In Ace-5 Lowball Poker, if Baducey is being offered:

(a) Half of the pot shall be awarded to the highest ranking Ace-5 Lowball Poker hand and the other half of the pot shall be awarded to the player with the best Badugi hand.

(b) For purposes of Baducey, a Badugi hand is a hand in which four of the player's five cards are of a different suit from the others and rank in accordance with Regulation .06 of this chapter with the best Badugi hand being an ace, 2, 3 and 4.

(c) If the pot cannot be split evenly, the excess, which may not exceed \$1, shall be given to the player with the highest Ace-5 Lowball Poker hand.

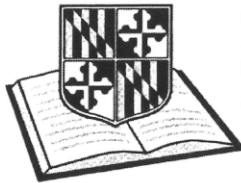
