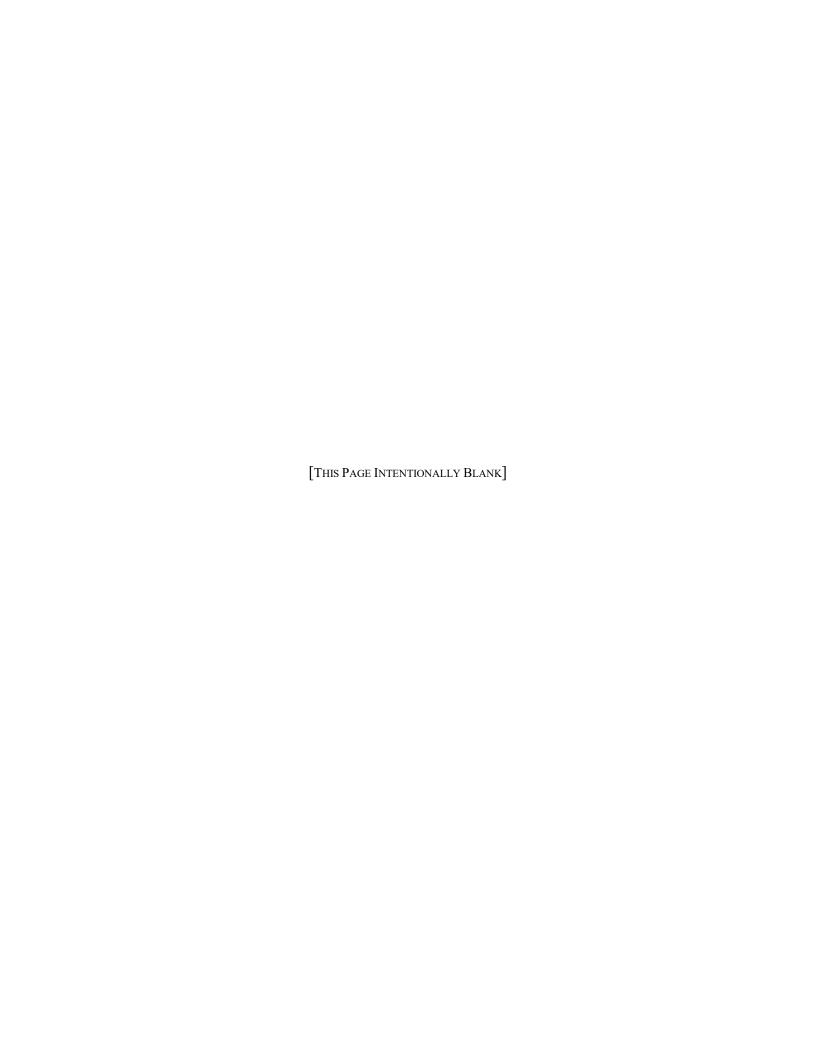

Report on the Administration of the Frederick County Ethics Law

October 2019 – September 2020

This report to the County Executive and the County Council describes the Frederick County Ethics Commission's work to administer the Ethics Law from October 2019 through September 2020. State law requires that this report be provided annually.

I. Ethics Commission meetings

During the reporting period, the Ethics Commission met on October 9, 2019, January 8, 2020, July 13, 2020, August 10, 2020, August 12, 2020, and September 9, 2020.

Copies of the meeting agendas and the approved minutes for these meetings are included in <u>Appendix A</u> and <u>Appendix B</u> of this report, respectively. The Commission's agendas and meeting minutes are also posted online.

II. Review of financial disclosure statements

A. Financial Disclosures

The Commission members review the financial disclosure statements filed by those County elected and appointed officials, employees and members of boards and commissions who are subject to the Ethics Law's annual filing requirements. (Financial disclosure statements are due in April of each year. The statements provide information for the previous calendar year.) Once the disclosure statements are received, the Commission reviews the statements to identify and address existing or potential conflicts of interest. Financial disclosure statements that are incomplete or raise questions about potential conflicts of interest are identified and the filers of those statements are contacted to obtain the additional information required for the Commission to determine whether there are conflicts of interest or violations of the Ethics Law. When concerns arise about compliance with the Ethics Law, the Commission provides guidance and direction to the official or employee.

During the period covered by this report, the Ethics Commission completed its review of the financial disclosure statements filed in 2019 and found no conflicts of interest. The Commission is in the process of reviewing the financial disclosure statements it received in 2020.

B. Advisory Opinions issued

The Commission issued no advisory opinions during the reporting period.

C. Action on complaints

The Ethics Commission received an ethics complaint in July 2020. The complaint alleged that a County official violated the "use of prestige of office" provision in the Ethics Law through postings on the official's Facebook page and public interactions. In August 2020, the Ethics Commission voted to dismiss the complaint, finding that the facts contained in the complaint, even if true, were insufficient to state a violation of the Ethics Law.

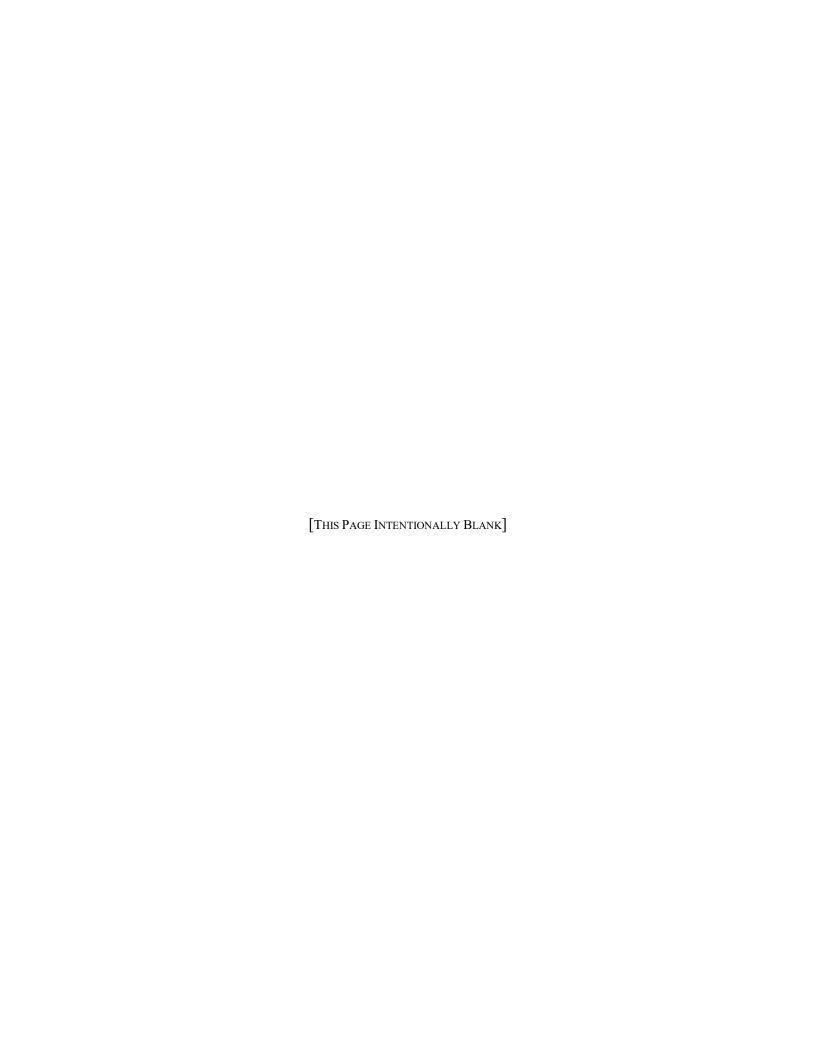
There were no other complaints filed during the period covered by this report.

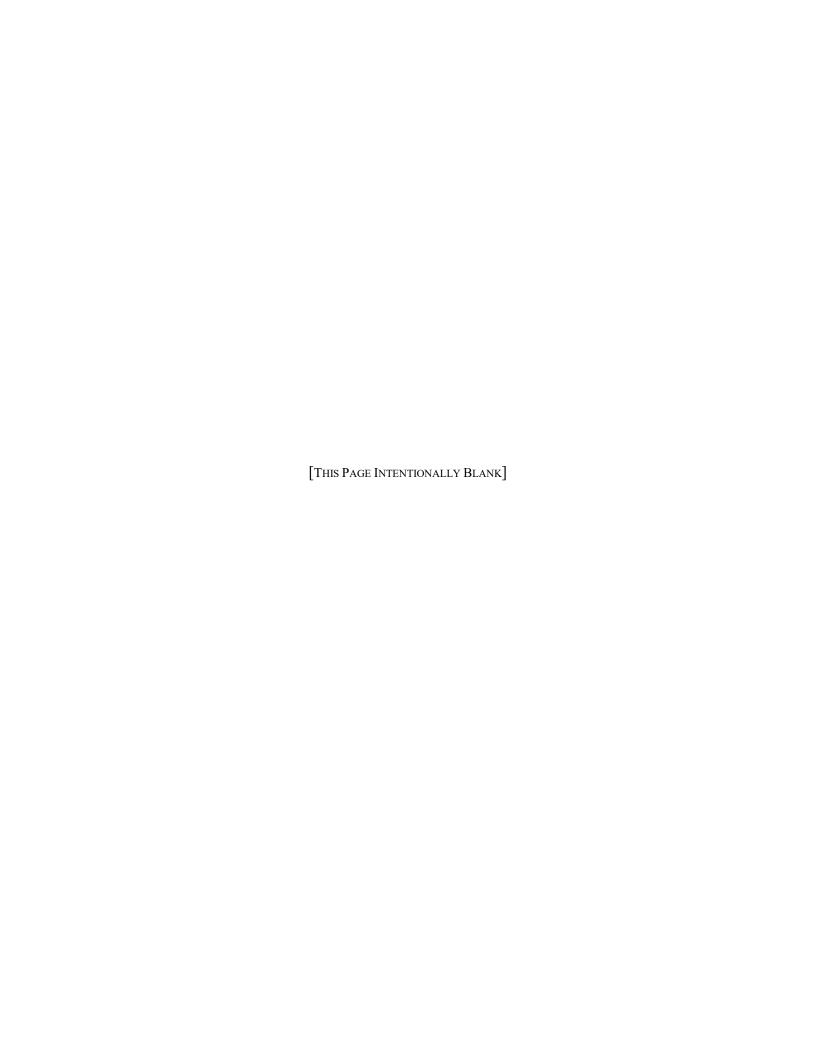

Frederick County Ethics Commission Minutes for the Public Meeting of Wednesday, October 9, 2019

The Frederick County Ethics Commission meeting started at 7:00 p.m. on October 9, 2019, in the Winchester Room on the 2nd floor of Winchester Hall, 12 East Church Street, Frederick, Maryland 21701.

<u>Discussion of financial disclosure statements</u> – Before the meeting, the members of the Ethics Commission received and reviewed the annual financial disclosure statements filed by those County officials and employees who are subject to the Ethics Law's filing requirements. The more detailed financial disclosure statements submitted by the County Executive, County Council Members, Chief Administrative Officer, County Attorney, Division Directors and members of the Planning Commission and Board of Zoning Appeals were distributed to each Ethics Commission member. The shorter financial disclosure statements filed by the remaining officials and employees who are subject to the financial disclosure requirements were divided into alphabetical groupings. Each grouping was assigned to a single Commission member for an initial review.

At the meeting, the Commission members identified and discussed issues arising out of their reviews. There were a number of disclosure statements that were incomplete or required clarification. The Senior Assistant County Attorney was directed to contact the persons filing those disclosure statements to obtain the additional information needed. The Commission members also identified some potential conflicts of interest that required further contact with the officials, employees or board or commission members to obtain additional information.

Mr. Canfield noted that in the private sector, members of some boards are given notice of their organization's conflict of interest policy and asked to disclose and address any potential conflicts of interest. He suggested that such a policy be considered for members of County boards and commissions. Mr. Hess noted that this could be accomplished through an amendment of the Ethics Law. Rev. Jones suggested that this could be an issue to raise in the Ethics Commission's annual report to the County Executive and County Council.

Adjournment

MOTION: Mr. Heller made a motion to adjourn. Mr. Stanker seconded the motion, which was approved unanimously.

<u>Public Ethics Report</u> – The Commission members received copies of the 2019 Public Ethics Report for the period January 1, 2019 through June 30, 2019, which was submitted by the Office of the County Executive. The Public Ethics Law requires that this report be provided to the Ethics Commission.

<u>Discussion of financial disclosure updates</u> – Before the meeting, the members received a written chart showing which officials and employees were contacted for additional information or clarification of information provided in their annual financial disclosure statements. After review of the information provided, the Commission members did not see a need for additional action regarding any of the individual forms submitted. The Commission noted that the electronic financial disclosure form needs to require that all of the required information be provided before the form is filed with the Ethics Commission. The County is aware of this need and anticipates that the revisions to the electronic forms will be made before the next distribution of the statements in April 2020.

<u>November 2020 meeting date</u> – The Commission noted that the second Wednesday of the month, which is the normal day on which the Commission meets, falls on a County holiday in November. The Commission will discuss whether the November meeting will be held and, if necessary, select a new meeting date later in the year.
