

County History At a Glance

Home of Harriet Tubman, Underground Railroad conductor, who led dozens of enslaved people to freedom and Anna Ella Carroll, who assisted President Abraham Lincoln in the Civil War.

Also home to seven prior Governors for the State of Maryland: John Henry; Charles Goldsborough; Thomas King Carroll; Thomas Holiday Hicks; Henry Lloyd; Emerson C. Harrington; Phillips Lee Goldsborough.

The County Seal was designed by Andrew Tolley and adopted by the County Commissioners in 1967. It depicts a waterman holding a pair of oyster tongs and a crab pot facing a farmer holding a cornstalk and pitchfork with the popular "bluecrab" at the top. The center shield is divided to show county interests: sailing, religious heritage, industry and shorelines. The background is a map of the County surrounded by blue water. On the small banner under the shield is written in Latin "Populus prope deum habitans" or "people living under the care of God". The gold banded border is imprinted with the County's name and 1669, the year the County became a unit of government.

COUNTY BUDGET HIGHLIGHTS

Per the County Charter, the Council is required to adopt a balanced budget no later than May 31st of each year. The County 's fiscal year is July 1st through June 30th.

In addition to funding County government services, the Council provided funding to the Board of Education and Chesapeake College.

23% of General Fund Operating Budget is devoted to education

LEGISLATIVE WRAP UP

Legislation

In Fiscal Year 2022 the Dorchester County Council adopted the following legislation pertaining to local government:

- Enacted new Section 40-14(E) entitled "Exemption Broadband Projects" to Section 40-14 Entitled
 "Permit Requirements" to Article II Entitled "Excavations" to Chapter 40 entitled "Roads" of Article 10 of
 the Code of Public Local Laws of Maryland for the purpose of providing for an exemption for broadband
 projects from the payment of the square foot surface openings in the surface of any road, street or
 thoroughfare.
- Amended Section 68-1(B) of Chapter 68 of The Dorchester County Code entitled "Chesapeake Bay Critical Area", providing for a definition of the term Nonwater-Dependent Project and to add new Section 68-25(N) to Chapter 68 Of Dorchester County Code providing for the permitting of nonwater-dependent projects on state or private wetlands within the 100 foot and expanded buffer of the critical area.
- Declared a certain parcel of land situate on Middle Street, containing 35,773 square feet of land, more or less, in the Town of Vienna, Vienna Election District of Dorchester County, Maryland, is no longer needed for public use by the County and providing for the sale of the property to the Commissioners of Vienna, a municipal corporation of the State of Maryland, at and for the purchase price of zero dollars and without a reverter clause.
- Approved the issuance by the Dorchester County Sanitary District, Inc. (the "District") of a bond of the district in the principal amount of \$65,000.00 to be known as "Dorchester County Sanitary District, Inc., Water System Bond (Bonnie Brook Sanitary District No. 2) Series B (the "bond"), to be issued pursuant to the authority of Sections 9-601 to 9-699 of the Environment Article of the Annotated Code of Maryland, providing that the payment of the principal of and interest on the bond shall be guaranteed by Dorchester County, Maryland, providing that the bond shall be issued upon the full faith and credit of Dorchester County, Maryland; and providing for the levy of annual taxes upon all assessable property within the Bonnie Brook Sanitary District No. 2 sufficient for the payment of the principal of and interest on the bond as it shall mature, and, to the extent that such levy is insufficient for such purposes, the levy of annual taxes upon all the assessable property within the corporate limits of Dorchester County for the payment of the principal of and interest on the bond as provided hereinabove.
- Pursuant to Section 10-202 And Section 10-328 of the Local Government Article of the Annotated Code of Maryland to Repeal and Reenact Section 116-6(A) entitled "Enforcement; Complaint, Investigation and Abatement" of Chapter 116 entitled "Nuisance Control" Of The Dorchester County Code to provide that depending on the violation, The Health Officer Of Dorchester County or his designee or the designated agent of the Department Of Planning And Zoning shall be the enforcement officer of Chapter 116 of the Dorchester County Code.
- Amended the 2021-2022 Annual Budget and Appropriation Ordinance of Dorchester County.
- Amended 155 Attachment 1, D, Entitled "Table Of Permitted Uses By Zoning District Dorchester County, Maryland", of Chapter 155 Entitled "Zoning" of the Dorchester County Code to add a new use category entitled "Unclassified" providing that non-commercial personal storage uses are permitted in the B-1 Neighborhood Business District, and the B-2 General Business District, and the I-1 Light Industrial District, and the I-2 Heavy Industrial District, subject to certain requirements.

In Fiscal Year 2022 the Dorchester County Council adopted the following legislation pertaining to local government:

- Amended the 2021-2022 Annual Budget and Appropriation Ordinance of Dorchester County, which
 established the County budget, consisting of the operating budget, the capital budget, and the grant
 budget, for the fiscal year ending June 30, 2022; and appropriating funds for all expenditures for the
 fiscal year beginning July 1, 2021 and ending June 30, 2022, to provide a mid-year compensation
 adjustment.
- Adopted the 2022-2023 Annual Budget and Appropriation Ordinance of Dorchester County.
- Repealed and reenacted Section 82-8, Records and Reports of Board, and Section 82-12, Applications For Registration, and Section 82-13, County Residents Presently Engaged In Established Electrical Business, and Section 82-14, Qualifications Required For Registration Applicants, and Section 82-16, Examinations, and Section 82-17, Fees And Bond, and Section 82-18. Revocations Or Suspensions Of Registration; Hearing, and Section 82-19, Reciprocity Of Chapter 82. Electrical Standards of the Dorchester County Code providing for applications for registration for master electricians, journeyperson electricians, or apprentice electricians, and providing that an electrician general class of electricians is established in Dorchester County, Maryland, and providing for the licensure and registration of qualified electrician generals in Dorchester County, Maryland, and providing that any applicant that applies for registration under this Chapter that has been licensed by the State Board Of Electricians as an apprentice electrician or as a journeyperson electrician or as a master electrician are qualified for registration as in such grade under Chapter 82, and providing for fees for registrations and permits, and providing for insurance requirements for registrants, and providing for revocations or suspensions and hearings, and providing for reciprocity, and providing generally for the regulation and registration of Master Electricians, Journeyperson Electricians, or Apprentice Electricians and the licensure and registration of Electrician Generals.

Resolutions

In Fiscal Year 2022 the Dorchester County Council adopted the following resolutions pertaining to local government:

- Reclassified Local Management Board (also known as Community Partnership For Children, Youth & Families) from a public agency operating as an instrument of County Government to a quasi-public nonprofit corporation that is not an instrument of County Government and designated Moving Dorchester Forward, Inc. as the LMB for Dorchester County effective July 1, 2022.
- Amended the County's Schedule of Fees for FY23.
- Amended 2004 Comprehensive Water and Sewer Plan by changing the designation of the parcel designated as Parcel 24 of Dorchester County Tax Map 12, Zoned B-2 General Business, in the Hurlock Election District of Dorchester County, Maryland known as Suicide Bridge Restaurant, from "No Planned Service" to "S-1" Sewerage Service.

- Baltimore Sun Media Group created an interactive travel hub that contained itineraries as well as content to inspire travel to Dorchester which reached multiple markets in an effort to enhance tourism.
- Branded content and native ads were placed in multiple markets and states surrounding Maryland to inspire travelers to inspire and educate about Dorchester's rich heritage and culture.
- Utilized several social influencers to create a first- hand experience visiting Tubman Byway,
 Choptank Lighthouse, various restaurants, etc. to influence their large group of followers to do the same.
- Dorchester County utilizes Baltimore Sun Media Group response and reputation in social media to amplify branded content which resulted in a large audience reading the content and increasing web traffic.
- Harriet Tubman anniversary year and Black History Month huge celebration throughout the year to promote Harriet Tubman's 200th Anniversary celebration.

- Evaluated regional market value for Airport T-hangars, resulting in a 7.5% monthly rent increase while maintaining 100% hangar tenancy with 32 persons on the waiting list.
- Increased tie down leases from 1 in FY21 to 4 in FY22.
- Replaced courtesy car with a new model vehicle surplused by the Sheriff's Office and an aging Airport Operations truck with a late model truck using funds from the FY20 Capital budget.
