Introduction

The Annotated Code of Maryland Education Article § [7-1102](#) requires the Maryland State Department of Education (MSDE) to report to the General Assembly annually (on or before December 1 each year) on the findings and recommendations reported to the MSDE by local education agencies (LEAs), other non LEA public agencies, and nonpublic schools on physical restraint and seclusion. The legislation specifically requires the collection of the following data:

1. Number of physical restraint and seclusion incidents, disaggregated by the student's jurisdiction, disability, race, gender, age, and type of placement; and
2. Professional development provided to designated school personnel related to positive behavioral interventions, strategies and supports and trauma-informed interventions.

On December 1, 2018, the MSDE submitted the first Restraint and Seclusion report, as mandated by Education Article § 7-1102.1, based on 2017-2018 school year data. The 2022 Physical Restraint and Seclusion Report: Data Collection, Findings, and Recommendations draws on 2021-2022 school year data. As with previous reports, the 2022 report describes the data collection process, provides summary data for the 2021-2022 school year based on public agency, and nonpublic school responses, and outlines findings and recommendations based on an analysis of the information gathered.

Implementation of Section 7-1104 of the Education Article of the Annotated Code required MSDE to modify the way data was collected to meet the unduplicated student level requirements. This report contains information on total incidents of physical restraint and seclusion disaggregated by disability category, race, gender, age, and type of placement. This information remains consistent with past reports for public agencies. New to the 2022 report is this same information for each nonpublic school, rather than one aggregate total incident number for nonpublic schools as in years past. Also new for the 2022 report are tables reflecting unduplicated student incident counts for physical restraint and seclusion disaggregated by disability category, race, gender, age, and type of placement for both public agencies and nonpublic schools.

Information gathered for this report is organized within four sections.

- Section I contains all data for incidents of physical restraint.
- Section II contains all data related to incidents of seclusion.
- Section III consists of information related to the review of seclusion rooms and all professional learning experiences.
- Section IV provides insights and recommendations.

Background

The use of physical restraint and seclusion by school personnel should be highly irregular and only used by trained personnel. Definitions and guidance are provided by MSDE to ensure all stakeholders conduct their duties with the utmost care for student wellbeing and at the highest level of professional responsibility.

The Code of Maryland Regulations (COMAR) [13A.08.04.02](#) defines physical restraint as, “a personal restriction that immobilizes or reduces the ability of a student to move the student’s torso, arms, legs, or head freely.” Physical restraint does not include:

1. “briefly holding a student to calm or comfort the student;
2. a physical escort, which is the temporary touching or holding of the hand, wrist, arm, shoulder, or back for the purposes of inducing a student who is acting out to walk to a safe location;
3. moving a disruptive student who is unwilling to leave the area if other methods such as counseling have been unsuccessful; or
4. intervening in a fight in accordance with Education Article §7-307, Annotated Code of Maryland.”

COMAR [13A.08.04.02](#) defines seclusion as, “the involuntary confinement of a student alone in a room or area from which the student is physically prevented from leaving...[Seclusion] does not include a timeout, which is a behavior management technique that is part of an approved program that involves the monitored separation of the student in a non-locked setting and is implemented for the purpose of calming.”

Under COMAR [13A.08.04.05](#) *General Requirements for the Use of Restraint or Seclusion*, the use of physical restraint or seclusion is prohibited in Maryland public agencies (a category that includes both LEAs and other [non-LEA] public agencies) and nonpublic schools until there is an emergency situation and physical restraint or seclusion, “is necessary to protect a student or other person from imminent serious physical harm after other less intrusive, nonphysical interventions have failed or been determined inappropriate.”

Md. Educ. Art. § 7-1104 bans the use of seclusion in all public agencies beginning July 1, 2022. Seclusion was an allowable practice used by public agencies and nonpublic schools during the 2021-2022 school year and information about the frequency of the use is contained within this report. The *2023 Physical Restraint and Seclusion Report: Data Collection, Findings, and Recommendations* will reflect the banned use of seclusion in public agencies.

In instances where the number of students and number of incidents in a cell were less than 10, the data were replaced with an asterisk to protect student identity.

Physical Restraint and Seclusion Data Collection

To obtain the specific data required under the Annotated Code of Maryland Education Article §7-1102 for the 2022 Physical Restraint and Seclusion Report: Data Collection, Findings, and Recommendations, covering the 2021-2022 school year, the MSDE required data be communicated using two different methods: 1) Incident data was entered into a spreadsheet and uploaded to the secure file transfer system MoveIT (Sections I and II), and 2) Information about professional learning experiences were captured using an electronic survey (Section III). For the collection of 2021-2022 SY data, MSDE disseminated the spreadsheet and survey to all public agencies and nonpublic special education schools in August 2022. The term public agencies refers to all 24 LEAs, the SEED School, Maryland School for the Blind, and Maryland School for the Deaf.

INCIDENT DATA

Each incident of physical restraint and seclusion that occurred during the 2021-2022 school year was entered as an individual data field and required the following information.

- LEA number, public agency name, or nonpublic school
- School number, school name
- Student identifying information:
 - Local student Identification number
 - State assigned student identification number
 - Date of birth
 - Gender (male, female, nonbinary)
 - Hispanic/Latino ethnicity (yes or no)
 - Race
 - Grade
 - Special education indicator (yes or no)
 - Special education disability code
 - Special education placement type
 - Section 504 plan (yes or no)
 - English Learner (yes or no)

- Physical restraint data for the 2021-2022 school year:
 - Date of physical restraint
 - Was the period of restraint 30 minutes or less (yes or no)
- Seclusion data for the 2021-2022 school year:
 - Date of seclusion
 - Was the period of seclusion 30 minutes or less (yes or no)

Professional Learning Experiences Information

- Seclusion Room Certification
 - Indicating that an individual from the LEA, public agency, or nonpublic school has:
 - Observed each seclusion room during the 2020-2021 school year; and
 - Reviewed the training plan(s) for seclusion during the 2020-2021 school year.
 - Name and title of the individual(s) who:
 - Conducted the observation of the seclusion room(s); and
 - Reviewed the training plan(s) for seclusion.
 - Findings from the observation of the:
 - Seclusion room(s); and
 - Training plan(s) for seclusion.
 - If your local public agency, or nonpublic school did not observe its seclusion room(s) and/or review its training plan(s) for the 2020-2021 school year, explain why.
- Provision of professional development training relating to physical restraint and/or seclusion to school personnel during the 2021-2022 school year:
 - The total number of hours of training required for school personnel to be considered authorized to perform physical restraint and/or seclusion.
 - The content of the professional development training provided to school personnel.
 - On average, the number of unique professional development training events that school personnel were required to participate in.
 - On average, the duration of each professional development training event provided.
 - The position(s) held by the person(s) conducting the professional development training event(s).

- The total number of individuals who received professional development training related to physical restraint and/or seclusion; and
- The positions held by the individuals who received the professional development training.

Section I: Physical Restraint Incidents

PHYSICAL RESTRAINT PUBLIC AGENCIES

Public agencies include all 24 LEAs, the SEED School, Maryland School for the Blind, and Maryland School for the Deaf. All 2021-2022 physical restraint data for public agencies are provided in tables 1 through 9 of this report.

Total Number of Physical Restraint by Public Agency

Table 1 shows the statewide total number of 4,291 reported physical restraint incidents occurring with 1,189 students for the 2021-2022 school year, disaggregated for each individual public agency. Additionally, the table includes for reference, the total student enrollment for each public agency.

In instances where the number of students and number of incidents in a cell were less than 10, the data were replaced with an asterisk to protect student identity.

In instances where the number of incidents were greater than 0 but less than 10, the data was replaced with an asterisk to protect student identity.

In the instances where the number of students in a student group was less than 10, the data was replaced with an asterisk to protect student identity.

PHYSICAL RESTRAINT NONPUBLIC SCHOOLS

Publicly funded Type I and II nonpublic schools provide instruction for students in general and special education. There are a total of 71 nonpublic schools serving the needs of students with special education services that are eligible to utilize restraint and/or seclusion. Of the 71 eligible schools, 67 reported data on the use of restraint and/or seclusion. Of the 67 that reported, 19 indicated they either do not utilize restraint and/or seclusion or report zero incidences of restraint and/or seclusion in this reporting year. All 2021-2022 physical restraint data for nonpublic schools are provided in tables 12 through 20 of this report.

Table 12 shows the statewide total number of reported physical restraint incidents 3,467 occurring with 571 students in a nonpublic school for the 2021-2022 school year, disaggregated for each individual nonpublic school.

Section II: Seclusion Incidents

SECLUSION BY PUBLIC AGENCIES

Public agencies include all 24 LEAs, the SEED School, Maryland School for the Blind, and Maryland School for the Deaf. All 2021-2022 seclusion data for public agencies are provided in tables 23 through 33 of this report. Fourteen of the public agencies (13 LEAs, Maryland School for the Deaf) prohibited the use of seclusion through policy and/or practice in the 2021-2022 school year, this is noted in the following tables with the word prohibited. The 2021-2022 school year was the last year in which seclusion was allowed to be used in all Maryland public agencies. Annotated Code of Maryland Chapter 31 (House Bill 1255) Physical Restraint and Seclusion – Limitations, Reporting and Training bans the use of seclusion in all public agencies beginning July 1, 2022.

Total Number of Seclusions by Public Agency

SECLUSION NONPUBLIC SCHOOLS

Publicly funded Type I and II nonpublic schools provide instruction for students in general and special education. There are a total of 71 nonpublic schools serving the needs of students with special education services that are eligible to utilize restraint and/or seclusion. Of the 71 eligible schools, 67 reported data on the use of restraint and/or seclusion. Of the 67 that reported, 19 indicated they either do not utilize restraint and/or seclusion or report zero incidences of restraint and/or seclusion in this reporting year. All 2021-2022 physical restraint data for nonpublic schools are provided in tables 12 through 20 of this report.

OBSERVATIONS OF SECLUSION ROOMS AND REVIEW OF TRAINING PLANS FOR SECLUSION

The survey was configured so that only respondents who allow for the use of seclusion as a practice were asked to respond to items related to the use of seclusion. Survey respondents that used seclusion were asked to report on whether someone from their LEA, other public agency, or nonpublic school had observed their systems or school's seclusion room(s) and reviewed their systems or school's training plan(s) for seclusion during the 2021-2022 school year. One hundred percent of respondents indicated that seclusion rooms were observed and that training plans were reviewed.

Section III: Professional Development Provided by Public Agencies and Nonpublic Schools

To obtain the specific data required under the Annotated Code of Maryland Education Article §7-1102 for the 2022 Physical Restraint and Seclusion Report: Data Collection, Findings, and Recommendations, covering the 2021-2022 school year, the MSDE required data be communicated using two different methods: 1) Incident data was entered into a spreadsheet and uploaded to the secure file transfer system MoveIT (Sections I and II), and 2) **Information about professional learning experiences were captured using an electronic survey (see Appendix A).**

Survey respondents were asked to report on professional development training relating to physical restraint and seclusion provided to school personnel during the 2021-2022 school year. The following section of the report summarizes the professional development training related to physical restraint and seclusion delivered by public agencies and nonpublic special education schools during the 2021-2022 school year.

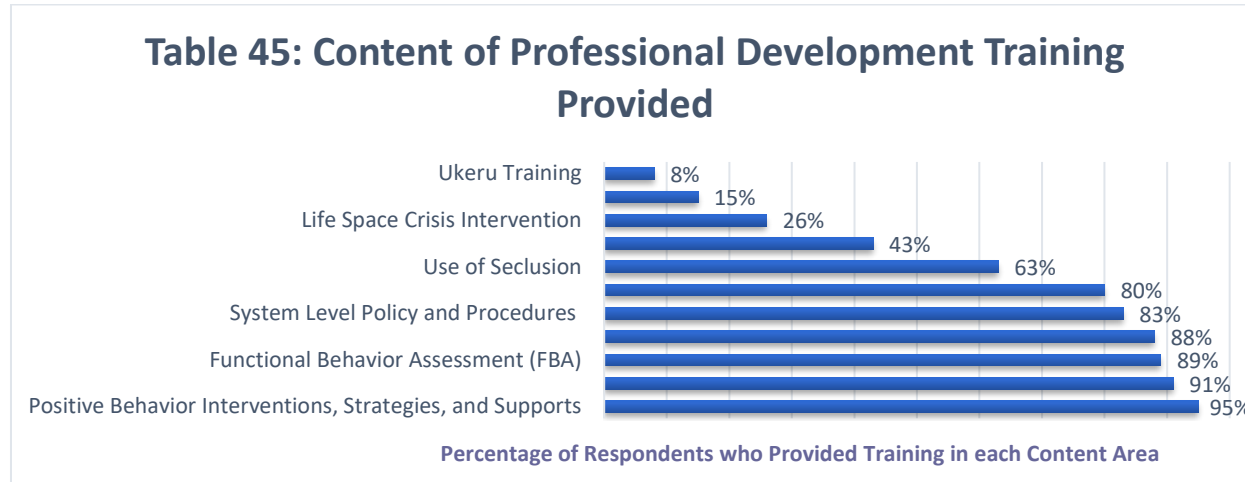
NUMBER OF HOURS OF PROFESSIONAL DEVELOPMENT TRAINING REQUIRED

Survey responses indicate the number of professional development hours required for authorization to perform physical restraint and/or seclusion varied across public agencies and nonpublic special education schools. For individuals being trained for the first time, the number of training hours required by public agencies ranged from six to 35 hours, while for individuals undergoing reauthorization training, the number of training hours required by LEAs ranged from three to 32 hours. The responses for nonpublic special education schools ranged from four to 49 training hours.

CONTENT OF PROFESSIONAL DEVELOPMENT TRAINING

Table 45 shows the type of trainings public agencies and nonpublic special education schools provided to school personnel during the 2021-2022 school year, disaggregated by the percentage of respondents who indicated that they provided training in the specified content areas.

Table 45: Content of Professional Development Training Provided

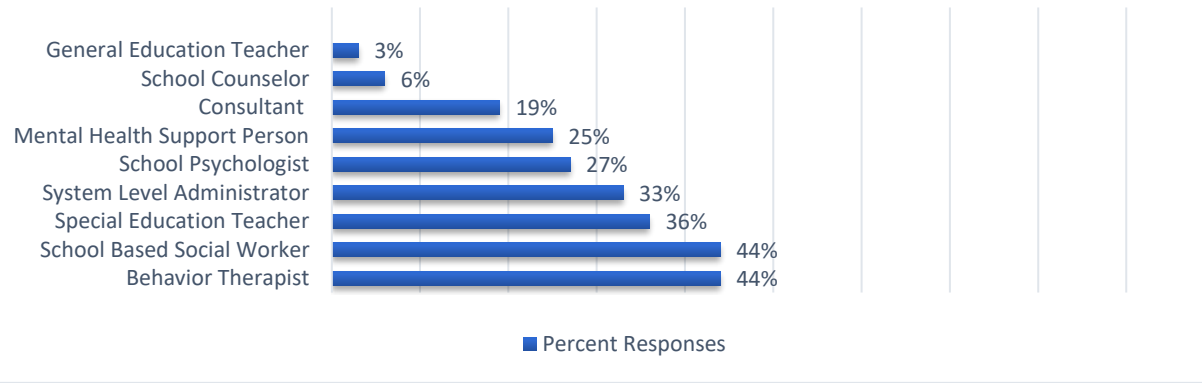

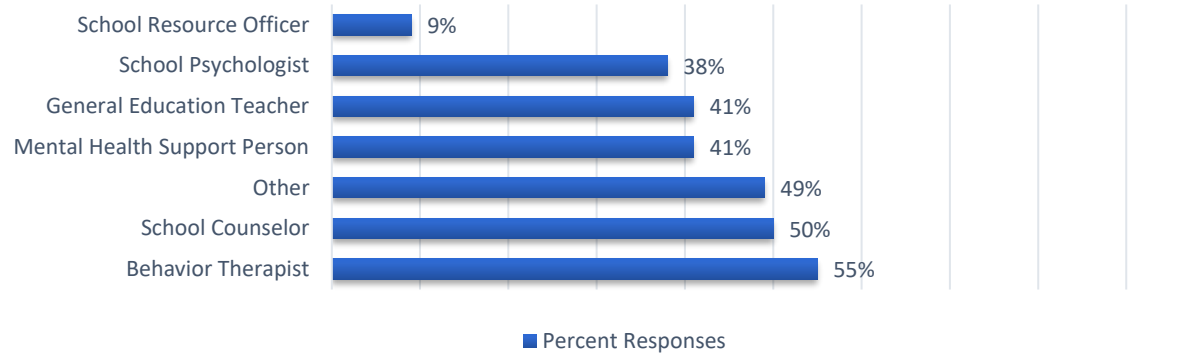

Table 47 shows the positions held by those individuals receiving professional development training for restraint and seclusion during the 2021-2022 school year. Forty-nine percent of respondents indicated other and provided the title of positions. These include teaching assistants, kitchen staff, nurse, childcare workers, related service providers, registered behavior technicians, behavior coach, IEP coordinator, reading interventionist, and administrative assistant.

Section IV: Recommendation

This report presents data collected on physical restraint and seclusion for public agencies and nonpublic schools in Maryland during the 2021-2022 school year. The following action items will be initiated during the 2022-2023 school year to provide support to public agencies and nonpublic schools as they meet the new legislative requirements (Md. Educ. Art. § 7-1104) and utilize approaches to eliminate and/or reduce the use of physical restraint and seclusion.

- The MSDE will establish an internal, cross-departmental team to review and evaluate progress and address the use of physical restraint and seclusion in all public agencies and nonpublic schools for all students. This team will work closely with the State Superintendent of Schools to implement all aspects of and revise existing COMAR regulation 13A.08.04 Student Behavior Interventions.
- The MSDE acknowledges that the ban of seclusion within those systems who have been utilizing the practice will require expanded professional learning experiences and direct technical assistance to ensure student and staff wellbeing and safety. The MSDE will conduct on-site meetings with all public agencies that used seclusion during the 2021-2022 school year to ensure compliance (Md. Educ. Art. § 7-1104). The on-site meeting will include an audit of spaces formerly used as seclusion rooms. While seclusion remains an allowable practice in nonpublic schools, MSDE will partner with nonpublic personnel to support the use of appropriate replacement strategies through professional learning experiences and direct technical assistance.
- Information provided by public agencies and nonpublic schools related to professional learning conducted within their organization and system demonstrates the need for more clearly defined expectations by MSDE. To this end, MSDE will develop a collection of behavior intervention professional learning resources for educational personnel.
- A process guide will be developed and disseminated to all public agency and nonpublic school personnel. Included in this process guide will be a recommended single incident form to be used to document each incident of physical restraint and/or seclusion (nonpublic only). The process guide will also include forms required for use by all public agencies and nonpublic schools to meet the notification of excessive use of physical restraint and/or seclusion (nonpublic only) and system level review requirements defined within (Md. Educ. Art. § 7-1104). Information within this guide will detail the specifics of how, when, and who notifies MSDE and completes the system level review. The guide will also include the procedures for corrective action plan development and progress monitoring that will be implemented beginning in the 2022-2023 school year.
- The MSDE will develop and disseminate an Implementation Guide that will provide information and clarification about the use of physical restraint and seclusion for all Maryland students. The Implementation Guide will be written in a way to provide information to any stakeholder, parent, student, educator, support personnel, community member, health professionals, etc.
