***Implementation of State and Local School System Policies and Regulations to Address Gangs, Gang Activity, and Similar Destructive or Illegal Group Behavior.***

**Introduction**

The Safe Schools Act of 2010 required the Maryland State Department of Education (MSDE) to submit a report, on or before January 1, 2011, and each year thereafter, to the Maryland General Assembly regarding the implementation of State and local school system (LSS) policies/regulations to address gangs, gang activity, and similar destructive or illegal group behavior. This report provides the requested information for Maryland's 24 LSSs.

The Act also required the Maryland State Board of Education (MSBE), in consultation and collaboration with the Department of Juvenile Services, the Department of State Police, the Department of Human Resources, and local school systems to develop a Model Policy to Address Gangs, Gang Activities, and Similar Destructive or Illegal Group Behavior (Model Policy) no later than March 31, 2011. LSSs were also required to develop local policies/regulations to address gangs, gang activity, and similar destructive or illegal group behavior (which included all components of the MSBE's Model Policy) and to submit these policies/regulations to the State Superintendent of Schools no later than September 1, 2011.

Each LSS was required by law to: 1) publicize its policies/regulations in student handbooks, on school system websites, and at any other location or venue the LSSs determined was necessary or appropriate; and 2) develop the following educational programs to address gangs, gang activity, and similar destructive or illegal behavior – a. an educational gang awareness program for students, staff, volunteers, and parents; b. a teacher and administrator development program that trains teachers and administrators to implement the policy/regulations.

This report to the Maryland General Assembly addressed the requirements outlined in the Safe Schools Act of 2010. Since there are 24 local public school systems in the State, the most succinct and informative method of providing this information is in chart form, with each local school system's chart indicating the status of: 1) where its gang policy/regulations are publicized; 2) what educational gang awareness program(s) are being provided for students, staff, volunteers, and parents; and 3) how administrators and teachers are/were trained to implement the gang policy/regulations.

All of the Local School Systems have updated their policies since 2010 which can be found on their district website. All systems provide gang awareness training such as training from local law enforcement agencies, the G.R.E.A.T program in elementary and middle schools, information from the U.S. Attorney's Office and DARE program. All LSSs also have a mechanism where the community can report alleged gang activity, which would be subsequently reviewed and investigated by the appropriate staff members.

Gang-Related Activity is currently a violation of The AACPS Student Handbook. The approach to handling gang related concerns level 2-5 consequences and may carry a major incident referral for a request of (45) day extended suspension pending outcomes of the level 5 investigation.

Our gang related policy/regulations prohibits students from knowingly participating in gang and/or gang-like activity, irrespective of whether schools are in session, within Board of Education owned or leased property, including school buildings or on school grounds; on school buses or other school vehicles; or during any school, or school sponsored activity, whether held on school property or at locations off school property, which includes, but is not limited to:

1. Wearing, possessing, using, distributing displaying, or selling any clothing, jewelry, emblem, badge, symbol, sign, or other item which evidences or reflects membership in or affiliation with any gang.
2. Commission of any act which furthers the interests of any gang, gang-like activity, or act of violence, including but not limited to:
3. Solicitation for membership in a gang.
4. Requesting any person to pay for protection or otherwise intimidating or threatening any person.
5. Committing or inciting criminal acts or violation of AACPS policies.
6. Soliciting other students to engage in physical violence against any other person.
7. Engaging in any act, either verbal or nonverbal, including gestures handshakes, slogans, drawings, etc. showing membership or affiliation with any gang.
8. Challenging or provoking fights, stare-downs, mad-dogging (threatening glance; to stare fixedly at someone in a hostile manner), flashing colors, verbal remarks, etc.
9. Marking or defacing school property with messages, symbols, or slogans that may signify gang affiliation.
10. Displaying gang apparel, signs, symbols, or slogans on personal property.
11. Engaging in physical confrontations where one or more persons confront another individual or group.
12. Using electronic devices such as pagers, cell phones, or computers to communicate gang activities while on school property.

The current Baltimore City Public Schools' gang policy was approved on July 26, 2011.
- 2. Have your gang policy/regulations been updated? If so, please provide date and brief summary of changes.**  
N/A. The gang policy/regulations have not been updated since approval on July 26, 2011.
- 3. Where are your gang policy/regulations located/electronically communicated?**  
The gang policy/regulations are posted on City Schools' website ([www.baltimorecityschools.org](http://www.baltimorecityschools.org)). In addition, the Gang-Related Reporting Form is included in the district's Code of Conduct booklets, as well as available at all schools.
- 4. What educational gang awareness programs are your school system providing for students, staff, and volunteers?**  
The City Schools' Police force offers a presentation on gang awareness to school communities. Presentations have been made to school staff, students, and community and parent groups. The City Schools' website for school administrators includes a Current Trends on Gangs PowerPoint, the Office of Juvenile Justice and Delinquency Prevention (OJJDP) Gang Awareness Handbook, and the Parent's Guide to Gangs pamphlet. School Police officers teach Gang Resistance Education and Training (G.R.E.A.T.) program to elementary and middle school students. City Schools also holds a G.R.E.A.T Summer Camp for students each year.
- 5. In what ways do you feel your gang awareness programs were effective?**  
City Schools considers the decrease in reported gang activity throughout the school district as demonstrated evidence of program effectiveness.
- 6. How were/are administrators and teachers trained to implement your gang policy/regulations?**  
The policy and regulations were disseminated on "City Schools Inside", the City Schools' website that shares requirements and information to school system administrators. The information has appeared weekly in the "Take Action" section since September 2, 2011. The policy requires school administrators to provide professional development for staff on criminal gang prevention and intervention. Additionally, School Support Liaisons (SSLs) provide ongoing training, guidance, and support to school administrators on implementation of the Code of Conduct, which includes disciplinary interventions and responses for gang-related offenses.
- 7. Is there a mechanism in place for community members to report gang activity involving school age youth to local schools? If so, please describe the procedure (data collection).**

City Schools has a dedicated telephone line for community members to express public safety concerns, including issues involving gang activity amongst school age youth. All matters will be subsequently reviewed and investigated by the appropriate staff members.

**8. Do you feel that gang related issues and similar destructive or illegal behavior has increased, decreased, or remained the same as the previous school year?**

Data shows that reported gang related issues and similar destructive or illegal behavior within the school district has decreased due to the gang awareness programs offered by City Schools' Police.

The School Police Officers have been teaching the G.R.E.A.T and D.A.R.E program within Baltimore City Public Schools for several years and it has proven to be an effective tool in gang awareness and prevention.

A synopsis of the policy and rule is published in the *Student Handbook* and titled Gang Activity and Similar Destructive or Illegal Group Behavior. This handbook is distributed to all students at the beginning of each school year, reviewed, and taken home by students to be shared with their parents.

**4. What educational gang awareness programs are your school system providing for students, staff, and volunteers?**

Baltimore County Public Schools provides training annually for staff and administrators in partnership with local agencies. School resource officers provide education to students at the secondary level as a part their teaching responsibilities. One school utilizes the GREAT program for its middle school students. Health education teachers provide gang related education at the secondary level. Community presentations are made through PTAs, advisory groups, and other community associations.

**5. In what ways do you feel your gang awareness programs were effective?**

BCPS uses a variety of strategies to provide gang prevention education and makes resources available on its Website along with the form for reporting concerns. The partnership between BCPS and the Baltimore County Police Department facilitates training and communication of concerns.

**6. How were/are administrators and teachers trained to implement your gang policy/regulations?**

Administrators receive training in the gang policy/rules through monthly principals' meetings. New administrators receive training in the use of the *Gang-Related Incident Reporting Form* as a part of their orientation to the policies, rules, and procedures of BCPS. Teachers are trained to implement the policy/rule through workshops. In addition, administrators attended a special presentation on the use of social media for gang

recruitment and communication also facilitated by the Baltimore County Police Department.

- 7. Is there a mechanism in place for community members to report gang activity involving school age youth to local schools? If so, please describe the procedure (data collection).**

Community members can access the *Gang-Related Incident Reporting Form* on the BCPS Website at *Gang-Related Incident Reporting Form*. The form is submitted to a school who enters the data and addresses the issue.

- 8. Do you feel that gang related issues and similar destructive or illegal behavior has increased, decreased, or remained the same as the previous school year?**

Incidents related to gangs and similar destructive behaviors have not changed over the past year.

The partnership with the Baltimore County Police Department has enhanced the district's awareness of gangs and gang activities as well as prevention and intervention strategies.

There have been only (1) gang related or destructive or illegal act occurred on school property since this procedure was enacted.

The gang policy and regulations are available on the school system website or through the Office of Pupil Services. They were sent to law enforcement agencies and the State's Attorney's Office.

- 4. What educational gang awareness programs are your school system providing for students, staff, and volunteers?**

Presentations through the U.S. Attorney's Office and the Maryland State Police Gang Task Force were provided to administrators in secondary schools (for students and staff) and for the community.

Caroline County Public Schools uses Safe Schools online training courses for all mandatory staff training. SafeSchools is a course training on gang prevention which has been made available to staff and volunteers.

- 5. In what ways do you feel your gang awareness programs were effective?**

There is constant communication with our local Caroline County Sheriff's Department and the local municipal police. We have not seen a great increase in gang related activity at this time.

- 6. How were/are administrators and teachers trained to implement your gang policy/regulations?**

Administrators were trained during several administrators and supervisors meetings. Principals then trained staff at the building level. New administrators are trained as necessary.

- 7. Is there a mechanism in place for community members to report gang activity involving school age youth to local schools? If so, please describe the procedure (data collection).**

The principal or school resource officer of each middle and high school conduct quarterly meetings to share general information with representatives of law enforcement, the State's Attorney, gang prevention and intervention programs, or any other appropriate individual about gang related activity that has been reported to the school. Schools are encouraged to collaborate with stakeholders to provide gang prevention and intervention services and programs based upon their available resources and those available in

Caroline County. Caroline County is small, and because the schools are such an integral part of the community, communication between community, schools and law enforcement agencies is strong.

8. **Do you feel that gang related issues and similar destructive or illegal behavior has increased, decreased, or remained the same as the previous school year?**  
Gang related issues and other destructive/illegal behavior has remained the same.

The training has made staff aware that gangs are not just found in large cities. It has also given staff gang indicators to look for at Carroll County Public Schools. As of this time, Carroll County Public Schools has not identified any gang type behaviors in schools. Carroll County Public Schools takes a proactive approach and because of our informational ongoing training, we try to be very alert for the potential of gangs forming at all times.
- 6. How were/are administrators and teachers trained to implement your gang policy/regulations?**  
Train the trainer model, Administrators were trained by Larry Faries (former CCPS Supervisor of Security) and/or Vince DeVivo.
- 7. Is there a mechanism in place for community members to report gang activity involving school age youth to local schools? If so, please describe the procedure (data collection).**  
We have a good partnership and communication with our local law enforcement agencies therefore, if any gang activity involving school age students occurs, they will alert Carroll County Public Schools. As of this time, any data collected would go through the normal referral process for school infractions.
- 8. Do you feel that gang related issues and similar destructive or illegal behavior has increased, decreased, or remained the same as the previous school year?**  
Gang related activity has remained the same as previous years.

- 4. What educational gang awareness programs are your school system providing for students, staff, and volunteers?**  
Throughout the year, opportunities are presented to the public to engage with law enforcement to address and inform the public about current trends in adolescent behavior and gang related activities. Opportunities are also presented throughout the year for students to learn about gang awareness through DARE classes. These classes are taught by local law enforcement agents and are presented to all middle and elementary age students. Also, during Local Management Board Meetings, information is shared by participating groups about gang activity and recruitment. These meetings occur monthly. At monthly School Resource Officers (SRO) meetings, all of the local law enforcement agencies gather to share pertinent information regarding criminal activities in CCPS. Standing agenda items includes a report on gang activity and recruitment. At the September meeting, law enforcement officials were all in agreement that gang activity is at a minimum and is having little to no impact on public schools. This was reinforced at the October meeting as well.
- 5. How were/are administrators and teachers trained to implement your gang?**  
Throughout the year, meetings occur with our Safe School Steering Committee. Various law enforcement agencies are present, along with representatives from the school system, community agencies, and the school resource officers assigned to each of our schools. At this meeting, current trends in student and adolescent behaviors are discussed, along with community trends. During these discussions, gang related activities are also discussed. School resource officers also have frequent communication with school level administration and teachers discussing adolescent behavior trends and gang related activity.

**6. In what ways do you feel your gang awareness programs were effective?**

The information shared with various stakeholders is critical to keeping knowledge about gangs and gang activity in the forefront of key individuals. While Cecil County has not seen growth in gang activity, keeping information flowing is critical to being proactive in limiting the spread of this activity.

**7. Is there a mechanism in place for community members to report gang activity involving school age youth to local schools? If so, please describe the procedure (data collection).**

Cecil County has a Gang Incident Reporting Form that is available online for any interested stakeholders to complete and return to the appropriate school. Cecil County has an open door policy for community members who should and would feel comfortable coming forward to report gang activity.

Related documents include MCPS Policy JFA: Student Rights and Responsibilities (revised in June 2014) and the 2015–2016 Code of Conduct in Montgomery County Public Schools which are revised and published annually.

**3. Where are your gang policy/regulations located/electronically communicated?**

It is communicated annually to all school staff members through a memorandum from the Department of Student Services, Office of Special Education and Student Services. The memorandum is addressed to all school principals and directs them to:

- Implement school wide gang-related behavior prevention and intervention strategies, including school climate surveys, to teach and reinforce responsible pro-social behaviors.
- Conduct annual professional development activities that focus on the prevalence, causes, indicators, and consequences of gang-related behaviors and include strategies to prevent instances of gang-related behaviors. Ensure that all staff members have the opportunity to participate in the professional development activity and that staff members hired later in the school year receive this professional development.
- Collaborate with families and community stakeholder groups on the prevalence, causes, indicators, and consequences of gang-related behaviors.
- Provide information, including a list of community resources, to staff members, students, and families on social services, health, and behavioral health resources for those students exhibiting and victims and bystanders of gang-related behaviors.
- Inform staff members, students, and parents/guardians about suspected gang activity reporting procedures at the beginning of the school year and periodically through the school year using newsletters, the school website, Parent Teacher Association meetings, and the school handbook.

- Encourage the completion of MCPS Form 230-37: *Gang-Related Incident Reporting Form* whenever a verbal report of suspected gang-related behavior is made to school staff members.
- Ensure that all incidents of gang-related behavior are reported and investigated within 24 hours.

The memorandum includes two PowerPoint presentations (one for elementary and one for secondary schools) and a list of community resources.

**4. What educational gang awareness programs are your school system providing for students, staff, and volunteers?**

The Comprehensive Health Education Unit in the Office of Curriculum and Instructional Programs is in the process of developing a specific objective for the high school Health Education course that will address the issue of gangs.

MCPS collaborates with the Montgomery County Department of Health and Human Services (DHHS) and Identity, Inc. to provide gang awareness programs and interventions to students, staff members, and volunteers. An extremely valuable resource and intervention specialist is Luis Cardona, Administrator, Positive Youth Development Initiative, DHHS. He serves as the coordinator of the Street Outreach Network whose mission is to “prevent, neutralize, and control hostile behavior in high risk youth and youth gangs through the development of positive relationships between youth [and] community stakeholders and outreach workers. The outreach worker utilize[s] positive youth development programs and leisure time activities as the intervening vehicle for redirecting antisocial and aggressive behaviors”

([admin.infomontgomery.org/query/programs.aspx?PrgID=771](http://admin.infomontgomery.org/query/programs.aspx?PrgID=771)).

MCPS also collaborates closely with the Montgomery County Police Department (MCPD) on monitoring trends in gang activity in the community.

**5. In what ways do you feel your gang awareness programs were effective?**

MCPS has maintained a proactive approach towards training of staff members to recognize, document, and report any suspected gang-related signs or activities. As a result, gang activity in schools is limited and when it does occur, staff members respond immediately to mitigate the negative impact it could have on a positive and safe learning environment.

Identifying possible gang involvement among students results in the formulation of mentoring opportunities for school-based staff members. These mentoring opportunities often lead to alternative options for supporting at-risk students and their families.

**6. How were/are administrators and teachers trained to implement your gang policy/regulations?**

As reported above, all MCPS principals are provided with information and a standardized PowerPoint presentation (customized for either elementary or secondary schools) to facilitate training on how to implement the MCPS gang regulation. This is an annual training that usually is conducted during preservice week. Principals also are advised to

provide new hires who join their schools after the initial training with the information contained in the PowerPoint.

- 7. Is there a mechanism in place for community members to report gang activity involving school age youth to local schools? If so, please describe the procedure (data collection).**

Community members are informed of MCPS policy and regulations and are advised to contact school staff members and complete Form 230-37: *Gang-Related Incident Reporting Form* whenever they learn of suspected gang-related behavior.

- 8. Do you feel that gang related issues and similar destructive or illegal behavior has increased, decreased, or remained the same as the previous school year?**

MCPS Department of Student Services (DSS) recently was notified of suspected increase in gang recruitment behavior affecting, in particular, students who are English language learners. DHHS, MCPD, and the MCPS Department of School Safety and Security are working closely with DSS to discuss this apparent rise in gang-related behavior and to develop appropriate interventions to support MCPS students. This is one example of how MCPS collaborates effectively with its county partner agencies to maintain the safety of our students.

There have been no updates to the regulation or the administrative procedure.

**3. Where are your gang policy/regulations located/electronically communicated?**

The Prince George's County Public School system posts all policies and administrative procedures on a web site that is accessible to all employees and the public-at-large. In addition, both Spanish and English informational brochure on gangs have been published and distributed to schools. The revised version of the Student Rights and Responsibilities Handbook, 2015-2016, was distributed to every student and parent. This handbook addresses consequences for gang involvement, gang activity, and similar destructive or illegal behavior. This document is published in both English and Spanish.

Prince George's County Public Schools also maintains a Gang Google site, which has resources for schools to use.

**4. What educational gang awareness programs are your school system providing for students, staff, and volunteers?**

The Student Rights and Responsibility Handbook is reviewed with all students by Pupil Personnel Workers. Students are required to sign a Code of Conduct Memorandum of Understanding indicating that they understand these policies and regulations. For the 2015-2016 school year, a video was produced to accompany the handbook. The video highlighted the changes that were made in the handbook from the prior school year. Staffs receive awareness training annually at the beginning of the school year. Principals have had police officers and staff from student services conduct parent informational sessions on gangs and how to be vigilant for signs that gangs may be recruiting children. The system-wide student dress code also prohibits the wearing of gang colors and/or gang paraphernalia.

**5. In what ways do you feel your gang awareness programs were effective?**

The programs were effective in helping both staff and parents understand what signs to look for in children of gang related activities. These programs have increased gang awareness for adults.

**6. How were/are administrators and teachers trained to implement your gang policy/regulations?**

All school administrators have received training on the implementation of the policy and receive a copy of the PowerPoint and other informational tools. All security staffs have received training through local police entities and from the Department of Student Engagement and School Support. Administrators and designated staff conduct trainings annually at each school to ensure that teachers understand the administrative procedures and reporting processes. New principals receive an overview of the policies and procedures. An internal Google site is available for administrators with information about gangs.

**7. Is there a mechanism in place for community members to report gang activity involving school age youth to local schools? If so, please describe the procedure (data collection).**

The Gang home page, found on the school system's website, has a link by which any person can access the Gang Related Incident Reporting Form. The form is used to report any gang related activity or similar destructive behavior. Schools conduct an investigation for each incident that is reported. In every case, schools used the student information system to record their gang information. Both Student Services and Security work collaboratively to record data. Each year, data is reviewed to determine trends and action steps that are needed to reduce incidents.

Additionally, the school system has partnered with Crime Solvers in a program called "See Something Say Something". Community members are able to report incidents via a toll free number.

The number of gang-related incidents in St. Mary's County remains low. Student feedback indicates the safety festivals are well received and thus, the school system continues to offer the programs each year.

Administrators and teachers are trained annually as part of the required online trainings through Safe Schools. Staff members are required to complete the training by mid-October of each school year.

There are three options available for community members to report gang-related activity. First the school system has a confidential hotline to report information. Information regarding the hotline is posted on the school system website. Second, the gang-related incident reporting form is available on the school system website.   - School Counselors in middle and high schools reviewed this guide with their students and a copy was sent home to parents (annual requirement)
  - Core Essentials (Character Education) lessons and announcements are shared with teachers at all schools on a monthly basis to be incorporated in the classrooms (i.e. respect)
  - Positive Behavioral Intervention and Supports (PBIS) initiatives at all eligible school includes specific strategies that address a safe and healthy school climate
  - Elementary students (5<sup>th</sup> grade) receive DARE instruction
  - Parent Orientations were held for all schools and a review of procedures and expectations were shared for academics, attendance and behavior
  - Annual review with school Administrators and school staff

  - Improved school climate

All administrators and staff have been trained by Vince DeVivo, School Outreach Coordinator, and US Attorney's Office. Each year, Mr. DeVivo provides training to all newly hired teachers. Gang awareness is presented to Elementary students through Drug Abuse Resistance Education (DARE) classes that are taught by an officer from the Talbot County Sheriff's Department. Middle and High School students review gang awareness through the Health Curriculum. Annually, administrators, counselors, local police representatives, State's Attorney and Public Defenders meet yearly to discuss trends in local gang activity. Information from these meetings is shared with other administrators and staff.

Our efforts have been effective in making administration, staff, students, and the community aware of the identification and reporting of gang related activities.

All administrators and staff have been trained by Vince DeVivo, School Outreach Coordinator, and US Attorney's Office. Each year, Mr. DeVivo provides training to all newly hired teachers.

  - Entered into a memo of understanding with the State Attorney's Office to foster coordination of current, and future gang prevention, intervention, and suppression efforts.
  - Anyone having knowledge of alleged gangs, gang activity, similar destructive behavior, or illegal group behavior shall report it immediately to the principal/designee.

- A report of alleged gang-related activity, similar destructive, or illegal behavior is required using the Worcester County Public Schools Gang-related Incident Reporting Form.
- Initial reports may be given verbally or in writing. If a verbal report is given, a written report shall be requested and submitted using the WCPS Gang-related Incident Reporting Form.
- If a student, parent, or guardian, or other person informs a school employee of any alleged gang-related activity, similar destructive or illegal group behaviors, the school employee shall report that information to the principal/designee.
- Reporting forms can be obtained from the principal/designee. The principal/designee shall maintain original alleged gang reports and related information in a secure file and shall not be part of student's educational record.
- Retaliation against a student for making a report in good faith is prohibited. Individuals knowingly making a false report will be subject to the range of consequences under the WCPS Code of Conduct.
