Implementation of State and Local School System Policies and Regulations to Address Gangs, Gang Activity, and Similar Destructive or Illegal Group Behavior

Introduction

The Safe Schools Act of 2010 (2010 Maryland Laws, Chapter 188) required the Maryland State Department of Education (MSDE) to submit a report on or before January 1, 2011, and each year thereafter, to the Maryland General Assembly regarding the implementation of State and local school system policies and regulations to address gangs, gang activity, and similar destructive or illegal group behavior. This report provides the requested information for Maryland's 24 local school systems for 2018-2019.

The Act also required the Maryland State Board of Education, in consultation and collaboration with the Department of Juvenile Services, the Department of State Police, the Department of Human Resources, and local school systems to develop a *Model Policy to Address Gangs, Gang Activities, and Similar Destructive or Illegal Group Behavior* (Model Policy) no later than March 31, 2011. Local school systems were also required to develop local policies/regulations to address gangs, gang activity, and similar destructive or illegal group behavior, which included all components of the State Board's Model Policy, and to submit these policies/regulations to the State Superintendent of Schools no later than September 1, 2011.

Each local school system was required by law to: 1) publicize its policies/regulations in student handbooks, on school system websites, and at any other location or venue local school systems determined was necessary or appropriate; and 2) develop educational programs to address gangs, and gang-like activity in schools. Educational programs must include an educational gang awareness program for students, staff, volunteers, and parents and a teacher and administrator development program that trains teachers and administrators to implement the policy.

This report to the Maryland General Assembly addresses the requirements outlined in the Safe Schools Act of 2010 and is designed around three core areas: 1) where local school system gang policies and regulations are publicized; 2) what educational gang awareness program(s) are being provided for students, staff, volunteers, and parents; and 3) how administrators and teachers are trained to implement the gang policy/regulations. In addition to these core areas, the MSDE has enhanced the questionnaire for the purpose of identifying other areas that need to be addressed and to optimize technical support.

Per the attached surveys, local school systems have updated their policies and have posted them to their local websites. All systems provide gang awareness training such as training from local law enforcement agencies, the Gang Resistance Education And Training (G.R.E.A.T.) program in elementary and middle schools, information from the U.S. Attorney's Office, and the Drug Abuse Resistance Education (D.A.R.E.) program. All local school systems have a mechanism where the community can report alleged gang activity and how investigation procedures will be conducted by appropriate staff members. The MSDE and the Maryland Center for School Safety meet regularly with Directors of Student Services and School Safety Supervisors to provide technical assistance on gang policies, awareness, and prevention.

2. Have your gang policies/regulations been updated? If so, please provide date and brief summary of changes.

Gang-related activity is currently a violation of the Anne Arundel County Public Schools (AACPS) Code of Student Conduct. The research based and collaborative approach to handling gang related concerns currently starts at levels 3-5 consequences and may carry a major incident referral for a request of a 45-day extended suspension by the principal pending outcomes of the level 5 investigation. Our gang related policy/regulations prevents student participation in gang and/or gang-like activity, irrespective of whether schools are in session, within Board of Education owned or leased property, including school buildings or on school grounds; on school buses or other school vehicles; or during any school, school-related, or school sponsored activity, whether held on school property or at locations off school property. This includes, but is not limited to: wearing, possessing, using, distributing, displaying, or selling any clothing, jewelry, emblem, badge, symbol, sign, or other items which evidences or reflects membership in or affiliation with any gang, commission of any act which furthers the interests of any gang, gang-like activity, or act of violence, including but not limited to: solicitation for membership in a gang, requesting any person to pay for protection or otherwise intimidating or threatening any person, committing or inciting criminal acts or violation of AACPS policies. It also includes soliciting other students to engage in physical violence against any other person, engaging in any act, either verbal or nonverbal, including gestures, handshakes, slogans, drawings, etc. showing membership or affiliation with any gang, challenging or provoking fights, stare-downs, mad-dogging (threatening glance; to stare fixedly at someone in a hostile manner), flashing colors, verbal remarks, etc., marking or defacing school property with messages, symbols, or slogans that may signify gang affiliation, displaying gang apparel, signs, symbols, or slogans on personal property, engaging in physical confrontations where one or more persons confront another individual or group, and using electronic devices such as pagers, cell phones, or computers to communicate gang activities while on school property.

4. What educational gang awareness programs does your school system provide to students, staff, and volunteers?

Gang-related lessons for students are implemented during advisory period in each school. Professional Development for faculty, staff and volunteers is conducted at the beginning of each school year.

5. In what ways do you feel your gang awareness programs were effective?

The most effective approach is one that involves communication between representatives of the groups involved. Students have been encouraged to seek assistance with staff members or programs, which may be available at schools' conflict resolution/peer mediation, mentors, school nurses, teachers, school counselors, principals, school psychologists, pupil personnel workers, school resource officers, school social workers, and school administrators.

6. How were/are administrators and teachers trained to implement your gang policy/regulations?

The Office of School Security provides the schools with the gang awareness packets. Professional Development for faculty and staff is conducted at the beginning of each school year. Gang related lessons for students are implemented during advisory period in each school. An administrative review of gang related activity, identification of pattern of criminal gang activity, underlying crime, anti-social behavior, gang-like activities, and signs of gang membership is conducted.

7. Is there a mechanism in place for community members to report gang activity involving school age youth to local schools? If so, please describe the procedure (data collection).

A synopsis of the policy and rule is published in the *Student Handbook* and titled Gangs, Gang Activity and Similar Destructive or Illegal Group Behavior. This handbook is distributed to all students at the beginning of each school year, reviewed, and taken home by students to be shared with their parents.

4. What educational gang awareness programs does your school system provide to students, staff, and volunteers?

Baltimore County Public Schools provide training annually for staff and administrators in partnership with local agencies. School resource officers provide education to students at the secondary level as a part of their teaching responsibilities. Several schools utilize the G.R.E.A.T program for middle school students. Health education teachers provide gang related education at the secondary level. Community presentations are made available through PTAs, advisory groups, and other community associations.

5. In what ways do you feel your gang awareness programs were effective?

The BCPS uses a variety of strategies to provide gang prevention education and makes resources available on its Web site along with the form for reporting concerns. The partnership between BCPS and the Baltimore County Police Department (BCoPD) facilitates training and communication of concerns. When an issue arose involving English for Speakers of Other Languages (ESOL) students, the BCoPD sent Spanish speaking officers to the school to develop a rapport with students and hired a Spanish speaking officer as a permanent member of its SRO team.

6. How were/are administrators and teachers trained to implement your gang policy/regulations?

Administrators received training in the gang policy/rules through the annual Safe Schools Conference and during professional learning opportunities offered after school hours. Teachers were trained to implement the policy/rule through workshops. In addition,

administrators attended a special presentation on the activity of gangs facilitated by the BCoPD.

- 7. Is there a mechanism in place for community members to report gang activity involving school age youth to local schools? If so, please describe the procedure (data collection).**

Community members can access the *Gang-Related Incident Reporting Form* on the BCPS Web site at *Gang-Related Incident Reporting Form*. The form is submitted to a school who enters the data and addresses the issue.

- 8. Do you feel that gang related issues and similar destructive or illegal behavior have increased, decreased, or remained the same as the previous school year?**

Anecdotal reports show that there might be a slight increase in gang activity in some areas of the County.

The partnership with the BCoPD has enhanced the district's awareness of gangs and gang activities as well as prevention and intervention strategies. The BCoPD has recently added a Spanish speaking SRO to the team of SROs at one of our schools to increase communication with students in the regional ESOL program.

Collective involvement between the school system, local and state law enforcement, and State's Attorney Office have joined together to share any reported gang-like activities on school property. Information is also shared regarding student involved gang-like activities occurring in the community.

Administrators and Supervisors were informed during (A&S) meetings. Administrators then were to convey this information to their staff. All staff have access to an on-line "SafeSchool" course as a resource to identify gang-like activities.

The Gang Related issues and similar Destructive or Illegal Behavior Report is inserted in the Students' Rights and Responsibilities Booklet that all students in the district receive. The data is collected on file in the Department of Student Services.

There have been only (2) gang related or destructive or illegal acts occurred on school property since this procedure was enacted.

Our school resource officers who are deputies from the county Sheriff’s office are instrumental in keeping the school informed. According to policy, these people meet monthly with the appropriate school staff to share information about gang related activity in general and discuss the educational plan for and progress of each student who has been arrested or adjudicated delinquent for gang-related activity...”

Our local police were helpful in addition to training on the “Gang Related Incident Investigation Reporting Form.”

Reports can be made on the Bullying Harassment and Intimidation Reporting Form of any gang related activity.

4. What educational gang awareness programs does your school system provide to students, staff, and volunteers?

Health curriculum, counselor lessons, presentations by Vince DeVivo – School Outreach Coordinator, U.S. Attorney’s Office. Carroll County State’s Attorney’s Office provided staff training in August 2018.

5. In what ways do you feel your gang awareness programs were effective?

The training has made staff aware that gangs are not just found in large cities. It has also provided staff with gang indicators and current trends to look for in Carroll County Public Schools. Carroll County Public Schools takes a proactive approach and because of our informational ongoing training, we try to be very alert for the potential of gangs forming at all times.

6. How were/are administrators and teachers trained to implement your gang policy/regulations?

Utilizing the train-the-trainer model, administrators were trained by Larry Faries (former CCPS Supervisor of Security) and/or Vince DeVivo. Additional professional development was provided in August 2018.

7. Is there a mechanism in place for community members to report gang activity involving school age youth to local schools? If so, please describe the procedure (data collection).

We have a good partnership and communication with our local law enforcement agencies therefore, if any gang activity involving school age students occurs, they will alert Carroll County Public Schools. Information collected typically goes through the normal referral process for school infractions; however, the new Safe Schools Maryland anonymous tip line can also be used to report gang activity.

8. Do you feel that gang related issues and similar destructive or illegal behavior have increased, decreased, or remained the same as the previous school year?

Gang related activity has remained the same as previous years.

Cecil County Public Schools

1. When (date) was your gang policy/regulations approved by your board of education?
Gang Policy approved July 11, 2011. Regulations were updated in September 2012.

2. Have your gang policies/regulations been updated? If so, please provide date and brief summary of changes.

The Cecil County gang policy was reviewed on April 1, 2016. No changes were made to the existing policy.

3. Where are your gang policy/regulations located/electronically communicated?

The Gang Policy and Regulations are publicized on the Cecil County Public Schools' (CCPS) website, along with being published in the Student Rights and Responsibilities Handbook. This handbook contains the Code of Conduct. The handbook is distributed to each student in Cecil County Public Schools during the first week of classes.

4. What educational gang awareness programs does your school system provide to students, staff, and volunteers?

Throughout the year, opportunities are presented to the public to engage with law enforcement to address and inform the public about current trends in adolescent behavior and gang related activities. Opportunities are also presented throughout the year for students to learn about gang awareness through DARE classes. These classes are taught by local law enforcement agents and are presented to all middle and elementary age students. Also, during Local Management Board Meetings, information is shared by participating groups about gang activity and recruitment. These meetings occur monthly. At monthly School Resource Officers (SRO) meetings, all of the local law enforcement agencies gather to share pertinent information regarding criminal activities in CCPS. Standing agenda items include a report on gang activity and recruitment. At the September meeting, law enforcement officials were all in agreement that gang activity is at a minimum but one particular community was beginning to see issues with a small group within the community. The principals of schools within this community have been notified of the activities and reminded of our Gang Policy. This was reinforced at the October meeting as well.

5. In what ways do you feel your gang awareness programs were effective?

The information shared with various stakeholders is critical to keeping knowledge about gangs and gang activity in the forefront of key individuals. While Cecil County has not seen growth in gang activity, keeping information flowing is critical to being proactive in limiting the spread of this activity.

6. How were/are administrators and teachers trained to implement your gang policy/regulations?

Throughout the year, meetings occur with our Safe School Steering Committee. Various law enforcement agencies are present, along with representatives from the school system, community agencies, and the school resource officers assigned to each of our schools. At this meeting, current trends in student and adolescent behaviors are discussed, along with community trends. During these discussions, gang related activities are also discussed.

School resource officers also have frequent communication with school level administration and teachers discussing adolescent behavior trends and gang related activity.

The SROs provide gang awareness in selected elementary and middle schools through the Gang Resistance Education and Training (G.R.E.A.T.) program. This is a school-based gang and violence prevention program with three primary goals: 1) teach youth to avoid gang membership; 2) prevent violence and criminal activity; and 3) assist youth in developing positive relationships with law enforcement.

In middle and high schools, the SROs communicate frequently with administrators to identify known gang members in their schools.
- 5. In what ways do you feel your gang awareness programs were effective?**
Principals now collaborate with the School Police Team/SROs on identifying emerging gang activities within schools. Students who are involved with gangs generally keep their gang-related activities and affiliation out of school, based on principal reports. We distribute gang awareness brochures to counseling offices and they are in the waiting room at the Superintendent’s suspension hearing office.
- 6. How were/are administrators and teachers trained to implement your gang policy/regulations?**
Originally, the Harford County Sheriff’s Office provided a presentation to school administrators. That information is available on the Sheriff’s office website link. SROs now keep administrators informed of emerging gang activities and incidents that occur in the community that may impact their school. All staff are able to access the policy on the school system’s website.

Yes, it is usually reported using the online bullying report.

Criminal charges have increased because of the inclusion of 2nd degree assault as a reportable offense for incidents outside of school and for fights within school. Fights and attacks have increased, likely a function of the aggravating nature of social media. The increase in reportable offenses have been associated with increased awareness and the incorporation of including a check off block on incident reports identify gang involvement.

MCPS Regulation JHG-RA, Gangs, Gang Activity, or Other Similar Destructive or Illegal Group Behavior Prevention, was developed initially in August 2011, revised in September 2012, and revisions were made July 24, 2017, to address where copies of the gang reporting form are distributed to facilitate better reporting and monitoring and to reflect the appropriate MSDE contact name and contact information.

2. Have your gang policies/regulations been updated? If so, please provide date and brief summary of changes.

MCPS Regulation JHG-RA, Gangs, Gang Activity, or Other Similar Destructive or Illegal Group Behavior Prevention, was revised in September 2012 to incorporate information received from the Maryland State Department of Education. The major change by the state was that upon receipt of a Gang-Related Incident Reporting Form, the principal or designee, assistant principal, and the school security officer would initiate an investigation within 24 hours. Revisions were made again in July, 2017 to establish reporting requirements that allow MCPS to track and monitor the number of incidents, types of behaviors, and findings from school investigations.

Related documents include Montgomery County Board of Education Policy JFA, Student Rights and Responsibilities (amended in June 2014), and MCPS Regulation JFA-RA, Student Rights and Responsibilities (revised July 2017). Related publications include the 2017-2018 Student's Guide to Rights and Responsibilities in MCPS, and the 2017-2018 Student Code of Conduct in MCPS, and the Office of Student and Family Support and Engagement Resource Guide, which are revised and published annually.

3. Where are your gang policy/regulations located/electronically communicated?

The MCPS gang regulation is located on the MCPS website at: www.montgomeryschoolsmd.org/departments/policy/pdf/jhgra.pdf. It is also referenced in the Annual Mandatory Compliance Training for staff (see #6 below). The regulation is available in multiple languages to ensure broad access to our school community.

4. What educational gang awareness programs does your school system provide to students, staff, and volunteers?

The curriculum for the high school Health Education course includes specific objectives that address the issue of gang awareness. MCPS collaborates with the Montgomery County Department of Health and Human Services (DHHS) and Identity, Inc. to provide gang awareness programs and interventions to students, staff members, and volunteers. An extremely valuable resource and intervention specialist is Luis Cardona, administrator, Positive Youth Development Initiative, DHHS. He serves as the coordinator of the Street Outreach Network whose mission is to “prevent, neutralize, and control hostile behavior in high risk youth and youth gangs through the development of positive relationships between youth [and] community stakeholders and outreach workers. The outreach worker utilizes positive youth development programs and leisure time activities as the intervening vehicle for redirecting

antisocial and aggressive behaviors.”

MCPS also collaborates with the Montgomery County Police Department (MCPD) and the Montgomery County State’s Attorney’s Office (SAO) on gang awareness programs. For example, in addition to the training and other activities discussed further in response to question six and below, the SAO has conducted a number of school-based assemblies, as well as community meetings on gang and other inappropriate behaviors. As discussed further below, the MCPD and the SAO also have pledged to coordinate services with MCPS and other agencies to promote prevention and mitigation efforts of gang and gang-related activities.

5. In what ways do you feel your gang awareness programs were effective?

MCPS has maintained a proactive approach towards training of staff members to recognize, document, and report any suspected gang-related signs or activities. As a result, gang activity in schools is limited, and when it does occur, staff members respond immediately to mitigate the negative impact it could have on a positive and safe learning environment.

6. How were/are administrators and teachers trained to implement your gang policy/regulations?

In 2017, MCPS renewed and updated its Memorandum of Understanding with law enforcement agencies in Montgomery County, including the MCPD and the SAO, to add a section specifically focused on gang awareness and prevention. The revised MOU was executed on October 17, 2017 and is available at the link below:

In addition to the gang awareness activities specified elsewhere in the MOU, the parties expressly agreed “to develop and implement gang awareness, prevention, and intervention programs for MCPS students and their families with a focus on outreach to at-risk MCPS students.” In addition, the SAO and law enforcement agencies agreed to “assist MCPS in developing ongoing training on gang awareness for MCPS staff”; “to meet regularly to address current trends in gang activity; and to “convene regular school security meetings for the middle schools and high schools to ensure the coordination of gang prevention, intervention, and suppression efforts.” To implement the MOU, meetings have been held throughout the school year with secondary principals and their security staff, as well as the MCPS Office of School Safety and Security, the SAO, the MCPD, and DHHS (School Year 2017-2018 - October, December, February, and April).

The MCPS Department of School Safety and Security collaborates with the Maryland School Safety Center to share information and learn how other counties throughout the State of Maryland have or are developing strategies to reduce gangs or gang-like activities.

The MCPD also presented gang awareness training to all MCPS security staff, which included an overview of gang activity in the region, what administrators and security staff should watch for, and how to report suspected gang activity (August 2017).

Beginning in the 2017-2018 school year, MCPS incorporated training on gang awareness into the [online compliance training](#) that is mandatory for all employees. The training, which was revised to be more interactive and engaging, includes guidance regarding:

- Definitions of criminal gang and patterns of criminal gang activity, as well as warning signs (behavioral, social, and physical);
- Requirements that schools must have prevention and intervention strategies;
- Requirement that all school employees must report any incident of suspected gang behavior using MCPS Form 230-37, as well as the investigation process and timeline;
- Prevention and intervention strategies such as making changes to the physical building and creating a school climate that is conducive to a safe environment;
- Information as to why students join gangs, and factors that may increase the risk of participation in gang activity; and
- Links to in-school resources, community resources, internet sites, and hotlines

7. Is there a mechanism in place for community members to report gang activity involving school age youth to local schools? If so, please describe the procedure (data collection).

Community members are advised to contact school staff members and complete [MCPS Form 230-37, *Gang-Related Incident Reporting Form*](#), whenever they learn of suspected gang-related behavior, or [MCPS Form 230-35, *Bullying, Harassment, or Intimidation Reporting Form*](#), which includes “gang related” and “gang recruitment” as categories of bullying, harassment, or intimidation.

8. Do you feel that gang related issues and similar destructive or illegal behavior have increased, decreased, or remained the same as the previous school year?

There has been a perceived change in gang activity in Montgomery County, MD. The MCPD and the SAO received supplemental funding from the Montgomery County Council to increase their prevention, mitigation, and suppression efforts of gang activities within the county. Both agencies have acknowledged that there is minimal gang activity within MCPS schools but the areas around some schools are impacted. DHHS, MCPD, and the MCPS Office of Student and Family Support and Engagement (OSFSE) and the MCPS Department of School Safety and Security work closely to monitor gang activity in the community-at-large and develop appropriate interventions to support MCPS students and maintain the safety of our students.

9. Optional: Please share any other thoughts, questions, or comments regarding gang activity, regulation, policies, or awareness programs in your local school system.

In the spring 2017, the Superintendent of Schools commissioned a thorough review of the security procedures and practices within MCPS. The Department of School Safety and Security conducted the review with input from two nationally recognized experts in the field of school security.

From the review came several recommendations that MCPS is planning to implement, including a number that touched upon gang awareness, including:

- Develop a School Climate dashboard of incidents and behaviors including gangs and gang-like activities.
- Establish a basic training program for all new security staff that includes gang awareness and prevention.
- Establish a working group of stakeholders to share information on gang activities and gang prevention efforts.

The Gang Policy 5157 was approved on June 20, 2011, by the Prince George's County Board of Education. On August 1, 2011, the Superintendent and Executive Cabinet approved the administrative procedure (AP 5142), which explains the process by which the policy is implemented.

2. Have your gang policies/regulations been updated? If so, please provide date and brief summary of changes.

There have been no updates to the regulation or the Administrative Procedure; however, a multi-disciplinary taskforce is currently in the process of updating the procedure, which will be finished by the end of the school year.

3. Where are your gang policy/regulations located/electronically communicated?

The Prince George's County Public School system posts all policies and Administrative Procedures on a web site that is accessible to all employees and the public-at-large. In addition, available in both Spanish and English, an informational brochure on gangs has been published and distributed to schools. *The Student Rights and Responsibilities Handbook* has information about gangs. An electronic version of the handbook is available to students and parents each year. This handbook addresses consequences for gang involvement, gang activity, and similar destructive or illegal behavior. Prince George's County Public Schools also maintains a Gang Google site, which has resources for schools to use.

4. What educational gang awareness programs does your school system provide to students, staff, and volunteers?

Pupil Personnel Workers (PPWs) review *The Student Rights and Responsibility Handbook* with all students annually. Students are required to sign a Code of Conduct Memorandum of Understanding indicating that they understand the policies and regulations outlined in *The Student Rights and Responsibility Handbook*. The system-wide student dress code also prohibits the wearing of gang colors and/or gang paraphernalia.

Staff members receive awareness training annually at the beginning of the school year. PPWs receive an annual refresh on gang involvement and the implications for student truancy. Principals have had the School Resource Officers and staff members from the Department of Student Services conduct parent informational sessions on gang and how to look vigilantly for signs that gangs may be recruiting their children. Schools also develop school-based interventions and programs that are germane to the needs of their buildings.

Additionally, this year, Prince George's County Public Schools (PGCPS) has reached out to parents to provide awareness on gangs through the Department of Family and School Partnerships (DFSP). DFSP provided a session on "Warning Signs: Gangs/Drugs and At-

Risk Behaviors developed to illuminate adolescent behaviors indicative of gang involvement.

5. In what ways do you feel your gang awareness programs were effective?

The programs were effective in helping both staff and parents understand what signs to look for in children of gang related activities. These programs have increased gang awareness for adults.

6. How were/are administrators and teachers trained to implement your gang policy/regulations?

Over the years, school administrators received training on the implementation of the Administrative Procedure related to gangs and gang prevention. All security staff members have received training through local police entities and from the DFSP. An internal Google site maintained by the Department of Security is a place where administrators can go for information. We are currently exploring the use of Safe-Schools modules to train all schools on gang related activity.

7. Is there a mechanism in place for community members to report gang activity involving school age youth to local schools? If so, please describe the procedure (data collection).

PGCPS' Anti-Bullying website has a link which may be accessed to complete the Bullying, Harassment or Intimidation Form. This form also provides an opportunity to report gang-related or gang recruitment activity.

Schools are required to conduct an investigation for each reported incident. In every case, schools use the student information system to record gang information. The Department of Student Services and the Department of Security Services work collaboratively to record and review data to determine trends and action steps to reduce gang related incidents.

To make anonymous reporting easier for students, parents and community onlookers, PGCPS has developed a new Bullying, Harassment or Intimidation (BHI) app that will be released in November 2018. This platform can be used to report Gang-related activity. Videos for staff members to provide training on how to use the app as well as a BHI Parent Tutorial have been developed to provide guidance on how to use this new tool. We recognize this avenue provides all stakeholders with the power to report incidents without trepidation.

Additionally, PGCPS has collaborated with Crime Solvers in a program called "See Something Say Something". Community members are able to report incidents via a toll free number.

8. Do you feel that gang related issues and similar destructive or illegal behavior have increased, decreased, or remained the same as the previous school year?

Gang related activity has remained flat from the prior year.

PGCPS realizes gang activity, involvement, and recruitment are not just community issues but involve those who enter our school doors. We have sought ways to address at-risk behaviors that students exhibit that are “warning signs” for gang involvement.

We have partnered with a number of community agencies that provide after school activities and family partnerships to include Latin American Youth Center, CASA Multicultural Center, Youth Services Bureau and Community Conferencing to name a few. We have now hired a Restorative Practices Coordinator to usher in restorative circles aimed at connecting students and teachers that would facilitate an environment that is nurturing, positive, and fosters a sense of belonging for all of our students. When we build in opportunities for greater student engagement through academics, career academies, mentoring, and community services, we are hoping to build mechanisms for better student-school connectivity and self-fulfillment.

Lastly, through trauma informed approaches, we will be able to build bridges with students whose life changing traumatic experiences are often fertile ground for gang involvement or other at-risk behaviors.

Gang awareness information is provided in several ways. Gang awareness information is included in the student handbook. Student handbook presentations are provided at each school. Safety festivals are held for students at each high school. Information is also provided through the Superintendent's Safety and Security meetings held quarterly. All staff receive training through the required online program.
- 5. In what ways do you feel your gang awareness programs were effective?**
SMCPS has been transparent about emerging student involvement in reported gang related activities and the increasingly destructive and disruptive actions taken by individuals identifying themselves as members of local community gangs. On February 15, 2018, SMCPS held an information meeting focusing on increasing community awareness about gangs. The meeting included information and discussion pertaining to researched-based best practices on intervention and prevention education. The meeting was well attended and additional follow-up meetings were convened focusing on school safety during the remainder of the school year. We have actively partnered with the Sheriff's office and held meetings with community groups such as the NAACP to coordinate messaging, information, and appropriate response. The Memorandum of Understanding between schools, the State's Attorney's Office and law enforcement (required under Maryland Education Article 7-424.2) was reviewed and revised on August 15, 2017 for a term of three (3) years.
- 6. How were/are administrators and teachers trained to implement your gang policy/regulations?**
Administrators and teachers are trained annually as part of the required online trainings through Safe Schools. Staff members are required to complete the training by mid-October of each school year.

There are three options available for community members to report gang-related activity. First, the school system has a confidential hotline to report information. Information regarding the hotline is posted on the school system website. Second, the gang-related incident reporting form is available on the school system website. Third, the gang-related incident reporting form is also available in the student handbook.

- 8. Do you feel that gang related issues and similar destructive or illegal behavior have increased, decreased, or remained the same as the previous school year?**

The number of gang-related incidents in St. Mary's County is increasing and this is having a residual impact on the school environment. We continue to work with local and state law enforcement agencies to investigate reported gang activity. We are currently working with the Southern Maryland Information Center (SMIC) to validate potential gangs impacting our school communities. The number of students involved is isolated to a very small percentage of the total number of students. Disruptions in the school environment have occurred ranging from physical attack on students and staff as well as other illegal activity to include vandalism, drug possession, and weapons on campus. This has resulted in outreach to law enforcement partners to investigate and potentially validate suspected gang activity. Meetings are held on a weekly basis with law enforcement and school administrators to address any gang related concerns. The Department of Student Services is proactively engaged in intervention strategies and to assist students who have been determined to be a significant risk to the school environment due to their declared gang affiliation and participation in crimes both on and off the school campus.

St. Mary's County Public Schools and law enforcement have a collaborative working relationship that is beneficial to the ongoing work in both the schools and community.

In addition, the Gang Reporting Form is posted on the Talbot County Public Schools website under the Student Services Department.

All TCPS staff complete a 30 minute online Safe Schools' Gang Awareness course prior to the start of each school year. Gang awareness is presented to the elementary students through Drug Abuse Resistance Education (DARE) classes and is taught by an officer from the Talbot County Sheriff's Department. Middle and high school students review gang awareness through the health curriculum. Annually, administrators, counselors, local police representatives, State's Attorney and Public Defenders meet yearly to discuss trends in local gang activity. Information from these meetings is shared with other administrators and staff.
- 5. In what ways do you feel your gang awareness programs were effective?**
Our efforts have been effective in making administration, staff, students, and the community aware of the identification and reporting of gang related activities.
- 6. How were/are administrators and teachers trained to implement your gang policy/regulations?**
All TCPS staff complete a 30 minute online Safe Schools' Gang Awareness course prior to the start of each school year. Policies and procedures are generally reviewed at the school levels.

Several elementary schools attend the meetings, but are not mandated.
- 5. In what ways do you feel your gang awareness programs were effective?**
There is Communication between the police, the school administration and students who identify as gang members. The communication has prevented problems in the schools and the community.
- 6. How were/are administrators and teachers trained to implement your gang policy/regulations?**
The School Resource Officers are members of the school-based safety committees and discuss issues with staff. The students, parents and staff are informed of the definition of gangs and what constitutes gang activity. All parties are made aware of the procedures to report gang activities. Staff is required to report suspected gang activity.

Students, parents and staff have access (paper and electronically) to the Gang Related Incident Reporting Form. We have a school resource officer who is a member of the Mid Atlantic Regional Gang Investigators Network (MARGIN). We also have a Task Force Members meeting with the school administration on a regular basis. Information received by social media or parents is shared with the above contacts.
