RE: Enhanced Program-Maryland School for the Blind (MSAR#93)

Dear Senator Kasemeyer, Senator Middleton, Delegate McIntosh and Delegate Hixson:

Section §8-315 of the Education Article requires the Maryland School for the Blind (MSB) to establish and operate a program of enhanced services for blind students who have other severe disabilities. The students served in the Enhanced Program shall be students who are at risk of requiring nonpublic placement in an out-of-State special education facility. The State pays the cost of serving students in the Enhanced Program based on an individual cost sheet on file at the Maryland State Department of Education (MSDE).

Pursuant to Section §8-315 of the Education Article, the MSDE shall report to the budget committees, the House Ways and Means Committee, and the Senate Finance Committee, on or before September 1 of each year, the number of students enrolled in the Enhanced Program of the MSB and the annual costs for the program. In addition, the Department shall report on any anticipated enrollment growth and future costs related to the Enhanced Program.

Below are the number of students enrolled and the annual costs of the Enhanced Program at the MSB for school year 2015-2016. The preliminary data for the current school year, 2016-2017, reflects projected enrollment of 52 students at a cost of \$4,508,745 (\$220,581 in local costs and \$4,288,164 in State costs). The Enhanced Program's projected enrollment for the 2015-2016 school year decreases by 11 students from the previous school year at a decreased in State cost of \$15,171.
