 vol. 6 to the 15th day of August 1850 to wit. This Indenture made this
 11th day of November in the year of our Lord one
 thousand eight hundred and fifty three between Caleb
 Brown Bentley and Henrietta J. Bentley his wife of Montgomery
 County and State of Maryland of the first part and
 Samuel Owens of the County and State aforesaid of the second
 part Witnesseth that for and in consideration of the sum
 of one hundred dollars current money of the United States
 by the said Samuel Owens to the said Caleb Bentley and
 Henrietta J. his wife in hand paid at once before the sealing
 and delivering of these presents the receipt of which is hereby
 acknowledged the said parties of the first part have given
 granted bargain'd sold aliened enfeoffed demised, released
 and confirmed, and by these presents do give grant bargain
 sell alien enfeoff demised release and confirm unto the said
 Samuel Owens his heirs and assigns forever all that part
 parcel of land situate lying and being in the County
 aforesaid is being part of a tract of land called 'Additions
 to Charley Forest' and contained within the following notes
