In compliance with Section 6, Article 60, Code of Public General Laws, to wit: "The Comptroller shall furnish each officer of the State whose accounts are in arrears, at least sixty days prior to a general election, a full statement of his accounts, and in default of his accounting for such deficiencies within thirty days thereafter it shall be the duty of the Comptroller to have published weekly for one month in one or more newspapers in the several counties of the State and the city of Baltimore, the names and titles of said officers, with the amount of such deficiencies."

I herewith publish the following list which embraces the names of all accounting officers in default to the State of Maryland, together with the amount of principal and interest due by each.
