

ARTICLE 2d.

The merchants established by virtue of our Letters Patent, shall have the sole power to treat for the cargoes, either separately or jointly.

ARTICLE 3d.

Every merchant, Foreign or Domestic, who shall receive directly, consignments of vessels, shall not sell the merchandize by retail; and shall conform according to Article 2d, with respect to the sale of their cargoes.

ARTICLE 4th.

The merchants established by our Letters Patent, shall not treat with the Consignees of Foreign vessels, until the Administration shall have made choice of such articles as are necessary for the army.

ARTICLE 5th.

Any person or persons contravening the present Decree, shall be fined three hundred dollars for the first offence, and five hundred for the second.

We give notice, and order, the Minister General of Finance, the General of Division and Brigade, the Principal and Private Administrators, to keep under guard, all who shall contravene the above Decree.

Done at our Imperial Palace, at the Cape, the 15th October 1804, first year of our Independence, and of our Reign the First

LIBERTY OR DEATH. DECREE.

Jacques the 1st, Emperor of Hayti. Taking into view, the protection, and good will that we shew to Foreigners, who transact commercial concerns with us; and who, instead of occupying themselves with their commerce, and respecting the laws of the country with which they deal, are pursuing the most extraordinary conduct, in facilitating the escape of men and women of colour, natives of the country.

We therefore, ordain and decree the following, to be executed to the utmost of its rigour:

ARTICLE 1st.

Every Captain of a foreign vessel, armed or not, on board of whom, one or more persons, natives, shall be found to be carried to a foreign country; such captain shall be arrested and thrown into prison, there to lay ten months, and at that time, to be sent to his own country, with express orders not to return to the Empire of Hayti, at his peril. The vessel and cargo shall be confiscated for the benefit of the Empire.

ARTICLE 2d.

Every native taken on board such a foreign vessel, shall immediately be shot in the Public Square.

The Generals of Divisions and Brigades, and the different Commanders, are charged with the execution of the present Decree.

Done at our Imperial Palace, at the Cape, the 22d Oct. 1804, first year of our Independence, and of our Reign the first.

(Signed,) JACQUES. CABRONNE, Gen. of Horse, near his Imperial Majesty.

MASSACHUSETTS ELECTION.

In order to show how far the opposition have reason to rejoice at the "GLORIOUS NEWS" from Massachusetts, we have copied from the Boston Courier, a comparative statement of the votes given in 106 towns last April for governor and in November for electors.

We will not presume, says the Chronicle, to inform our republican friends throughout the union, that the Jeffersonian ticket will succeed on the issue of the election, in this State; but this we can aver with great truth, that as no time since the patriotic elections of the amiable and munificent HANCOCK, and the venerable S. ADAMS (the professed patriots of Massachusetts) has there been such strong manifestations of popular energy and democratic ardor, as has been displayed on this occasion. As far as we have heard, the proportions of votes, in the various towns forming the central force of the Commonwealth, the returns have been decisively republican, by a great and lustrous majority, considering all that has recently passed.

In descending from this elevated subject, we shall merely notice, that there is the highest probability of NINE republicans being returned from this State, to congress giving the republicans a majority of one in that honorable body.

The factious amendment proposed by Massachusetts to the Constitution of the United States, in relation to Black population, has been negatived by the Legislature of Vermont and Rhode-Island.

"GLORIOUS CHANGE"

Massachusetts.—The public will judge of the grounds of exultation of the federalists about Quincy's success, when they are informed that at "the head quarters of federalism," 4467 votes were given, of which Quincy had 2283, Dr. Emris 2184; leaving the enormous majority of 99 for the federal candidate; yet this is termed the fun of federalism is rising.

A few years ago, the republicans could not venture to oppose, they can now come forward with confidence.

Although we have received no complete returns from any other district than Suffolk which has chosen Quincy, we can date with some degree of certainty what republicans and what federalists have been chosen, and the names of those of whose success we are doubtful:

Repubs elected. Feds elected. Crowinghield, Quincy, Seaver, Wadsworth, Varnum, Stebbins, Cutts, Taggart, Bishop, Chandler, B. dwell.

Of the election of the following candidates we are doubtful.

Republican. Federal. Bangs, Nelson. Cook, Barker, Green, Fowler.

The probability, however, is, that three at least of the five republicans, and that the federal candidate Nelson are elected—these statements we have the best grounds for believing to be correct; the result, therefore, will be thus—Massachusetts will send seven republican representatives to congress, and but seven federalists. It is beyond a doubt, in our judgment, that republicans will compose the majority of the representation. The increase of republican votes, was beyond example great at this election, in the districts which Mr. Hastings represents in the present

congress, the increase of republican votes since April has been about 520, and the probability is that Mr. Hastings will be permitted to spend his next winter at home; in the town which is his place of residence he had but 35 votes, his opponents, Mr. Bangs, had in the same town 105. In nearly all the towns, even in Bolton, there has been an increase of republican votes, the federal votes have increased but in a few.—[Aurora.]

The electors of president and vice-president, chosen by the legislature of New York, (nineteen) "are," says the American Citizen, "all decided republicans and will undoubtedly vote for Jefferson and Clinton.

Vermont electors.—We are happy to be able to state that Vermont has returned six decided republicans as her electors of President and Vice President—their names are, Josiah Whipple, Samuel Shaw, Ezra Butler, Nathaniel Niles, Wm. Hunter, and John Noyes: who will, no doubt, every one vote for Jefferson and Clinton.

The legislature of New Jersey have passed the act for incorporating the "City of Jersey," at Pauls Hook.

Thy's amendment.—In the house of representatives of New Jersey on Wednesday last, Mr. Kitchell offered a resolution against the Massachusetts resolutions, recommending an amendment of the constitution of the United States—after a short discussion in committee of the whole, the resolution was adopted. This is the first state which has had these resolutions under consideration and the third to oppose them. It is remarkable that his early decision has been made by three small states, two of which have few or no slaves, and the third a dispensation for the freedom of a definite period, of those who shall not, by any other means, become free before their expiration. Such is the effect of such scandalous efforts to excite jealousy and promote the division of the states. [Aurora.]

Mr. King, who arrived here in the Thetis, from Martinique, informs that a few days previous to his falling arrived at Trinity a French frigate with 250 troops, cash & being one of the three that sailed in company bound to Martinique. The next day after the arrival of the frigate, the port of Trinity was chiefly blockaded by three English frigates, & continued when the Thetis sailed. [Norwich Courier.]

INFORMATION.—The lead mine discovered on Parkimon creek, the property of Francis Deacon, has been lately opened, and attended with great success. The vein proves to be a regular one, and of a long continuance. Its course is N. N. E. its direction nearly perpendicular, and its thickness from one foot to 15 inches. Two tons of that beautiful ore was raised in a few hours, and one ton more at least, was left in the bottom of the pit, which is yet but 9 feet deep. From the situation of this mine, its nearness to navigation and market, its very commanding height, its richness in metal, and the large field it forms on—it is thought by judges to be one of the first discoveries yet made in the United States.

From the analysis made of 100 parts, it contains—Oxide of lead 85 Oxide of iron 1 Sulphuric acid 13 Water 1

The lead being compelled, has proved to contain 2 and an half oz. fine silver to 100, which is nearly 3 dollars worth of the metal. [Phil. paper.]
