BE it enacted by the general assembly of Maryland, That this state shall be divided into six judicial districts...

IV. And be it enacted, That if the attorney-general or the prosecutor for the state...

V. And be it enacted, That there shall be a court of appeals, and the same shall be composed of the chief judges of the several judicial districts of the state...

VI. And be it enacted, That all and every part of the constitution and form of government...
