We are requested to advise you to our readers, and other well-informed friends, of the General Assembly of the STATE OF NEW YORK. They may thus be possessed of their annual statement of the state of the union, which will be highly interesting, and it has always merit. And the public estimation is unfeignedly the best proof of its merit.

We understand that a letter from Bordeaux of the 2d of October, received at New York, mentions, that the French army had crossed the Rhine, & at the W. India goods were on the rise.

GENERAL MURRAY, it is said, will attend the review of the troops in New-York, on the 23d instant.

The house of delegates on Wednesday last, elected JAMES L. HAWKINS, director in the Bank of Baltimore, on the part of the state, for the ensuing year.

Leave has been given, in the general assembly of this state to bring in the following bills:

A bill to provide for the election of the governor by the people, and to abolish all those parts of the constitution and form of government which relate to the council of the governor, and the time and manner of electing the governor, and other purposes.

A bill to incorporate a company to make a turnpike road from the line of the district of Columbia, where it crosses the post-road leading from George-town to Frederick, through Montgomery and Frederick counties to Frederick.

A further additional supplement to the act, entitled, An act to mark out a bordering land; a bill to provide for the election of commissioners by the people to settle and ascertain the public taxes in each county of this state, and for other purposes; a bill to authorize the judges of the general court to send causes to their respective counties for trial, to facilitate the taking the depositions of witnesses, and to prevent the removal of causes for delay from the county courts to the general court, and for the regulation of fees in the general court, chancery court, and court of appeals; and a bill to withdraw the funds from Washington and Saint John's colleges.

A bill to prevent free colored persons from selling wheat, corn or tobacco.

A supplement to the act, entitled, An act to lay out and establish a road from the city of Annapolis to the city of Washington, and to repeal the act of assembly, therein mentioned.

SPANISH DEPREATIONS.
Letter from a friend at Havana to the Editor of the Boston Repository, dated HAVANNA, October 19, 1803.

SIR,
The numerous insults, offered to the flag of our country, prompt me to enclose an account of the treatment received by Captain Thompson, in a vessel bound from Jamaica to New York, from a Spanish privateer, and after the Captain's arrival in this city. This I have received from Capt. Barnett, a passenger.

Schooner Nelson of Newbern, N. C. Thomas Thompson, Master, from Jamaica for New York, was captured, October 14, in lat. 24, 15, long. 81, 30, by the Spanish privateer schooner Vengeance; was plundered of cash to the amount of 12,222 dollars; all the instruments on board; two good watches; all their clothes and a Negro man. A prize master and a number of cut throats were put on board, and ordered for Camppeachy; but by the persuasions of Capt. Thompson and Capt. Barnett, a passenger, they steerred for Mariel, where the vessel now remains, waiting her doom.

Captains T. & B. immediately repaired to the Havana for redress, but on enter-

ing the gates were stopped by the guards, placed in care of 2 soldiers, ordered to the Governor, from him to the General of Marines, but no satisfaction is as yet obtained and what is worse, no good prospect before them.
