

BOSTON, May 5.

FRENCH FLEET.—Capt. Corby, who arrived at Newburyport on Friday last, from the schooner, informs that, on the 14th of March, in lat. 31, 40, lon. 21, 40, he was brought to by and boarded from a French fleet of eight sail of the line. Two days afterwards in lon. 23, 6, fell in with a British fleet of 120 sail of merchantmen, steering W. S. W. The same day was boarded from a French sloop of war.

Capt. Hullen, who arrived yesterday from Bilbao, failed thence with the design of proceeding to the Isle of Rbe for a cargo of fait, but was boarded from an English frigate, and informed of the British Order of Council forbidding neutrals to go from one enemy's port to another.

NEW-YORK, May 8.

The Albany mail due last evening had not arrived at midnight; so that we have nothing to lay before the reader, as to election returns, but verbal reports, conveyed to us yesterday principally by Albany papers.

Oneida, it is rumoured, has given Lewis a majority of but 16.

The British frigate Jason arrived at Barbadoes on the 11th ult. from a cruise. She had spoken an American ship from Rio-Grande for New-Orleans, and was informed, that the British forces under General Atchafaluy, had taken Monte-Viedo on the 2d of February, after great slaughter.

[This account is probably correct—for Captain Brown, of the brig Perseverance, who arrived here on Tuesday, sailed from the River of Plate on the 29th of Jan. immediately preceding which time Monte-Viedo had been taken—14 days, and it was expected the place would surrender.—The account of the taking of this place, as given by Captain Russell, cannot be correct.—Captain Brown is the latest from that quarter.]

IMPORTANT INSURANCE DECISION, IN THE DISTRICT COURT OF PENNSYLVANIA.

MONDAY, May 4.

The argument of Marshall, of the Delaware Insurance Company, on the case of the Rolla, was closed this morning, and judgment given for the defendants—that they are only liable for an average loss. The principles of the decision are highly important, deciding, for the first time, expressly,

- 1. That the date of the fact, not of the intelligence, at the time of the abandonment, must decide the question of total or average loss.
2. That capture and restitution before abandonment, though not known here, defeats the claim for a total loss.
3. That the property being safe, although not actually in the possession of the owner, the right to abandon, and claim as for a total loss, cannot be exercised, at a period subsequent, with, or without notice of the fact here. On this point, however, Judge Wallington only declared the leaving of his mind; as he thought, the fact of actual restitution of the insured, before the hour of abandonment, sufficiently established by the evidence in the case of the Rolla.

Conquest of Montevideo.

BRIDGE-TOWN, (Barbadoes,) April 11.

The following particulars of this event will be found highly gratifying, being given with an accuracy which does not admit of a doubt, and upon which further proof of the valor, discipline and enterprise of the British arms, we pay a most willing testimony. The account is received from the American brig Troy, John Hazard, 44 days from Rio Grande, bound to New-Orleans; spoke by his majesty's ship Jason arrived here this morning from a cruise, and communicated to us from the first authority.

General Achmuty with a reinforcement of four or five hundred men, about the 7th of January last arrived at Malibado, and after having embarked all our troops then there, proceeded up the river towards Montevideo, landed at point Cartas, about three miles from town, on the 19th, and immediately attacked and routed a body of Spaniards collected to prevent their landing, taking from them a twenty-four pounder. The English then marched and took post at the watering place, about a mile from the town.—On the 23d the Spaniards came out of Montevideo with five thousand men to attack them. The English immediately decamped and formed an apparent retreat, till they got 3 miles from the town, when they halted: the Spaniards who supposed them flying, pursuing in a most furious manner, huzzaing, &c. during this retreat a party of 3000 cavalry, with some infantry, were landed between the enemy and town from our ships.

On being attacked the enemy made a very faint resistance, and retired in the greatest confusion, only 300 Spaniards getting back to the town. The viceroi, with 100 men, escaped into the country. Our troops then proceeded to invest the town; and on the 2d Feb. having made a feint at the harbour (or North Gates, which drew the enemy's attention to that part) the English army entered by the Sea Gates, which they faced, and after a great carnage took possession of the town.

When the Troy left Rio Grande, the English were preparing to proceed for Buenos Ayres. General Beresford was still a prisoner about ten leagues from Buenos Ayres. The English prisoners, said to be about three hundred deficient of their original number, are dispersed about the country.

A report of the expected arrival at Martinique of the Rochefort squadron, has again been revived here. His majesty's schooner Morne Fortune, is said to have brought home account to this effect, from St. Lucia, which state that the squadron consists of six sail of the line and some frigates, with 3000 troops.

A neutral from St. Pierre's, which left it four days ago, and arrived here last night, in some measure corroborates the report; yet it does not appear to attract much attention in either our naval or military circles, although we understand that Sir Alexander Cochrane, with his squadron of the line, goes to sea in consequence of this evening.
