

Board, when the Point had been solemnly decided by his Majesty in Council. Upon showing this, the Council for the Memorial gave up the Point, and declared, *They were not apprized of it before.* Mr. Attorney concluded (as Mr. Solicitor did after him) with a handsome Eulogium of the Governor's Conduct, and said, The Reason of his adjourning the General Court to *Salem*, was, because the Town of *Boston* had, in a very extraordinary and factious Manner, met in Common Council (as they term it) and there enter'd a sort of Protest against his Majesty's Instruction.

As soon as the Board of Trade have drawn their Report, I'll acquaint you of it.
