The Coming Inquagration Ball.—Our highly esteemed friend Rev. W. T. D. Clemm is quite out-spoken about the approaching Inauguration Ball. which will take place on the evening of the 4th of March next. Mr. Clemm is a member of the Methodist Episcopal Ministers' Association, and when present among his brethren always speaks his mind, no matter whom it pinches. The ministers a few vate, and not allow their proceedings to get before the public. This is contrary to the wishes of Mr Clemm, who believes that all matters should be discussed with open doors. If he had been present at the ministers' meeting on Monday he would have offered the annexed resolution in reference to the Resolved, That we endorse without reserve the action of the Methodist Preachers' Association of Columbus, Ohio, "that in the election of a Christian man to the Presidency it is a fitting time for high official discountenance to the tendencies in certain quarters to imitate the follies, pageantry and extravagance of European courts, and their protest against the proposed expenditure of nearly \$1,000,000 for the purpose of imitating these follies, corrupting the simplicity of Republican principles. encouraging the tendencies to extravagancies and perpetuating that relic of barbarism—the inauguration ball—on the occasion of his induction into the office of the Presidency. And we hereby suggest and commend as a much more appropriate commemoration of this event that a union religious service be held on the night of the 4th of March in Washington, to which the President and his family be invited, and in which the blessing and guidance of the God of nations be invoked upon the Chief Magistrate, his administration and the country. As to the Inauguration Ball, Mr. Clemm is emphatic in condemning it as a great folly, and as a sin. It is a curse upon our social life, sensual and corrupting, and adverse to spiritual purity and the sanctity of the religious life. Any ball is an evil, social and moral, but this ball is especially so by a bad pre-eminence. The Harford Turnpike.—The Directors of the Harford Turnpike Company have come in of late for a good deal of abuse owing to the bad condition of the road bed between Hall's Springs and Boundary Avenue. It is hoped that their first efforts to remedy the evil having been so successful they will be able to put the road again into proper order. An Act of Assembly provides that not more than three tons shall be carried on a four inch tire, not more than five on a six-inch tire, and above that requires a ten-inch tire. The stone wagons hauling stone for the Harford-run sewer violated the rule, ill remonstrance being useless. The Company then built scales at Gate 1 and weighed the wagons each trip. They have now sued and obtained judgment against Mr. I. H. Peddicord, whose wagons have een ruining the road-bed. There is no way of stopping the hauling, but a law allows the collec-tion of a fine four times the ordinary toll for each fiense, which the Company has put in force. The Company is asserting its rights against the tres-passers of this rule, and are determined to force them off the road. They have won one suit, and are going to keep on suing for every violation of the rule. A deputation called upon Mr. Williams to remonstrate, but it was shown them that all the money that was being collected at the first gate was being spent on that part of the road, but all to no purpose. Indignation meetings and a torch-light procession were held also. But the Company, without seeming to notice such protestations, has been quietly trying to stop this illegal hauling, and it is believed they will be able to do so. The Hillen and Walls Roads certainly owe their damaged condition to heavy hauling. The latter, especially, is in a pitiable condition on both sides of North Ave-
