Recently the New York Herald sent its Washington correspondents into the three great departments at Washington-Treasury, Interior and Post Office-to ascertain the number of appointees of Cleveland's administration and the number of Republican "hold overs." appointed by Republican administrations, and still in office, and the figures stand thus: Treasury-1.230 "hold overs." with \$1,885,000 annual pay, and 440 Democratic appointments. with \$878,340 annual pay. Interior -1.674 "hold overs," with \$2,000,000 annual pay, and 456 Democratic appointments,

About 150,000 visitors came to Washington from distances varying from 50 miles to 3,000. The average cost of the trip to each of the persons for fares alone is estimated at \$10, which would eat up \$1,500,000, or put it in the pockets of the railroads. If the visitors boarded here at the rate of \$5 for the stay of two of three days, they spent \$750,000 more, all of which went into Washington pockets. Then there were ball tickets sold to the amount of \$58,000, and two thirds of them were undoubtedly sold to strangers. Cars, cabs, carriages, stages, restaurants, saloons, all collected money as fast as they could render service and collect, and they must have taken up enoumous sums. BALTIMORE, March 15th, 1889. Let the succrers who have heretofore succred at the prognostications of the ground-hog, unwind their horns now, and wind them again to play an entirely different tune for the future. For surely the most exacting of skeptics could not require any performances in the prophetic line to be more satisfactory than those which have just been furnished us by that astute little animal. So if fitness for position were really to be considered in the coming distribution of offices in Washington, we might send our worchance for a share in the spoils soon to be appropriated by the bipeds belonging to kindred species. But even if any one were sanguine enough to hope for the enforcement of Civil Service rules at present, recent developments have shown us that the star of the "Maryland Delegation" has faded, and the potency of its influence vanished. For somewhile to come. therefore, we need not bother ourselves with any endeavors to obtain rewards for merit. There will be numerous percine creatures in Washington whose claims for consideration will

far exceed ours. The mention of ground-hog weather is a reminder of that queer fancy of our uncestors which makes of the month of March a sort of composite animal, like those of which classical antiquity has left us so many illustrations. Ex ept that our March, which is compounded of the lion and the lamb, seems to have been coustructed with the heads of these two animals at its opposite extremities. By which device t seems to be capable of walking in either diits fancy, or as one or the other of its two freewills happens to have achieved the ascendency. And hence we can understand that if it enters the year lion-end first, as it has come this time. its lamb-end will be that presented upon its departure; while, of course, if the lamb leads the way it will be the lion portion which must fol-

The picture of this beast, however, is by no means an attractive one. We cannot admire the creature of bold front, which advances with brave bluster, promising to perform mighty deeds, when after all there is nothing but sheepishness behind its display of valor. And neither can we approve the demeanor whose approaches of meekness and gentleness are only the prelude to the rampant roarings of flerceness which it keeps ready in reserve. So whichever way we take it, and we must take it as it | comes, March is a treacherous, deceitful, bad month; the worst, and the most disreputable, and disagreeable, in the whole year. And perhaps this was one of the very reasons which induced those who established our religious customs to set the season of Lent mostly at this time; with a view either of toning down its disagreeable nature, or of turning its disadvantages, in some way, to our profit. Indeed, it is probable that we do not give the founders of our institutions half enough credit for the tions.

The remarkable timeliness of this very season of Lent, is a case that is quite in point. It ers blooming; or when we are oppressed with the languor of midsummer; not when the garnered harvests and ripe fruits call upon us for rejoicing feasts; nor when the crisp, bright veins, that the human sinner is required to humble himself in the sackcloth and ashes of penitential sorrow, and mourn over his evil nature, and the wretched estate of a guilty world. No: but when he has passed through this whole round of the seasons, and has gathered the blessings from each and all of them; when he has enjoyed all their delights; when he has eaten his fill of all manner of viands, and sits down sated after his feast; when his heavy raiment has grown shabby, but must not be discarded, because the bleak, damp, raw, chilly weather makes it more necessary than ever, and the clouds of dust that come sweeping over him at every corner, render it the most appropriate for the occasion; when the season is neither winter or spring, but just a forloru, dreary, dismal foretaste of purgatorial horrors; when neuralgia and rheumatism wrack his bones, and a cough tears his throat and lungs: when past pleasures seem to be dreams, and future happiness impossible: then the poor diapidated soul is taken into the Church hospital, and its wounds and bruises are dressed; i is physicked and coddled, and rested and soothed, that it may be restored whole, and

To be sure, it pleases the children, for a few days or weeks, to have these things; but it really seems to cultivate their destructive propensities; and the question is whether it does

But then"-But then: when we come to look at the sums which are wasted upon the toys for grown folks, at the jewels, and feathers, and unnecessary fineries of all sorts, in which Christian people invest their funds; when we consider the cost of cast-off party dresses; of rare flowers, and festive banquets; of the luxurious Christian homes, and gorgeous churches; when we think what sums are lavished upon material things. by Christian people who have promised to renounce the world; when we turn from the costly baptismal robe of the infant, to gaze upon the magnificence of his funeral, three or four scores of years later; when we wander through our cemeteries studded with costly crumbling monuments, and adorned with withered garlands of expensive flowers, it is the cost of the toys for grown folks, and the perishable character of even these, that we are confounded to consider. turned. There's a big row in the Republican camp already. It is a question of veracity between Harrison and Ex Governor Alger. Alger told the Michigan delegation that Harrison had expressed great regret on account of having to leave him (Alger) out of the Cabinet, and that as a slight compensation the President had told him that he might name a man for Solicitor General. He named H. M. Duffield. whom he asked the delegation to endorse, at the same time assuring them that it was only a formality; that the appointment would be considered personal, and would not be charged to the State. The delegation endorsed the application and carried it immediately to Mr. Harrison. The delegation was struck dumb when the President told them he knew nothing about the matter, and that they had better file the application with the Attorney General. What transpired when the delegation got back to Alger is not known. Representative Townshend, of Illinois, died suddenly on Saturday.
