Jackson notice that he has designated Wednes-day, April 10th, as "Arbor Day." In view of this designation Prof. Newell has addressed a circular letter to Mr. Chas. B. Bogers, Examiner, with full instructions as to the observance of the day. In order that teachers and pupils may learn all the order that teachers and pupils may learn all the facts we herewith print the circular entire:

OFFICE OF THE STATE BOARD OF EDUCATION, BALTIMORE, March 15th, 1889.

Dear Sir:—The Governor, in pursuance of law, has appointed the 10th of April next to be observed as "Arbor Day." The purpose of this observance is to inspire the young with a love of trees, to prevent the unneces-sary destruction of our remaining forests, and to lead to a more general system of tree-planting, and You will notify the teachers of your county that the ordinary school exercises will be omitted on Arbor Day; and that the pupils shall assemble at the school house at an appointed hour with their friends and neighbors.

Appropriate selections should be read, suitable songs sung, and essays read by the pupils. Addresses by citizens of the neighborhood would also be in order, either in the school room or on the

At the conclusion of the literary exercises th tree, or trees, will be planted and named. The trees must be procured beforehand, and all necessary arrangements made. If the school premises do not afford a suitable place, let the trees be planted by the roadside, and in such a way that in successive years a line of shade trees will grow up. If the school prefers to plant fruit trees, there is no objection. The pear and cherry are graceful and excellent ornamental trees for the way-side.

I would not accept three-year-olds as a gift where I could buy yearlings at a reasonable The following hints on "How to Plant" are by D B. G. Northrop in the report of the Secretary of the Connecticut Board of Agriculture.

"Let the holes be dug beforehand, and deeper and wider than is needful to receive the roots when spread to the utmost. Great care is needed in when spread to the utmost. Great care is needed in lifting or digging up trees so as to get the most and longest roots possible, and especially the fine capillary rootlets. When first dug up, the roots should be set in a box or barrel and covered with moist leaves. \* \* \* \* Spread some four inches of good soil in the ample hole. Set the tree about three inches lower than it stood before, spread its roots carefully in all directions as they grew.— Churn the tree gently, while rich, pulverized soil is thrown upon the roots, working it around them with the hand so that no empty spaces be left; dashing water on the roots to secure their closest embrace by the soil; tread the earth firmly about the roots; cover the whole with a little loose earth to prevent the surface from baking; leave the soil around the tree a little lower than the general level; and mulch freely with straw or leaves." A Cut in J. P. Charges, -Under the provisions of the new code which has become operative throughout the State, the fees of the Justices of the Peace have been considerably diminished. There are no fees allowed for the summons of witnesses, for taking affidavits, for hearings in cases, for docket entries nor for judgments rendered. The only fee allowed in a criminal case is 30 cents for each warrant issued and fees for commitments.—

Thorne and Jones have the contract for hauling the water pipes recently taken up which were used for the temporary water supply from the Gunpowder River, at Meredith's Ford Bridge, to Roland Run, at Lutherville, leading into Lake Roland. There are 1,050 pipes, each 12 feet long, and the contractor gets \$6.90 for each pipe delivered in Baltimore. It is said that the pipes weigh about five tons each. The whole cost of hauling will be \$10,695
