President Mayer being interviewed upon the subject said:

"There never had been any intention of closing those important shops, but that in keeping the Company's increased equipment of cars and engines in good order and up to the highest state of efficiency these shops would be fully employed and would furnish plenty of work for the large number of amployed. On the conrary, my information is that the engines now be ing constructed at Mt. Clare are equal in every reing constructed at Mt. Clare are equal in every respect to engines constructed at any other works in the country, and that the average cost will compare favorably with the cost of those of a like character purchased elsewhere. Correspondence of the Maryland Journal. OUR BALTIMORE LETTER.

Coincidental Dates--Egypt and the Hebrews-England and America-Satan and the Souls-The Chapel of the Cross-Adam's Grave-The Vision of Saint Francis-Modern Methods as to Sinners and Saints-A Bemarkable Result-The Hope of Good Friday.

• Baltimore, April 19th, 1889. Which, as we are well aware, is a date of much historical significance in the anuals Baltimore, and also of those of our nationa career. The city's celebrity in connection therewith, we are of course doing our best endeavors to ignore and forget, in the Christianlike effort to heal up the wounds made by the passions developed in sectional strife. But the ational recollection of the first blood shed in the Revolution will naturally and necessarily be quickened and refreshed by the celebration of our Constitutional Centennial, which is now so near at hand. So that it is quite in order now for all good, patriotic citizens to rejoice over the delivery of this nation from its condage to monarchical power, and the estabishment of its own independent existence, as the results of the work that was begun on this same date in 1775.

It is by a coincidence, therefore, that we find the Hebrews at this time celebrating their feast of the passover, in commemoration of the deliverance of their forefathers from their bondage to the power of Egypt; and of their taking the, step which resulted in the birth of one of the world's most remarkable nations. And throughout this week every plous Israe. lite the world over, whether in Europe, or America, in the Holy Land, or in China, Kamtchatks, the African provinces, or the isles of the sea, appear in his place of worship, and listen to the same Scriptures, and recite the same prayers; and he will eat his unleavened bread, chew his bitter herbs, in thankful recollection of the evils which his race escaped, and the plessings it secured, by means of the events which the paschal feast commemorates.

As there are millions of Jows scattered over the world, the occasion is, of course, one of very wide significance. But its scope becomes vastly more extensive in view of the fact that the present is Passion Week of the much more numerous millions of the whole Christian world. The general tenor of events runs on so smoothly, however, that we may very easily fail to recognize the full import of this season. Business proceeds almost the same as usual; the streets are as full of people; the ordinary avocations of life are seemingly carried on in their accustomed ways; and on the surface there is little sign of the quiet work that is going on all over Christendom: very little evidence of the tremendous powers that are being brought to bear upon the consciences

Yet daily and nightly, through this week there are congregated in the thousands of churches of both Catholics and Protestants scattered over two hemispheres, uncounted millions of people who assemble to commemorate the deliverance of the human race from its bondage Satan, and the founding of Christian commonwealth upon the earth. And in the ears of all these vast, mixed multitudes of men, women, and children there is related and rehearsed, with repeated repetitions the story of the most awful tragedy that the world has ever witnessed. A story that never grows old, or loses its terrible pathos, but on the contrary, seems to grow more and more terribly thrilling with every year's repetition. It would be natural to expect and very reaonable to fear, that the annual recital and portrayal of the dreadful scenes of the agony, the betrayal, the trial and the crucifixion of Christ, would blunt the susceptibilities of the hearers, and dull their feelings, and finally render them callous to the details of the awful story. But the reverse of this result is what occurs in the case of normally healthy Christians. Their sensibilities are quickened; their hearts are touched; emotions of gratitude well up within their souls; their affections go out o the Lord who has given his own life to se-

cure their eternal happiness; their pious resolves are strengthened, and they grow into larger hearted and better beings. In the volumes of "The Land and the Book there is an account of the Chapel of the Cross, which is built on Galgotha, or Mount Calvary. It says, among other things, that "in the apse. on the east side of this room, are shown the places where stood the three crosses; that of Jesus in the middle, and on either side those of the two thieves, some five feet distant. About the same distance from the cross of Christ is shown the cleft made in the rock when "the earth did quake, and the rocks rent," at the hour that Jesus yielded up the ghost; and beneath it is the Chapel of Adam. The idea that Adam was buried in Golgotha prevailed extensively in early times. It is mentioned by Origen, Athanasius, Basil, Jerome, and many others. The tradition is that the blood of Jesus flowed down through the cleft in the rock upon the

head of Adam, and by it he was restored to Such was the power anciently ascribed the faithful to the literal blood of the crucified Saviour. And some such life-giving efficacy seems to remain still, for the dead and dried up souls of men, even in the recital of the story of the crucifizion. It is like the voice of a soundest sleeper; though of course the deliberate sinner may refuse to obey its call. In such, even the blood of the Crucified One fails to quicken the heavenly life germ; for goodness being a matter of choice, it is not possible to make any one good under compulsion. A legend with this moral relates that a cer-

tain notoriously wicked man being very ill, his parish priest came to him, and tried very long and hard to induce him to renounce his evil ways, and bring him to "repentance and a better mind." But making no impression upon the murder has already been committed resulting hardened criminal, and finding that death drew near, he sent for a certain St. Francis to come and endeavor to save the poor perishing soul. The St. hastened to obey the summons, and used his best efforts to convert the dying sinner. But without any avail. He spent hours and hours kneeling by the bed of the impenitent man, praying, weeping, pleading, and implor-

ing, yet the blasphemous soul refused every pious suggestion. At last, quite exhausted with his endeavors. the good St. sank into a swoon, and in this state he beheld a vision. He saw the real cross with the dead, crucified Saviour extended upon it, with the blood, sweat, and tears streaming down from his face over his body. Then as the St. did not heed or regard him. Then the right hand of the Lord released itself from the nail that held it to the cross, and the curved palm filled with blood which he dashed into the face

of course. It could not very well, happen in these modern days. For if this notorious evildoer had lived in these times it is not likely that he would have been notorious at all. It is much more respectable now not to do evil openly, but to appear hypocritically decent. So he would probably have been a deacon of vestry-man in some church; and if he had headed subscription lists promptly, the clergyman in charge would not have worried much over him in his dying days. But if so be that any one had been sufficiently interested in him to be solicitous about his salvation, and had wanted to find a saint to snatch his soul from destruction, he might have had to go so far in his search that the man would have been dead before his return, even if he succeeded in bringing a real, live saint home with him.

And if there were no saint, there would be no vision, of course. We ought to have some saints in these days. though. In fact, we ought to have a great many more than they had in the days when Christianity was new, and its methods had not been thoroughly worked out and tested. It stands to reason that the older Christianity rows, and the better its theories are developed, the larger and finer should be the crop of Saints which it produces. But this does not seem to be the result, though there are numbers of people who appear to be using the means which ought to develop their saintship. We have regular church goers, and Bible-class students all the year round; and when Lent comes there are flocks of devotees, who say extra prayers, and do penances, and give alms, and fast, with a perseverance worthy of an old-fachioned martyr, or a medieval

For some remarkable reason, however, these means and measures do not seem to turn ou the old brand of saints at this date. We respectfully submit that we have been in session 84 days, docketed 137 cases, examined 265 witnesses, made 97 presentments, found 94 true bills, ignored 3 cases and dismissed 40 cases.
