But it is admitted that certain obstructions do exist in the bed of the highway of the traverser which interferes with public travel, and which, it alleges, were placed there by the Maryland Central Railroad Company, and which the traverser has endeavored to have removed; and the traverser submits to such judgment as shall be proper in the case. Blind Lawyer.—Mr. James B. Green, a blind lawyer, formerly of Baltimore, was on the 27th ult. awarded a verdict of \$12,000 by a jury in the Circuit Court at Richmond, Va. On August 14th, 1888, while traveling on the Virginia Midland Railroad, Mr. Green sustained serious injuries in an accident which occurred near Culpepper Court House .-These resulted in paralysis of the lower limbs and unfitted the plaintiff from the performance of any manual labor and destroyed all power of locomotion. Mr. Green brought a suit for \$40,000 damages against the Richmond and Danville Railroad, to whose system the Virginia Midland belongs. The defendant company did not appeal nor ask for a new trial. It is believed that the road is quite well satisfied with the result of the trial. Mr. Green was deprived of his eyesight by an accident while attending the University of Virginia as a student some years ago. Notwithstanding this great affliction he determined to continue his studies. He employed some one to read the text-books to him and under these disadvantages graduated with Mr. Green has practiced in the Circuit Court for Baltimore County and is highly esteemed as a good business man.

Arrest of Col. Wm. Louis Schley .- The Grand Jury of the United States District Court, on the 27th ult., found an indictment against Col. Wm. Louis Scheley, the well known pension claim agent, charging him with assisting in making, forging and counterfiting a voucher, for the purpose of obtaining money from the United States. The case was that of Mrs. Laura Weaver, a widow, who was entitled to a pension, and who died a year or so ago with-out having received it. It is charged that her son, August Weaver, induced Mrs. Catherine Miller to impersonate his mother, and that Col. Schley pre-pared the voucher purporting to have been execued by Mrs. Weaver, knowing at the time that Mrs. Weaver was dead. August Weaver and Mrs. Miller have also been indicted, and are out on bail. Suicide at Steelton.-On the 23d ult. Geo. Clark, aged 57 years, an employee of the Steelton Company at Sparrow's Point, committed suicide by nanging himself. He was discovered by his wife, swinging by a small piece of rope which had been neck in almost perfect hangman's style. Near him notes of praise. was an over-turned stool. First making the rope Mr. Wm. G. A ast to the beam overhead, he stepped on the stool, fixed the noose about his neck, then kicking over the stool swung off, and his life was strangled out of him. Committed Suicide.—On Sunday morning, 26th ult., between 9 and 10 o'clock, the Rev. Henry Greenfield Schorr, Assistant Rector of St. Paul's P. E. Church, Charles and Saratoga streets, Baltimore committed suicide at his rooms at St. Paul's House Cathedral street, Baltimore, by shooting himself in the right temple with a pistol. Rev. Mr. Schorr being late in making his appearance at services at the church, Rev. Dr. J. S. B. Hodges repaired to Mr. Schorr's rooms and knocked. Receiving no answer he opened the door and found Mr. Schorr's body on the floor with a pistol near his right hand and a large wound in the right temple. The ball entered the temple and came out near the left ear. On a table was the following note: "SUNDAY, May 26th, 1889, Many will condemn me. God will have mercy. Tell my dear, aged parents, 905 Eastern avenue. in this city, but do it in a gentle manner. Bury me from St. Paul's House, and do not send my body to my parents. It will kill them if you do. H. GREENFIELD SCHORR." He opened his Bible, which lay on a table, and placed the note on it, laying a paper-weight on it to keep it in place. Then he removed all his clothes, laid them carefully across the back of a chair in the study, took out all his other clothes and placed them on a lounge, and put on his night shirt. He had apparently been dead twenty minutes when Dr. Hodges and Mr. Glenn entered

the room, and in all probability death was instantaneous. Dr. Hodges at once sent for Dr. Robert W. Johnson, who came immediately, and pronounced him dead. Mr. Frederick Schorr (the father of the unfortunate man) thinks the suicide of his son was caused by temporary abberation of mind, produced by financial matters, his son having endorsed a note for \$2,000, which he had to pay, for a party in Mc-Keesport, Pa., where he was pastor of a church Mr. Schorr was very much liked by the congregation of St. Paul's. Later developments in the case prove Schorr to have behaved in a base manner. On the day before his suicide he sent all the letters received from Mrs. Smith, with some of his own, to the New York World in which paper they appeared on Tuesday. This seems to have been a clear case of revenge because Mrs. Smith refused to marry him. Mrs. Smith is known to be a lady of the highest respectability and refinement. The disclosures of the erratic Schorr are of the most painful character and have greatly prostrated her. From his posi-tion in the church schorr had excellent opportunities to operate. Mrs. Smith fell under his wiles, but seems to have discovered later that he would not be

a man to whom she ought to link her destiny, and It is now known that Schorr's supposed endorsement of a note at McKeesport was not correct. Some of Schorr's letters to Mrs. Smith contain blasphemous sentences, and are entirely unlike those a tender lover or a sane man would write. The revelations have produced a decided sensation in Baltimore where the parties are well known. The community is unanimous in condemnation of the act of Schorr in sending the letters to the press, and by their publication doing almost irreparable injustice to an excellent lady. At the hour of 10 A. M. the body was enclosed in a beautiful cloth-covered casket furnished by Mr. Wm. C. Brooks. After being viewed by the grief-stricken widow, children and friends, the members of Hereford Lodge, No. 89, I. O. O. F., of which deceased was an honored member of many years standing, carried the body to the M. E. Church near-by, followed by the mourners, where they were met by the Revs. S. N. Alford and F. H. Havenner, both of whom spoke feelingly to the family and people, and paid tributes of eulogy on the life and character of Mr. Young. One pleasing part of the services was the singing of a duet by Mrs. F. H. Havenner and Miss Rosa Heathcote entitled "In the Morning." It was rendered in an exquisite manner. Miss Heathcote presided at the organ. made of immortelles; a sheaf of wheat, and a beau-tiful bouquet of lillies-of-the valley, were the offer-ings of his children and friends. The congregation, in defiance of the bad weather, was large, and would have been much more so under favorable circumstances. His brother from Johnstown, Pa.; relatives from York, Pa., Baltimore, Washington, and other points, were present. Mr. Abraham Young was born in Marietta, Lancaster county, Pa., and was in the 62d year of his age at the time of his death. He came to Baltimore county when only about 16 years of age and learned the trade of wheelwright at Piney Hill and Hereford, which business he carried on during his lifetime. He also followed attending funerals and kept a hearse. He was considered a first-class workman. The de was considered a first-class workman. The de-ceased was of a loveable, quiet, good-natured dis-position, and was highly respected. He was called a square, honest man, and was a gentleman of the old school—liberal in all his dealings. He delighted in his family, and his beautiful little home was his kingdom; and his family in turn loved their father. He leaves a sorrowing widow, three daughters, and seventeen grand.

A High-License Movement for Baltimore City.—Mr. Meyer Stein (of Stein Brothers, bankers,) who is the originator of the movement in Baltimore city to bring about high license for liquor salcons and to establish a Police Court for the trial of petty cases, said on the 27th ult. to a reporter of The Sun: "Two years ago this summer I was a member of the Grand Jury of which Mr. W. W. Spence was foreman. During my term of service witnesses who were summoned in saloon cases made false statements. Since that time I have been thinking, is there no remedy for this? At last I started this movement for high license and a Police Court, which I believe will relieve the Grand Jury of a great deal of work and save the city much expense, I had a talk with Mr. Spence, and he accepted the plan heartily. We sent out the circular, and every gentleman, business man, lawyer and capitalist have seen has, without exception, approved of the plan with enthusiasm, and we feel now that there can be scarcely any doubt of success. The matter must be carried of course to the Legislature, and every candidate who is nominated will be questioned as to his position, and must give a positive answer. A number of our best and well-known citizens have consented to units in this movement. Others will be invited to join, and we shall have a conference next Monday night at Concordia Opera House organ. Upon the subject of prohibition and high license we give herewith the excellent views of His Eminence, Cardinal Gibbons, than whom there is no more intelligent and far seeing citizen among us. In conversation with a representative of the Sun the Cardinal said:

who does not declare himself in favor of the move-

"I am decidedly opposed to prohibition as a means or preventing intemperence, it does not prohibit. Experience has shown in those States where prohibition has been tried that it is not an effective means of preventing the vice of drinking. There are many ways of evading the laws, and often the law officers connive at the evasions. Prohibition is to be discouraged also because it confronts the drunkard with those who use liquor fronts the drunkard with those who use inquor in moderation, making out a sin where there is no sin. The only places where prohibition might be enforced are thickly settled country districts.

I am very strongly in favor of high license as a means of checking intemperence. I regard high a means or onecking intemperence. I regard high license, with moral sanction, as the most efficient way of diminishing the drinking vice. In order to make high license effectual only a limited number of licenses should be issued for each ward, and they should be given only to persons of good reputation, men who stand before the community moral and unright and owners of reconstruction. moral and upright, and owners of property.

The licenses should be accompanied with strict legislation, and the violation of laws respecting these license should be severely punished. Among the punishments should be the withdrawal of li cense, never to be restored to the one who violates

I am in favor of a severe police Sunday law pro hibiting the sale of liquors on Sunday, and would have the law rigidly enforced. The saloon keepers in Baltimore say that they sell more liquor on Sunday than any other day. This is a crying shame, and somebody is responsible for that state of things.— The keeping of taverns and saloons open on Sundays leads to many bad consequences. The man who frequents the saloon is not likely to attend church, nor is he in a condition to worship. Drunkenness, whilst always sinful, is an aggravated crime when committed on Sunday. It is scandalous, and leads to the violation of other laws. More crime can be traced to intemperance than to any other source.—
It is useless to make the most stringent laws for the observance of Sunday and the prevention of the sale of liquors on that day unless the police are brought to enforce those laws. The i

lifference shown the Sunday laws and the neglect

to enforce them bring those laws into contempt,-Either enforce Sunday laws or take the liquor censes away."
