THE JOHNSTOWN LOSSES. Careful Estimates Now Place the Total Eight Millions.

This is not the owners' loss, but a very conservative estimate placed upon all losses by the board. In determining these losses allowances has been made for property that has been saved, hence this is an estimate only of total loss. The following are Secretary Davies'

figures: The aggregate of the local committee's estimates of loss in classes 1, 2, 3, 4 and 5 is \$4,-791.747. The total number of cases in these classes is 3,364. The average loss, therefore, is \$1,424. The total loss in class 6 is \$1,-112,192; number of cases, 445; average loss

The aggregate loss of borough property, all the boroughs having reported, is \$168,180.— The damage to school property reported from seven school districts is \$52,132. The fire companies, six in number, report a loss of \$37,151. Losses of private corporations so far reported amount to \$1,731,662.

The total loss reported to date, including individual losses and the losses of boroughs, schools, private corporations and fire companies is \$7,893,064. Up to to-day blanks to the number of 491 have been filled, in addition to those acted upon for future action of the board and local committees. Assuming that the average loss in these cases will be equal to the average loss in the cases already passed upon, viz., \$1,550, there should be added to the total stated above \$761, 050, making a grand total of \$8,665,114.

QUEEN VICTORIA'S INCOME. -- As for the money paid now to the royal family, it amounts to £543,000 a year, as the last official finance accounts show. Out of this £385,000 is paid the queen for the expenses and salaries of her household, retired allowances, bounties, alms, special services, &c. For Her Majesty's privy purse \$60,000 is allotted. In addition to this she receives from the Duchy of Lancaster about \$45,000 a year. Out of these revenues it is alleged, as a grievance, that Her Majesty has made large savings, and that she is immensely rich. This is very doubtful, but supposing it to be true, is there any shame in the sovereign living within the means provided by Parliament? It is at least a totally new phenomenon. In former reigns Parliaments have frequently been called upon to pay the debts of the monarch or of his heir presumptive. No such chaims have been made during the present reign.
