All the York Turnpike authorities care for is, that the bed of the turnpike shall be cleared of the five trestles that now stand in it. The turnpike authorities have o power to cause the railroad company to arect an iron bridge. It appears that an agreement had been made between the heirs and certain lawyers that the counsel were to receive one third of the estate re-covered for the heirs. Rufus Gill; the Snow Hill Farm, for \$10,500, to Mr. John C. Bosley: the Snowden Farm, for \$7,344, to Mr. James C. Wolf. The sales ggregated something in the neighborhood of \$28, 844, which was less than the amount named in the agreement by \$11,156.
