> Mr. Cox was a native of Ohio, having been born at Xenia, September 30th, 1824, and was, consequently, 65 years old. He had revolutionary blood in his voins. His grandfather, General James Cox, of Monmouth, N. J., where Mollie Pitcher fought in her husband's place, was a soldier of the Revolution and took part in the battles of Brandywine, Germantown and Monmouth. General Cox was a friend of Thomas Jefferson and served in Congress during his administration, dying, however, before the term was completed. Mr. Cox's mother was the daughter of Samuel Sullivan, State Treasurer of Ohio in 1818, a man of high character in all the relations of life. He was educated at the Ohio University and Brown University. Rhode Island, and graduated in 1846, and made Cincinnati his starting point in life. In 1853 he was editor of the Chio Statesman at Columbus. President Pierce appointed him Secretary of Legation at Lima, Peru, from which he re-

signed on account of ill health. He was first elected to Congress from the Licking District in 1857, and was three times re-elected. In Congress in 1868, and has remained a member of the House ever since, with the exception of 1872, when he was defeated for Congressmanat-Large. Hon. Jas. A severe wind-storm accompanied by rain has prevailed in this vicinity all day. > was a foot deep. . LET THE FARMERS CHEER UP. The farmers in Maryland, as well as other States, have cause to be discouraged over the record of the season now drawing to a close. It has been almost unprecedented in its l badness, and very few of the crops have come near the average, and on some farms the damages done by the storms in the spring and early vegetables suffered as much as the grain, and it is no wonder there is wide discouragement among agriculturists, and in some places there have been suffering and absolute want. But no one knows or should know the ways of nature better than the man that tills the soil .--The land that has borne good crops will bear good crops again; the barns that have been filled with ripened grain, will be filled till it would seem their very sides would burst. The winter may compel some Maryland farmers to squeeze and pinch a little, to economize here and there, to stop up this leak and that, but with another spring will come brighter pros-

pects for better season than this has been. Nature, like history, sometimes repeats herself, but a season like the present is more than likely to be followed by one of unusual crops. BALTIMONE, September 13th, 1889. It has been alleged against Americans, as a people, that they do not take holidays enough, and indulge in a sufficient amount of merry-making. But besides the fact that we are always ready for a good joke, and are given to the practice of taking lots of fun in small doses as we proceed along through the every-day duties of life, the great centennial performances in which we have been engaged during the hast dozen years, show a marked improvement in us as a people in this respect; while our numerous State Expositions in the north and the south, the east and the west, prove that the taste for festivities is one that is fast growing And we are quite justified in boasting that

n this progress along the feative line Baltimore has had a prominent place in the van of the procession. It is the custom to flout us with being conservative, and slow, to accuse us being behind the times, and all the rest of it but look back at our Sesqui-centennial celebration, if you please; and consider the gorgeousness of our Orioles, which even reached the point of over-doing in the excess of our zeal. And then, if you gazed for four mortal hours on last Monday's grand civic parade, it will begin to dawn upon you, if it never did before, that Baltimore is a master-hand at the business of getting up spectacular festivities, and is the champion producer of gay holiday times.
