these theories is correct, or indeed whether the proprietor of the storm brewery had any particular purpose to subserve in the production of such a vintage of inclemency. There has been so much said lately against our old established faith in the officacy of the equinoctial season in producing stormy weather, that it would seem as though the immortal weather makers had exerted themselves in an especial manner, at this time, to sustain their ancient reputation. The terrible emphasis with which they have thundered their answer all along our Atlantic coast, just at the exact season to refute this meteorological heresy, certainly lends it weight to this supposition. And it is well for neople to stop formulating such unorthodox heories, if they are to be refuted in a manner

so appallingly expensive. The Signal Service Bureau, therefore, would ct wisely in ceasing to meddle with theories with regard to the causes of weather. If it would confine its attention to the occurrence of facts, so as to be able to predict the storms which are going to come, and give people warntime to provide for them, it would render a much more signal service to the community for whose benefit that institution is superate Army, and with them he meekly shared posed to exist. It does not do anything of the kind, however, when the worst of our storms are coming upon us. If it did its full duty it ought to contrive some device by which we might escape such calamities as those which, in these days, are continually taking place; but failing in this, it ought at least to provide danger signals before an emergency; for anybody can tell us all about such events after they have happened.

But it lets blizzards swoop down upon us, and raging waves ravage our shores, and it makes a practice of allowing us to get up our great popuar demonstrations in the very worst sort of weather that could be contrived for them, with no more conscience than if it had an actual inerest in the destruction of life and property In view of all which facts it is certainly pertinent to inquire of what use or value the Signal Service is to us, at any rate. It really seems to be scarcely worth while to indulge ourselves in maintaining so expensive an institution for the mere and simple purpose of proving our ability to establish a signal failure. Yet in spite of the combination of the weather
