In the performance of the duties of this office now by appointment of the Governor and hereafter by the choice of the people, I will know neither isons, politics, nor partizanship; but to the best of my skill and judgment, diligently and faithfully, without partiality or prejudice, execute the office according to the Constitution and laws of the State. There is one matter to which I desire, for the inormation of the people, to make a special allusion t has been charged that the Public Schools of this ounty would be endangered by my election to the ludgeship. I declare to the people of Baltimore county with all the energy and earnestness of which I am capable that a more senseless, shame less and reckless falsehood never was uttered. Does

any man, for an instant, suppose that Gov. Jackson would appoint a man to a public office who would use his official power to destroy or hamper the pubic schools of this county? The men who are urging this charge know full well that it would not be in the power of a single Judge to destroy, hamper, endanger, impair, or in any way interfere with the public schools. No Judge would desire to do so, and none would have the power to do so. The law imposes upon the Judges the duty of appointing the School Board. To appoint the School Board requires the joint action of a majority of the Judges and to charge that I could, as a Judge, affect injuri riously the public schools of this county is to make a charge that is as senscless as it is malicious. I would have no more power as a Judge of this Court to appoint a school Board, or even a single

member thereof, than any member of this Convenvention would have to do so. The very utmost that I could do would be to participate with one or both of the other Judges, both of whom are the known friends of the public schools, in making the ap pointment of the School Commissioners. So much as to the folly and transparent insincerity and dishonesty of this charge; besides, my fellow-citizens, I would, as a Judge of our Court, consider myself bound by every obligation, human and divine, to strengthen and foster and encourage the public schools of our county by aiding in the appointment of men as School Commissioners who are known and recognized as the sincere friends of public education, and who would consider it a pleasure as well as a duty to sustain and foster the public schools. With this statement of my position upon the only material question in regard to which a persistent effort has been made to excite prejudice and deceive. I confidently submit the question of my election to the honest, fair-minded and intelligen voters of this Judicial Circuit. The Covenntion then on motion was adjourned

dent, sends the following for the local columns of the Journal: A very fine and at the same time an nteresting window ornament for the winter, when all without is cold and bleak, can be made in the following simple manner: Get a good-sized fish bowl, or any glass vessel which has a large top, and fill it full of clean, clear water. Now get a piece of raw cotton and cut out a piece the size of the bowl, about one-half inch thick, lay this on the water and press the edges carefully around the rim of the and press the edges carefully around the rim of the vessel (the cotton will, in a few days, become firmly attached to the glass and will not sink.) After having done this as directed, get some flax seed and mustard seed and carefully sprinkle them evenly over the cotton, but not too thickly. Next take the bowl and place it in a warm, dark cupboard, where you are to leave it undisturbed for three days, at the expiration of which time when you take it out you will have in place of the dry seed a beautiful green foliage on top of the cotton, and in the water you will find a mass of beautiful roots as white as snow, which, if left alone, will completely fill the snow, which, if left alone, will completely fill the bowl. As the water in the vessel evaporates it should be replenished in the following manner: Gently loosen the cotton from the glass with the handle of a spoon or some other suitable instrument, just enough so that you can insert syringe or small teaspoon, and, with one or the other, fill up to the top with older, water, 'Other' saids can be grown besides those mentioned above, such as sunflower, corn, oats, etc., and in fact singlet any small.

OBITUARY. Cql, William Allan.

On Tuesday, 17th inst., Col. William Allan, in the 52d year of his age, died at the McDonogh Farm School, on the Western Maryland Railroad, near Owings Mills. The Baltimore Sun gives the following synopsis of his life and work:

Col. Allan was born of Scotch parents at Winchester Gardens near Winchester Weight School ter Gardens, near Winchester Va., in 1837. There he attended private school. He was not allowed to engage in mercantile pursuits on acctunt of his deli-cate health. He was a bright boy, and at the age of sixteen years he began teaching school in his native town and in Jefferson county. As his father was poor he sought in this way to raise money for college expenses. In 1857, at the age of 20, he entered the University of Virginia, where he took a high stand. He won the debater's medal, an enviable distinction, and when he was graduated in 1859 he was spoken of as one of the University's shiest students. ablest aludents.

After leaving the University he accepted a posi-tion as assistant to W. Le Roy Brown, now Presi-dent of the University of Alabama, but then the principal of Bloomfield Academy, Loudoun county, Va. He remained there until the war broke out when he volunteered his survice for the Confederacy. His first military appointment was that of aid to Major Harman, Stonewall Jackson's chief quartermaster. The excellent organization of this ervice was largely due to the administrative talent of Mr. Allan.
In December, 1862, in the competitive examination for the ordinance service, he won the highest rank, that of Captain of Ordnance. He was then rank, that of Captain of Ordnance. He was then assigned to duty on Jackson's staff as ordnance officer of that General's division. During the last two years of the war he served as ordnance officer of the famous second corps of the Army of Northern Virginia under Jackson and Early, and attained the rank of Lieutenant-Colonel. His duties were of the most responsible and difficult character. It was his business to furnish his corps with arms and ammunition, and as the resources of the Con-

ammunition, and as the resources of the Confederacy lessened his task required the highest ability. He exhibited great talent for organization and administration, and won the regard of both Jackson and Lee. He was an active participant in the great battles of Sharpsburg, Fredericksbug. Chancellorsville and Gettysburg, and he served with distinction until the surrender at Appomattox. After the war Colonel Allan went to Staunton, Va., and became cashior in the surrender of the control of the Assignment of Morigages.
