WASHINGTON, October 10th, 1899. Ex-Postmaster General Hatton has created a sensation by printing in his paper the time, place, and even the price, for which a list of the questions to be asked at an examination held in this city by the Civil Service Commission was furnished to a party here. The list was sold by an employe of the commission, who is a brother-in-law of Commissioner Lyman, and to clinch matters he has printed a letter from ex-Commissioner Edgerton to President Harrison, written last April, containing the same charge.
