School for Nurses, which will form one of the departments of the Johns Hopkins Hospital .-This institution is intended by the hospital authorities to give a practical and scientific training of two years to such women as desire to learn the most efficient manner of taking care of the sick. It has been placed under the superintendence of Miss Hampton, a trained nurse from Chicago, who has several well-qualifor training must be between twenty-three and | Baltimore county. thirty-five years of age; must bring testimonials as to character and physical ability; and must undergo an examination as to the foundamentals of an English education. The persons who are accepted as pupils will, after serving for a month on probation, spend the first year as assistants in the hospital wards. with an allowance of eight dollars per month, each. During the second year they will be required to perform duty either in the hospital or at the homes of private persons, or as district nurse among the poor, and will receive the sum of twelve dollars a month. And while on duty they will wear the uniform of the institution, which is simple dress of pale blue gingham, with white apron and cap, and linen collar and cuffs. They will also receive a course of instructions under physicians and nurses, which will comprise lectures, recitations, demonstrations, examinations, &c. And when the term of two years has been completed, satisfactorily, the pupils so trained will receive diplomas, and can then choose for themselves the field in which to work; though they

will be expected to make annual reports of their labors to the School authorities for a few years. A large separate building, handsomely appointed, is set apart, on the Hospital premises. for the home of these nurses, so that when not on duty they can have bright and pleasant surroundings, and enjoying rest and recreation in a cheerful atmosphere; with parlor, library, ewing-room, and kitchen in which they may find diversion, and due exercise for their various energies.
