4 Beautiful Reredos .- On the 1st inst. a beautiful new reredor of Numidian marble and Vene tian mosaic was unveiled in St. Timothy's P. E. Church, Catonsville. It is a thank-offering from one of the members of the church for many mercies during the past half century. This work of art is a durable and permanent substitute for the wood panel that extended along the east wall of "chancel." The "Mosaic" over the altar represents our Lord seated on a throne, holding in His left hand a globe and having the right hand raised in blessing. There are four adoring angels at the four corners of the panel. Standing above this central group and directly over two narrow panels of Mexcan onyx are two emblematic figures of adoration and praise carved in stone, with wings stretched upward. On a lower level, and on either side of the altar are the four archangels—Gabriel, Michael, Hriel and Raphael. All these nine figures are on a gold background, full of life and character and action, in quiet colors, and thoroughly devotional ir feeling. The reredos was designed by Mr. Stent. o. New York. The cartoons were drawn and painted by Heming, of London, England. The marble is from Theis & Janssen, New York. The mosaic from the Muran Company, of Venice, Italy. The statues were carved by Sibbel, of New York.

Principal of the McDonogh Farm School .-Prof. D. C. Lyle, who was recently elected Principal of the McDonogh Farm School by the Board of rustees to fill the vacancy occasioned by the late lamented Col. Wm. Allan, is a Virginian by birth, a native of Rockbridge county. He was graduated from Washington College, now Washington and Lee University, in 1869, and the next year appointed Assistant Professor of Mathematics in that Institution. He remained there, in that capacity, for one year, when he went to Richmond and was made Secretary to the Board of Public Education of the State of Virginia. A year later he resigned and went to Germany to prosecute his studies in the German language. Upon his return to this country, Col. Allan, lately made Principal of McDonogh, ap pointed him Instructor in Mathematics and Ger man. From then until now he has been working side by side with Col. Allan. His acceptance of the Principalship of McDonogh gives the alumni and friends of the school sincere pleasure.

OBITUARY. Rev. Dr. Libertus Van Bokkelen. On Sunday last, 3d inst., the Rev. Dr. Libertus Van Bokkelen, aged 74 years, who conducted St. Timothy's School in the ante bellum days, was found dead in his bed at Buffalo N. Y. His death was attributed to heart disease. The deceased was at one time State Superintend ent of Public Instruction in Maryland; was also the Rector of St. Timothy's P. E. Church at Catons-

He was born in the city of New York. His paternal grandfather, a physician, came from Holland in 1796, being exiled by the French government because of his adherence to the Prince of Orange .-He brought with him two sons, the youngest whom, the father of the gentleman who just died, was educated in New York as a merchant. The maternal grandfather of Rev. L. Van Bokkelen was a native of Wales. From the age of nine the Doctor was educated at boarding school on Long Island, and up to the year 1864, when he was commissioned Superintendent of Public Instruction here, he had never lived outside of a school or college, having been previous to that time either a pupil, tutor, professor or principal. When 22 years of age he established St. Paul's School, at College Point, L. I., which afterward became the preparaory school of St. Paul's College. In 1842 he took holy orders in the Protestant Episcopal Church, and had ever since combined the duties of the ministry with educational work. In 1845 he founded at Catonsville, Md., the institution which, as St. Timothy's Hail, became well known through the Southern States. Beginning | with nothing it achieved success. The buildings were extensive, accommodating one hundred and fifty students. The corriculum of this school included physical education, for which a gymnasium under skilled teachers was provided. The students were organized as an infantry battallion and artillery corps, for which muskets and cannons with equipments were furnished by the State.

While conducting St. Timothy's Hall, Dr. Van Bokkelen was elected President of St. John's College, Annapolis, and of the Agricultural School near Bladensburg. He was also invited to the charge of colleges in Tennessee and Missouri, and to establish a school in California, but declined them all. In addition to his ministerial work in St. Timothy's Church, he had charge for a while of Clark, and Messrs. Hugh Jenkins, Edward Wyatt,

Grace Church, at Elkridge Landing. In these duties he was assisted by the clerical professors at St. Timothy's Hall. This institution was at the height of its prosperity in 1861, and plans were made for extending the buildings, but the war frustrated the effort, and Dr. Van Bokkelen suffered very heavy pecuniary loss. From 1859 to 1865 he served as School Commissioner for the 1st District of Baltimore county. During these years he made the school system a subject

Mrs. Wm. Thode, a daughter, liver in Baltimore. N. B. Royston. Mr. N. Bowen Royston, aged 68 years, died sud' denly at Glyndon from an attack of Bright's disease. The deceased entered the employ of his uncle Joshna Royston, in Baltimore, in 1836. At the age o 21 he was given an interest in the business, and after the retirment of Mr. Joshua Royston the firm was know as N. B. Royston & Bros. Two years ago Mr. Royston, after fifty years spent in active business pursuits, retired, and about a month ago removed to Glyndon. He was for a long time a member of Grace M. E. Church. His wife and four sons survive him.

Han Cholera vs. Charcoul -- An Almost Sure Cure for the Disease.-For pigs and fattening hogs give anthracite coal every few days. If this cannot be had, get Cumberland coal, and the next best is charcoal. These coals are one of the best correctives for a disordered system, and in a number of cases experimented on by several large feeders of pigs as well as ourselves, we have found that anthracite especially will stop the spread of cholera, even when it has gotten into the herd. Some years ago we lost some eighteen large fattening pigs, and by using anthracite freely the disease was stopped. Our pigs and sows have now the run of the woods, where they have free range and a variety of food, yet we feed coal freely, especially charcoal. We burn charcoal ourselves. It is a very easy matter to keep a quantity on hand.— Make a good fire, and after it burns freely smother it with sods and a little water poured over it, and a large pile of wood can be had. Use it freely. The approach of cholers can usually be noticed by the appearance of large red spots gradually turning into running sores back of the ears. Remove such animal from the rest, give small quantities of laxative food, and feed coal freely to the sick, as well as to the healthy animals. Those having the disease badly cannot be cured, and had better be at once killed and burnt. A real cholera-sick hog cannot be sold for meat without detection in the open market, as the appearance of the animal is against and none would risk buying such meat. If sold a all, it would be by stealth, and then made up into sausage. Pigs should have a wood range, and access to pure water, and cholera would be rare,— Filth, impure water and exposure to intense heat during the summer will usually inocculate the ani-

mals with the disease germs which will cause the disease to manifest itself in the early fall. Had the large sums of money spent by our government for a number of years in trying to eradicate this discase been used in enforcing health laws for the proper feeding and caring for these animals, some good might have been accomplished. As it is, we have hundreds of expensive agricultural books published, with queer microscopic drawings, which be wilder the reader and confuse his ideas-and de little, if any, good.
