[Wm. E. A. Axon in The Academy. Catonsville News.-St. Mark's Catholic Church at Catonsville was dedicated on Sunday last, 9th inst., James Cardinal Gibbons, Archbishop of Baltimore, officiating. The ecclesiastical student from the Redemptorist College at lichester marched in procession around the church. A grand high mass was celebrated. The paster of the church, Rev. Fr. John E. Dunn, was the celebrant, with Rev. Geo. W. Devine, of St. John's Church Ballimore, and Rev. Mark Moeslein, of the Passion ist Monastery, as deacon and sub-deacon, respect ively. The deacons of honor to the Cardinal were Rev. Michael Holaus and Mr. Thos. Hanley, of the Redemptorist College, Ilchester. Rev. John Hausser, of Ilchester, was master of ceremonies. The sermon was by Cardinal Gibbons. The music of the mass was rendered by the choir under the di-rection of Mrs. Clara McDonald, and Miss Vanlill was organist. The soloists were Misses Kate Cummings, May Walter; Misses Van!ill and Linhardt, sopranos; Misses Jenny Mahoney, Annie Schleup-ler, Louise Schleupler, Tip and Lawson, altos; Messrs. George Roseman and James McDonald tenors, and James E. Farrell, John Cummings. Philip Gerry, Harry Vanlill and Andrew Schleuper, bassos. A number of uniformed societies from Baltimore were present. The new church is a substantial granite structure, with red brick trimmings, and is of Gothle architecture, with a frontage or 40 feet and a depth of 90 feet. It is on Melvin avenue, about 200 yards from the Frederick pike, and is surrounded by a handsome lawn. I is lighted by fifteen oval stained-glass windowssix on each side and three in front, while in the rear, over the sanctuary, are three windows .-There are forty double pews of ash, with walnut trimmings, which will seat nearly five hundred persons. A spacious choir gallery is over the main entrance to the church, with two confessionals be neath it. The walls of the church are adorned with a number of handsome pictures illustrating the passion of the Saviour. The corner stone of the church was laid October 7th, 1888, and during the great gale of December of the same year the walls, which were nearly completed, were blown down. This principle should have its full force where the settlement is evidenced by so formal and solemn an instrument as a mortgage. The presumption of the law is that consideration set out in mortgage represents the actual amount due, but if the plaintiff can satisfy the Court that fraud was practiced in the obtention of the mortgage or in the statement of the amount of the consi leration, or that a mistake was made in relation to the amount of the indebtedness stated to be due, t would be the obvious duty of the Court to open the settlement, and that a correct account be made between the parties.
