THE ROAD QUESTION.

A Meeting of Tax-payers Called. Messrs. C. Lyon Rogers and Washington Stevenson, on behalf of the Granges in Baltimore county, and Senator James J. Lindsay and Mr. Edward N. Rich, member elect of the House of Delegates, had a conference with the Board of County Commissioners, on the 17th inst., in relation to a public meeting of the tax payers of Baltimore county, to be held at the Court House, on Monday, 30th inst., at 12 o'clock M. to take into consideration the best and most practical means for the improvement of the road system of the county. It is to be hoped that there will be a large attendance of all persons interested. and that a full expression may be had on the subject in order that the best and most effective means may be used for the improvement of the roads in

every section of the county. The County Commissioners expressed a willingness to do everything in their power to further and aid the road question, and the county representatives in the state Legislature are desirous of doing all in their power to aid the tax-payers in order to insure a good and economic system for improvement of the county roads. The representatives of the different Granges are

desirous of having a full attendance at the meeting in order that the farmers, who are the people most interested, shall declare their views and keep the road improvements within the bounds of the capacity to stand such a road tax as the necessities of the case require. It is to be hoped, therefore, that all persons who are in the least interested will attend the meeting to be held at the Court House on Monday, 30th inst., at 12 o'clock. Views From "A. B. C."-A gentleman, in Bal-

timore, "A. B. C.," who has paid some attention to road making and who is acquainted with method in England says that the roads may be made good at a slight expense, as follows: First, drain properly; second, you must give hill side regular per centage in down grade; third, make the bed of the road higher in the centre so that water will drain off both ways from the centre, the ditch on both sides to be 18 inches deep, 30 inches wide and at least 16 inches wide at the bottom, all soil to be thrown outside for a pathway, when the bed is made smooth put on 6 inches of broken stone or good rough gravel. When the road is finished keep some one to fill or repair wheel tracks that may be made after one season. The county road beds of England are treated in this manner and they are just as firm as the streets of Baltimore.

> Gen. Alex. D. Brown Files a Motion to Strike Out Judgment .- Mr. Bernard Carter, as counsel for Gen. Alex. D. Brown, on the 14th inst. filed a motion in the Circuit Court for Baltimore county to strike out a judgment for \$6,938.75, ob tained by default against him by his wife, Laura J. Brown, and Charles Bosley, Sr. The action in which judgment against Mr. Brown was entered was based on an agreement between him and his wife and Bosley (her uncle.) dated Brown promised to return to the home of her husband she had temporarily left on account, as alleged, of cruel treatment, and he on his part agreed to pay her the sum of three thousand dollars a year in monthly payments. The condition by which the principals to the agreement mutually bound themselves were that he should "henceforth treat her with the kindness and affection due from a husband to his wife, and refrain from all crue treatment and improper conduct towards her," she agreeing that she would "in all respects, as heretofore, conduct herself as a faithful and devoted wife." The reasons given for striking out the judgment are that it was obtained by surprise, the plaintiff and his counsel, Messrs. Bernard Carter and A. W. Machen, being under the impression that the case term, instead of the trial docket; because the payment of the money mentioned in the agreement of January 9th, 1884, is conditional upon the said Laura J. Brown continuing to live with him as his wife, and conducting herself as agreed upon; that at the time of the institution of the suit there were and still are pending divorce proceedings, ommenced June 6th, 1887, in which testimony has

been taken by both parties; that upon the true construction of the agreement already referred to the money therein stipulated to be paid is only payable while the parties continue to live together as husband and wife, unless she should, for sufficient cause, of her own accord leave her husband and re-fuse to live with him, which state of facts, the defendant says, has not occurred; that during the pendency of the suit for divorce he has been reguarly paying his wife two hundred dollars a month for alimony, and has further paid five hundred dollars to her solicitors as counsel fees, which payments, he claims, are in lieu of any rights on her part to demand, payment of the sums mentioned in he agreement: that before the institution of the ivorce suit, and when the same was in conteinolation, Charles Bosley, Sr., one of the plaintiffs the judgment suit and a party to the agreement of January 9th, 1884, strenuously advised Alexanler D. Brown to institute divorce proceedings against his wife, and that as he (Bosley) was the person by whom such a claim must be legally made, f made at all, he would never consent to be a party to any suit for that purpose; upon the faith of which assurance divorce proceedings were institu-
