They Should Have It.—It is nothing more than an act of sheer justice that the "Belt" firemen who were taken from Baltimore county and added to the Baltimore City Fire Department, should receive the same salaries as the rest of the members of the city department. They are subjected to the same rules, and they are obliged to answer 212 city boxes and 27 Annex boxes. It is a tremendous increase of duty, for which they now receive only what the county paid them. The police, lamplighters and garbagemen receive city salaries, why not the firemen, the most important of all? It is quite likely the Councils will grant the increase.

After the York Road and Other Suburban Railways.—We learn that a bill will be passed in the Legislature to provide that the York Road, the Catonsville and other suburban railways, will not be allowed to collect a greater fare than 5 cents upon their lines anywhere within the city limits. present these railways continue to collect the old rates of fare over territory last year taken in by the "Belt" bill. So it may be likely those who use the York Road Railway will be enabled to travel from the station on Holliday street to the new city limits for 5 cents; and vice versa.

Death of a Remarkable Woman -Mrs. Catho ne Burke, a native of county Tipperary. Ireland died on the 10th inst., at the residence of her daugh ter, Mrs John C. Shannahan, near Reckord, Balti more county, having attained the age of 106 or 107 years. She came to this country 37 years ago, a widow with five children. The venerable lady was wont to boast that she never had a day's sickness and never took a dose of medicine from a physician in her life. She eschewed sweetmeats and tomatoes, her favorite diet being meat, cabbage and po tatoes, and of these she partook sparingly. Her mind, memory and eyesight were unimpaired unti' the day of her death, but her hearing had become somewhat imperfect. She was of medium height trongly built, was very active and had a clear complexion, her face being unclouded by wrinkles. She was only confined to her bed for two or three weeks. Previous to that time she occupied herself with sewing and knitting, never using lasses, and assisting in household work. Up to a ew years ago, when over a hundred years old, she requently walked five miles and back to St. John's Catholic Church, Long Green, of which she was a Before she took to her bed her stories of the Irish

rebellion of 1798 were a source of unfailing interest o her relatives and visitors. "Grandmother Burke" was noted as a nurse far and wide. About five years ago Mrs. Burke accidentally fell down a long flight f stairs and broke one or two of her ribs besides having several teeth knocked out. He recovered very soon and some time afterward accidentally fell from a porch, a distance of three feet, alightin on her head on a stone walk. It was then in very bad condition-mud oles, stone piles, &c. By the honest work of a Supervisor it was gradually gotten into good condition and was better generally than the turnpikes.— Through some *political* exigency, about the time the whole road was in *good* order, it was taken from my neighbor and given to some one else. Having noved away from that point I do not know whether t has been kept up or not, but if all the roads in the county had been worked as faithfully as the one question there would be no clamor about roads. Items from Upper Falls—The remarkably fine weather so far this winter has enabled the farmers to do much work that under other circum stances they have much difficulty in doing in the spring time. Many of the farmers have completed most of the spring work, such as plowing, fencing, hauling, &c. The mild weather, no doubt, makes times dull, but it is a benefit to farmers, as they can lo considerable work now free of cost which would e expensive to them in spring time. The people are somewhat alarmed about the ice crop, but there is plenty of time yet for ice, and just now the cold spell gives us good encouragement in The discussion of the road question still

tinues, and it is certainly hoped that some good will come out of it. Considering the amount of money appropriated for the improvement of our roads we must admit that they are in fair condi-tion; yet they are far from being what the majority of the people would like them to be. It was truthfully uttered by our public spirited citizen, Mr. Fred. Raphael, when he said at the road meeting held at Towson on the 31st of December last, "the the amount of money levied for the roads was not enough to keep the ditches cleaned out, ' &c., but when this same gentleman at the road meeting held at Towson on the 13th inst. said, "that if the money appropriated for the roads was judiciously expend ed, that is, it good Road Supervisors were appointed and the matter taken out of the hands of the politicians, the present amount appropriated would be sufficient to give us good roads." Now I would like for Mr. Raphael to answer this question; Where is the consistency between his remarks as made at the first meeting held at Towson and his remarks made at the second meeting held at Towson? Mr. Raphael is a staunch believer in the road machine, for what reason I cannot s.y, unless it is because the machine does not vote. He contends that the road machine should be used because, says he, i will do as much work in one day as afty men will lo. Now if this statement be correct the county pays \$500 for work that should be done for \$56. For example: If the road machine can do as muc work in one day as 50 men can do, the \$500 allowed for the roads in this portion of the District is just equal to 400 days work for one man at \$1 25 per day. And if the muchine can do the work of 400 men in 8 days, and if we allow \$7 per day for six horses, host of friends by his jovial manners. and wo men and the machine it would require a days' work of the machine at \$7 per day to do the work. Now, in my mind it is very doubtful that this road machine can do the work for \$56 that the county now pays \$500 for, but if this statement be true the county money (as Mr. Raphael says) is not judiciously expended, and the County Commissioners should secure Mr. Raphael's assistance at any cost in using the road machine. In conclusion of this road question I desire to say a word or two in behalf of our Road Supervisor, who is quoted by Mr. Kaphael as s ying the damn road machine s no good.
