STH DISCRICT, May 8th, 1890. Dear Journal: Since the 4th and 5th have assumed a historical attitude in regard to Districts. I thought it proper to tell you something of the 8th, and will begin by saying something of old "Gillford."
Here is the seat, the home and the origin of the Gills, of whom it may be said are more numerous and active than the gilly fish of both Piney and the Gill Runs, with the Western Run added. It is jokingly said that when Noah's ark lodged on the beautiful an mmit of "Belleview" that his fishing view had such luck in these waters that they made this spot a permanent settlement and hence called them-"Gillford" the home of the Gills for the nest handred years and late y occupied by the learned Dr. Gill, is located on the Western Run right in the heart of the Western Rup Valley, and i shrine of the apple of the eye of all the Gilis and the Gill's possessions. So much is it revered by these same Gills that they propose to monument it by a place of worship—a pretty chapel—and call i "Gilkirk," Bordering on the northwest lies the beautiful home and lands of Mr. George Gill, and is called "Gill's Repose."
