SENATOR GORMAN AND THE TARIFF Senator Gorman, on Tuesday 29th waked up the Republican Senators as they have not been waked up for some time upon that interminable question, the tariff. The question before the Senate was the proposed change of the duty on chromic acid from 15 per centum ad valorem to a specific duty of 6 cents per pound. The report of the speech we take from the

Baltimore Sun: The Senator called upon the members of the Finance Committee, and particularly Senator Aldrich, in charge of the bill, to state the necessity of the proposed change. He then proceeded to arraign the Republican party for its course on the Tariff ques-tion, and charged that the pending bill was framed in the interest of the manufacturers, and probably or the purpose of paying off party obligations in curred in the last national campaign.

The hot shot poured in upon the Republicans was not wasted upon empty seats, as nearly every Senator was present, especially the big guns of the ma-jority, Messrs. Sherman, Allison, Ingalis, Edmunds, Frye, Manderson, Morrill, Dawes, Stewart, Teller, oner, Aldrich and Don Cameron. Congressman Mudd, of Maryland, entered the chamber while Senator Gorman was speaking and took a seat next to Senator Sherman. He endeavored to engage the Ohio Senator in conversation, but the latter ferred to listen to the speech of the Senator from It was apparent that the Republicans did not relish the plain truths trust upon them is such a

forcible manner, and a hurried consultation resulted in the selection of Senator Aldrich to reply. Several pages were dispatched to the library to get the Record containing the tariff debate of 1885. With the permission of the Maryland Senator, Senator Aldrich called attention to the position of Senator Gorman on this question in 1883, and charged that he had moved to increase the duty on bichromate of potash from 3 to 3½ cents per pround. "Shall I tell the Senator from Maryland why he made that motion?" exclaimed Senator Aldrich, in an excited tone, while his Republican associates smiled approvingly "Certainly," said Senator Gorman. "Well," con tinued Senator Aldrich, "he favored an increase the duty on bichromate of potash because it manufactured almost exclusively in the city of Baltimore." He then read extracts from Mr. Gorman's speech made at that period in support of his proposition to increase the duty from three to three and a-half cents per pound. He charged the Democrats with attempting to draw the Republicans into general debate on the pending bill, and denied that any one had been refused a hearing before the committee during the preparation of the bill. He said the tariff has been the leading issue before the country for the past three years, and every intelligent person in the country is familiar with the question, and in view of the fact that it was fully dis cussed in 1888 and 1889, the Republican Senators do no propose to take up the time of the Senate in tryig to relieve the minority of its ignorance on a subject with which they should be familiar, having had ample facilities to acquire all the necessary knowledge. He sat down feeling quite confident that he had completely used up the Maryland Senator. Senator Gorman, however, readily explained why he had moved to increase the duty on bichromate of potash. The duty at that time was 4 cents per pound, and the bill proposed to reduce it to 3 cents. He charged that the reduction was almed directly at the city of Baltimore because it was a Southern city, while the duty on the products of New England cities, especially in the State of Rhode Island were largely increased because Senator Aldrich happened to be a member of the committee which pre pared the bill. In view of the unjust discrimination against a Maryland industry, he proposed to modify the reduction in the bill from 3 to 3% cents per pound, which was a-half cent reduction in the Senator Gorman then went on to say that it would not do for the Senator from Rhode Island and his associates to attempt to dodge the real issue by re minding him of what he may have said or done i 1883. His views of '83, like those of other sensible

men, have been somewhat modified. The situation has changed since then, and the bill is not the same which was considered by the Senate in 1888 and '89 He recalled the fact that while the Allison bill was regarded as a radical measure, the present bill championed by the Senator from Rhode Island was even more radical, which, perhaps, accounts for the change in the management of the bill. The people of the Northwest and West have spoken, and the Senator from Iowa has heard them. He then went back to the bichromate matter and said that industry is so well established, like hundreds of others, that it can afford a reduction in the existing rate, and when that point in the bill is reached he will vote for a reduction if the Senator from Rhode Island makes the motion, and if he does not do it he (Mr. Gorman) will offer an amendment to that effect, because the same rule applies to that article which applies to the factories of the State of Rhode Island and to the industries all over the land. Continuing, Mr. Gorman said; "This bill had no fair consideration. It has had none from the hour it was conceived, so that the minority might meet it in council or in a deliberative body. The doors of the committe room were closed to al men who are interested in these business enterprises." He said he knew several gentlemen from Baltimore whose business depends upon these changes who came to Washington day after day with the hope of getting a public hearing, but found the doors of the committee closed against them. To show that the Democrats are not disposed to consume an unreasonable time in debate he referred to the time consumed in the debate on the tariff bil in 1888 and 1889. "The bill," said he, "comes here without any public consideration. There were present day after day gentlemen of repute, among them a Republican, the head of his party, the Chairman of the Republican party, who came here to be heard against the outrageous increases that are in some portions of the bill. Then the Senate ordered that when you did make increases you would give the reasons for them and the effect which the increases would have, whether they would add to or take from the revenue. Yet you stand here as dumb as oysters and taunt us for asking you why you have made the increaser.

"The committee has declined to comply with the resolutions of the Senate, and it has brought forth a bill from which no living man can get any informa-tion as to what is to be the result of it. It is due to the country and every individual member of the Senate that you shall comply with the resolution introduced by Senator Plumb. "No charge of ignorance, no reminder of the advocacy of a duty on an article that happened to be manufactured in my State will deter me. 1 stand to-day precisely where I have always stood—with the Democratic party, right or wrong. I stand with it because I know that party from the foundation of the government until now has been in favor of levy ng duties sufficient for a government economically administered, and that in the levving of those duties all the protection that American industries require will be given. But this bill goes to the other treme. BALTIMORE, August 1st, 1890. All things considered, Baltimore, as well as some other favored localities, seems to have mustered up enough energy to succeed in spending a very active and industrious July. In most years things only drag along through this sultry month, and people want to throw sside their duties and cares, and escape to some unfamiliar region for a change of scene, how, though our people have gone away by thousands, and the usual July holiday season has by no means been slighted, yet it appears that we still have enough energetic spirits left to keep a number of enterprises moving along, in a rather unusual manner, for such a time. In fact, it is not easy to see how his abilities could be replaced in case anything should happen to him; and it would certainly be a mistake for even the Crescents to dispense with his services before the election of our next President. The possible consequences of the aforesaid Force bill, are, also, another subject over which

our people have recently been busy, to the extent of thinking and talking, at least. And small wonder, indeed, that it should be so, for called upon to meet. And as it is one which will have to be met, too, if the formidable bill in question should become a law, it is just as bilities, without any delay. Nobody, with eyes and a brain, watching grasping, unscrupulous party in power has none but the most selfish ends in view; and that in order to perpetuate its reign it is ready to practice upon Southern weakness indignities and outrages which it would not dare to inflict upon its stronger foes in the North or the West. But it may be wise for everybody concerned to come to a timely recognition of the fact that there is a point beyond which Southern human nature will not submit to being goaded. And if the county, as well as throughout Maryland, who threatened injustice of the Force bill is inwill be gratified with the prominence which flicted upon the South, it is quite safe to say that it will not tamely submit to the loss of self-government, but will promptly inaugurate another rebellion, of some sort, instead. It is all very well for peacolovers to deprecate the scheme of a southern boycott of northern commerce, or any other retaliatory measure. But however much any one may deplore the fact something is certainly going to be done. And, of course, somebody is going to be hurt in the scrimmage: there is no help for

that. If the South has northern friends who would be injured by a boycott, or whatever other measure of self-defense may be adopted. why let their friendliness declare itself by taking measures to neutralize the work of their own representatives, or do something to avert the evil which they profess to deplore. No amount of friendliness and simple regrets will be sufficient in this emergency. For the A. \$1,500 South itself will also deplore most heartily the Ohio R. Gordon, and the present southern uprising will lead to this very desirable result. LOCAL NEWS

Episcopal Church at Sparrew Point.—Sparrow Point can lay claim to possessing one of the handsomest of village churches in the little Protestant Episcopal Mission of St. Matthew's, which has just been occupied by the congregation. It is a frame structure built upon a stone foundation, and is of the Gothic style of architecture. It stands just on the edge of the woods on the eastern side of the town, and has a frontage of 32 feet and a depth of 00 feet. Rising from the centre of its front there f 60 feet. Rising from the centre of its front there is a tower with an elevation of 40 feet to the pinus-cle of the belfry. The bell is a gift to the church from Mr. R. H. Hummel. The interior of the edifice is a model of elegance in hardwood finish. The ceiling is of ciled pine, supported by timber trusces finished to harmonize with the general style. The pews of ciled popular have a central sisle between them. The chancel rail, the altar, lectern and readthem. The chancel rail, the altar, lectern and reading desk are all of polished quartered oak. The rector is the Rev. Joseph Fletcher, who is a native of St. Mary's county, Md., and who was assistant to Biahop Paret at Epiphany Church, Washington. He took charge of the work December 15, 1885, and has given proof of his energy. He built with his own hands the altar and other sanctuary furniture,
