Thomas Waters Gives Ball .- On the 12th inst. Mr. Bernard V. Rapid Street Travel in New York City.— The Seventh Avenue Surface Road in New York city is trying a new electric car run on the McDougall torage system. It runs easily and the mechanism is very simple. The motor weighs only 42 pounds. and has the advantage of easy application, at small expense, to the ordinary cars now in use. It is cealed under the floor, and is run by a battery of 144 cells, which develops a power of 720 volus continuously for 12 working hours. The trial trips are reported to have been very satisfactory to a number of electricians and railroad officials who witnessed the experiments.

4 Fine Freight Landing.—Mr. Walter B. Brooks, Jr., contractor, has just constructed for the Pennsylvania Steel Company, at Sparrow Point, an immense pier for the landing of iron ore from ves-sels. It was begun in April last, and cost in excess \$40,000, and is the largest pier in Baltimore. The pier is 700 feet by 100 feet wide, and has a double approach of 400 feet on either side. The superapproach of 400 feet on either side. The super-atructure is built of Georgia pine, heavily ironed and filled up with white oak fender piling. In its construction there were used 2,000 pine piles, vary-ing in length from 40 to 75 feet, 200 white oak piles 50 feet long and 1,000,000 feet of Georgia pine lum-

Dr. John T. Councilman.

Dr. John T. Councilman, of Pikesville, Balt more county, one of the most eminent physicians in Maryland, died at the Johns Hopkins Hospital, Baltimore, on Saturday, 9th inst., where he had gone for treatment, aged 75 years. The cause of death was from Bright's disease of the kidneys, from which he had suffered for some time. On the lat inst. Prof. Halstead, of the University, performed an operation, but it failed to relieve him. Dr. Wm. . Councilman, a son of Dr. Councilman, is of the nedical staff of the Johns Hopkins. Dr. Councilman graduated at Yale Colloge in the class of 1839, and in 1842 received the degree of M. D. at the Maryland University. He then established himself in practice at Friendship, Calvert county, where he remained for seven years. He removed to Pikesville, Baltimore county in 1849, where he practiced for the past forty years. In the earlier portion of his practice the field of his operations was very large, he being compelled to ride over many miles of territory to visit his patients. He was a skillful physician and his services were sought Dr. Councilman always took a deep interest in public affairs and was much interested in good public roads, as he had daily use for them, and tudied well their construction and repair.

Mrs. Resalte C. Storm. | Miss Edith Storm. The sad death of Mrs. Rosalie C. Storm and Miss Edith Storm, wife and daughter of Mr. Samuel W. Storm, who were drowned on the Sist ult. at the mouth of St. Inigoes Creek, in St. Mary county, was noticed in the Journal last week, which, as ther given, was substantially correct. There were nine others in the water with Mrs. Storm and her daughter, but they all succeeded in getting out safely ex cept Mrs. Johnson and Carroll Graham. To a reporter for the Baltimore American Mi Storm gave the following account of the accident:
"My family and myself had been at Mrs. Stevens for a week, and had been enjoying our vacation hugely. Thursday afternoon at about half past three o'clock the ladies and children started out, as was their custom, to bathe. I kissed my wife goodbye, and my last words to her were 'Be careful.'— The house is situated on a bluff perhaps several hundred feet from the shore. The ground shelves gradually downward, and it would appear, from the experience of Thursday, that the slope beneath the water is a very precipitous one. It seems that my wife and the little boy, Carroll Graham, were farthest out in the water. When the Sue passed, my wife raised both hands and waved them joyously to the passing vessel, which tooted its whistle in response. I heard the blast, but I did not know that t was sounding the death-knell of my wife. None of them were in water much above their waists, and yet the swell caused by the vessel was sufficient to lift Mrs. Storm and the little boy from their feet. Mrs. Johnson and my daughter rushed to the rescue, and were themselves carried away, as was also 3118. BLE ng at 11 o'clock A. M., and evening at 7.30 P. Shets in the Court House on Wednesday Night-County Money Missing.—On Wednes-day night, 18th inst., John Carroll, about 18 years age, who is a pretty stout young man, and who has been the night watchman at the Court House for the past 6 weeks in the absence of the regular night watchman, Mr. John.P. Murphy, who is con-fined to his home at Texas by an attack of typhoid fever, shot Detective Thomas F. Hogam, of Baltimore, who had been put into the Treasurer's Office to see if he could find out anything wrong after the hours of closing.

About half-past nine o'clock Wednesday night persons living in the vicinity of the Court House heard pistol shots, apparently in the building, and it was soon learned that young John Carroll, assistant to Mr. Stocksdale, Keeper of the Court House, and who was acting as Night Watchman, had alos Detective Hogan, of Baltimore. For some time past Treasurer Geo. W. Yellott had known that small treasurer (160. W. 1 effect that known that small sums of money were being stolen from the safe in his office, and, being unable to discover the thief, he consulted with a confidential friend, and it was determined to simploy a detective to work up the case. The city authorities detailed Detective Hogan for the duty, and on Wednesday evening he entered a large closet sitting in the Treasurer's Office from which he could watch the safe through a hole cut for that numbers. Mr. Yeliott through a hole cut for that purpose. Mr. Yeliott concealed himself in another part of the building, he and the detective having arranged signals for communication between them. When the place of concealment was fixed upon for the detective it was not supposed that he would be required to remain in long waiting, hence improper precautions for the ventilation of the officer's close quarters, and about the hour named he had to seek some from air by opening the closet door. Before that Carroll had heard him move and tried twice to open the

closel door, which was fastened by a hook inside. As soon as the detective opened the door Carroll, who was in the Commissioners' Office, fired, where upon the detective called him by name and exposed his badge, but John continued to fire. The detective then drew his pistol and threatened to kill Carroll if he did not cease firing. Carroll then made for the window in the Commissioners' Office, and as he was about to leap out fired a fourth shot, Hogan firing at the same time. All the shooting was very quick. Mr. Yellott rushed to the Treasurer's Office door as soon as the first shot was fired, but was unable to get the door open before the shooting was over. Mr. Hogan diedlaims all inten-tion of trying to do more than save his life by scar-ing off Carroll, and neither of his shots struck the Watchman. One of the four balls fired by Carroll caused's painful, but not very serious, wound in Hogan's arm. All parties are to be congratuiated that no more serious results followed the unfortunate meeting.
