Asking for a Bridge.—Messrs. R. N. Wilson, N. Rufus Gill, John G. Gill, G. D. Waters, J. M. Price, Chas, G. Wheeler and Joseph M. Fowble, Sr. have presented a petition to the County Commissioners asking for the building of a bridge over Dead Man's Run, on the road between Shawan and Mantua Mills. The matter was referred to Mr. Wm. H. Shipley, Superintendent of Bridges; Jacob D. Geist, Road Commissioner, and Mr. Goo. Jessop, a disinterested taxpayer, to examine into the matter and report to the County Commissioners.

Abatement Allowed .- Mesers. Martin and Mc-Andrews, proprietors of the Gentlemen's Driving Park at Pimlico, appeared before the County Commissioners and secured an abatement of \$1,000 levied on buildings which had been entirely removed. They had been assessed for full value on all improvements made in the park in 1887, and no allowance had been made for the assessment on the buildings that had been torn down. Their assessment was corrected and tax bills adjusted to suit. The rebate allowed for the three years was \$16.

The Safe Robbery Again Before the County Commissioners.—On Tuesday, 26th inst., Detec-tive Thomas Hogan, of Baltimore, who was shot in the arm by John Carroll in the Court House, appeared before the County Commissioners and made his statement of the occurrence as has already been published heretofore. He states distinctly and positively that Carroll fired three shots at him before he fired at Carroll, and that Carroll fired a shot at him after he (Carroll) had said he would surrender, and he then fired at Carroll to protect himself. The detective had his arm in a sling and said the wound was healing. He was accompanied by Detective Thomas Barranger. This closed the matter as far as the investigation into the robbery of

Connor, Chief Clerk and Auditor to the Commisioners, with another Clerk, to examine his books and accounts and verify the statement he made, and he would leave the matter of the appointment of the Examiners to the Board, so that they might appoint any expert accountant whom they thought iit. In regard to the matter laid before you last week as to the Keeper of the Court House, I still stand uncompromisingly upon the position then taken, and ask you to take some decided action in the Mr. Todd replied "that it looks as if that paper was prepared by a lawyer, and 1 do not think it would be right to carry out that proposition and turn down a man on whom nothing has been proven; and it looks as if this was an attempt to hold the County Commissioners responsible for the loss of the money. Mr. Yellott said: "That paper was prepared by my brother, Major John I. Yellott, simply for my own protection, and with no idea to put the County Commissioners in a hole; and so far as that paper is concerned I stand by it, making no reflection upon any one, but simply asking for adequate protection

for the money in my case. Mr. Todd said : "If we turn down Mr. Stocksdale it would look like a reflection upon his character, and I do not propose by my vote to cast any reflec tion upon him. Mr. Yellott said: "I have nothing to do with his character. I am not making any attack upon it. I think there was a dereliction of duty upon his part, and I want to guard myself against a recurrence of the same. Mr. Magruder said "that a proper and strict watch was not kept in the Court House. As a watchman it was his duty to watch the whole Court House and not one particular room. Mr. Todd said, "we had not given him any orders about watching the Court House, and therefore I do not think he is entirely to blame in the mat-

Mr Smith made a motion that the whole matter he laid over for an investigation by the Grand Jury. Mr. Magruder replied: "It is my judgment that if we do not give Mr. Yellott the protection he asks or in this matter then we become responsible, and I do not propose to become responsible for the losses that may occur in the Treasurer's Office through our neglect, and I want my vote recorded in this Mr. Yellott said: "Gentlemen, if you do not give me the protection I ask for, I shall hold you re-sponsible for future losses, and I shall proceed against you at once for the loss I have sustained."
Mr. Magruder then said: "There was another
matter brought to my attention last week, and that was that the Treasurer only took the one Commissioner into his confidence. It was merely through his friendship and because it was a matter that required secresy, and the Treasurer could not well consult the full Board without the chance of publicity in the matter, and not for any want of confldence in or respect for the other members of the Board.

Mr. Yellott said: "I went to Mr. Magruder as my personal friend, and not from any want of confidence in the other members of the Board." Mr. Magruder then said: "I call for the motion I made last Tuesday asking for the suspension of Mr. Stocksdale. I want my bondsmen to feel easy in this matter, and .I propose to do everything in this matter; and, moreover, Mr. Stocksdale in his examination had admitted that he had not been as careful as he ought to have been, and for that reamy power to relieve them of any apprehension in examination had admitted that he had not been as careful as he ought to have been, and for that reason I hall vote for his suspension."

Hyland Road Commissioner of the 9th District, appeared before the County Commissioner on the 96th inst. and reported that the Joppa Road running west from Sherwood, N. C. R. R., was in a bad condition from washes made by the recent heavy rainfalls, and i would require more money to put it in thorough re-pair than he could spare from the District Road Fund. Mr. Magruder said that he had been informed that the citizens had contributed \$850 towards put-ting this road in good condition, and that they were coming before the Commissioners to see what aid they could get from the county. Mr. Hyland was di rected to fix up the worst places, but not spend more than he could help, and then there would be all the more left to aid the citizens on putting the oad in good condition.
