Serious Accident at Mt. Washington .- On Monday morning, 29th ult., a serious and disdressng accident occurred at Mt. Washington, resulting n the death of Mr. Morris Murphy and the fatal injury of his wife. The parties were in a wagon when they attempted to cross the track at a temporary crossing just below the depot, in front of a rapidly approaching express train. The engine struck the team with terrific force, throwing the horse a considerable distance on one side of the track and killing him instantly. The wagon was thrown in a broken heap on the other side of the track. Mr. Murphy was killed instantly and Mrs. Murphy was picked up in an unconscious condition. Blood was gushing from her mouth, and although no ribs or bones were broken, it is thought that she received several severe scalp wounds and was badly bruised about the body. She was removed to the store of J. Wiedey nearby. Mr. Mur phy was mangled almost beyond recognition. The train ran on for several hundred yards before it stopped. Conductor E. M. Skiem went back to the scene of the accident and sent for Dr. H. M. Ewing, the company's physician, and Drs. M. J. Todd and I.B. Bowen. He could do nothing more at the time and came on to the city with his train. The physicians found that Mrs. Murphy had received atal injuries. Besides several severe scalp wounds. She was suffering from concussion and compression of the brain and internal injuries, although no bones were broken. The physicians also examined the dead man's body, and found that he had been literally crushed death, being covered with cuts and bruises. Nearly every large bone in his body was broken. his skull was fractured, and the remains presented a terrible appearance. Justice James Hamulton, Jr., summoned the following jury of inquest, James E. Ayers, foreman; Eli Matthews, Charles Wiedey, Albert Webber, George Gamble, James Ryan, David Ormond, John J. Roach, L. S. Arnold, Hugh Coleman, Joshua Amos and Sylvester Roach. A number of witnesses were examined, including citizens of the village and some of the trainmen. The engineer, James McClure, testified that he did not see the wagon approaching the track and was only aware of its presence when almost upon it and too late to prevent the crash. He had not been notified of the temporary crossing by the company officials. He gave the usual signals when passing the station and at

Fireman Hikes Ebaugh corroborated the above testimony, and said also that he was in the left side of the engine looking out of the window, in accordance with his prescribed duty when passing a station. Saw the team when nearly on the track and called to the engineer, but was too late to pre-Baggagemaster E. W. Graves and Brakeman David Benfer also testified, but their testimony developed nothing as they were too far away and saw nothing and knew nothing of the accident until the train to await the arrival of Conductor Skiem and several other witnesses.

The jury of inquest met again at 1 o'clock and, after listening to the testimony of Conductor Skeim and several other witnesses, gave the following verdict: "Morris Murphy's death was caused by his being struck by train No. 6, of the Northern Central Railrord. We exonerate the employees, but consider the company guilty of gross neglinence in not providing a watchman at the crossing where the accident occurred." Baltimore County Grange Meeting.—A regu-

The second question was, "What are we to understand by the single tax law proposed and advoca-ted by some, and how it will affect the interest of Mr. Sands explained the question by saying: a farmer does not get good roads, he gets nothing for his taxes. The single tax, therefore, should be

accompanied by a State Road fund similar to the Public School fund, to be made up by a uniform tax on land value, but distributed according to the number miles or roads. With good common roads. maintained by an honest system of taxation, the farmer could easily defy competition." A feeble attempt was made by several of the members to discuss the question, after which a unanimous resontion was passed expressing the Grange s dissatis-Mr. Charles T. Cockey, Lecturer of the Grange, delivered his quarterly oration. Among other things, he said: "This Grange is the American farmer's parliament of Balamore county. Death of an Ex-Confederate.—Mr. Winfield 8. Thompson, civil engineer of Baltimore, and who is well known in Baltimore county as having made the topographical survey and plats of the newly-annexed District of Baltimore, died at the residence of his pathen. of his brother, Mr. Eustis S. Thompson, at Catonsville, on Friday, 26th ult. His death was caused by Bright's disease. He was in his 58d year. Mr Thompson was born in Baltimore, and was the sor of Gen. Henry A. Thompson, who was President o the Bank of Baltimore, and was also the first President of the Loudon Park Cemetery Company. Baltimore was his birthplace. Mr. Henry S. Thompson, of Baltimore, is his brother. During the war Mr. Thompson was chief engineer in the Confederate States Navy. He served on the steamer Georgia commanded by Lieutenant Jones, in the Savannah squadron, under Commodore Tatnall; on the steamer Tuscaloosa, commanded by Captain C. H. McBlair, and he was on the Florida when she was seized in the harbor of Bahia. Captain C. Manisault Morris, now of Baltimore, was at that time ner commander. After that he was a prisoner of war for some time. Towards the end of the war he was released and went to Liverpool, where he reported for duty to Captain Morris. The war closed and he returned to the United States. Several of his brothers were in the Confederate army, and one t them was killed. For some years past Mr. Thompson has not lived in Baltimore. He was a member of the Society of the Army and Navy of the Confederate States of America in Maryland. The funeral of the deceased took place on Satur lay. The remains by his request were buried with the Confederate dead at Loudon Park Cemetery.— The services were held in St. Timothy's Church, Catonsville. Rev. Thomas W. Punnett, the Rector, officiated. E. Courtney Jenkins Dies in Richmond. -Mr. E. Courtuey Jenkins, aged 50 years, died Richmond, Va., at midnight, Sunday, 28th ult., Mr Jenkins was a native of Balto., a son of the late Ed. Jenkins and a brother of E. Jerome Jenkins. He was educated at Loyola and Georgetown Colleges and afterward engaged in business in Baltimore, being a member of the firm of Dugan & Jenkins. At the outbreak of the civil war he, with R. Curzon Hoffman, W. Stuart Symington and a number of other young men, went to Richmond and enlisted in Company B, Twenty first Virginia Infantry Volunteers, under command of Capt. J. Lyle Clark .-The company was known at "the Maryland company." During the summer of 1861 Mr. Jenkins severed connection with his regiment in the Rich Mountain campaign under Gen. Lee. He was in delicate health at the time, and broke down during that arduous campaign and went to the hospital at Staunton, Va. There he was found in a greatly reduced physical condition by Mrs. W. A. Jenkius, a warm-hearted Richmond lady, who took a deep interest in the welfare of the Confederate soldiers, especially those from Maryland. She was not a relative. Mrs. Jenkins took him to her home and nursed him back to health. Mr. Jenkins being a man of remarkable energy entered the Confede ate navy as soon as his health permitted and saw active service on the Mississippi under Captain John Wilkinson, and afterward on a blockade-runner under Commodore Lynch. He continued in that service until the close of the war. Later he was married to a North Carolina lady and took up his residence in Richmond, where he engaged usiness. During President Cleveland's adminis tration he was Assistant Postmaster at Richmond. Last spring he went with his wife to South America in the hope that the trip would benefit his failing realth. It is the duty of the Constable, Deputy Sheriffs and the regular Police Force of the county to arrest any porsons violating the game laws and take them before the nearest Justice of the Peace to be dealt with according to law.
