A Dastardly Murder.—Vernon Arnold, a white man, was found dead on the place of Mr. Martin Lynch, known as "Springfield," on the Pot Spring Road, in the 8th District, on Friday night, 31st ult. From statements made it appears that on Monday, 27th ult., while Mr. Lynch was at dinner, a white man, carrying a valise and dressed in very shabby clothes, walked up to his house and asked for work. He gave his name as Vernon Arnold, and said he had walked from Philadelphia. He had passed through Bel Air on his way, and had stopped to work for Mr. B. F. Pope, who has a place on Charles Street Avenue. Mr. Lynch asked Arnold if he could shuck corn, and Arnold said he could. He was given his dinner and put out in the field to work. work.

He was dressed so poorly when he came to the farm that he looked as if he might be a tramp. He

farm that he looked as if he might be a tramp. He was quiet, had a very mild disposition, and looked like a man who could be easily imposed upon. He worked at Mr. Lynch's out in the corn field, and seemed to be good friends with all.

Friday morning Mr. Lynch left the farm early for Baltimore with things for market. Before leaving he gave instructions to his hands about the work. Henry Smith, a colored hand, who had lived in the neighborhood for years and on Mr. Lynch's farm since last July, and who was considered by his employer as trustworthy in every way, was left in ployer as trustworthy in every way, was left in charge during Mr. Lynch's absence. About half-past seven Mr. Lynch's absence. About half-past seven Mr. Lynch returned to his farm. As he turned into his lane he saw several of his friends out in the road with lanterns, and among them were Wm. Hedrick, Mr. Price and W. H. Todd. They were leaning over the body of a man, and Mr. Lynch supposed that the man was drunk. He was about to pass on, when the party called to him to stop, come back and look at the man, who they said they had found in the road dead about 5 o'clock in the afternoon.

Mr. Lynch went back, and was very much sur-Mr. Lynch went back, and was very much surrised to find that the dead man was the man that prised to find that the dead man was the man that he had employed on Monday. He could learn nothing of the cause of the man's death. There were two bruises on his head The body was left just where it was found, and Mr. Lynch went to his house. Henry Smith, the colored man he had left in charge, was still on hand. Mr Lynch asked him if he knew anything about the death of Arnold. He expressed great surprise when he heard it, and said he knew nothing about it. Later Smith could not be found. Search was made everywhere for him, but no trace of him could be found. He had disappeared, and evidently to escape further questions:
