At the session of the Senate on the 8th inst Senator Hoar endeavored to have Friday 12th fixed as the day upon which the Senate was to vote upon the bill. Upon the proposition Senator Gorman, of this State, said : Mr. President: am indebted to the Senator from Delaware (Mr.

the suggestion of the Senator from Massachusetts at this early period of the session to fix a day so near, Friday next, on which the vote on this bil shall be taken, and I was calling attention to the fact that at the last session of Congress, when this matter was under consideration, the Senator him self, as we understood upon this side of the Chamber, and as I think the country understood, aninced that if the bill was not considered ther and should go over until this session, there would not be time in the thirteen weeks of the present session to give it due consideration and final action. Then, in view of what occurred at the popular election in November I think it became a firm con viction in the mind of everybody that probably the Senator from Massachusetts did not intend to urge, or at least would not press, the bill at this session So when we met here on Monday last, I think with one exception and that the Senator from Indiana (Mr. Turple) who had prepared a speech to be delivered at the last session, supposing the bill might then be pressed, not a single Senator on this floor had given the matter that consideration which would enable him to discuss it intelligently. And when it came up on Tuesday last on the motion of the Senator from Massachusetts, this side at least were absolutely unprepared for his motion and unprepared to discuss the bill. It therefore has dragged along every day from Tuesday until now, as we all know, being discussed, during which time quite a number of Senators have been giving it

Thus it is that we are not even on the threshold of the discussion of this bill. The developments of the last two days show that even the authors of the bill were uncertain, absolutely uncertain, as to its provisions. Of course, those of us who are not on the committee are without knowledge. Therefore, Mr. President, it does not seem to be possible in fairness, at this time, after only four or five day consideration, to even consider the suggestion of fixing a day as early as Friday next for a final vote. President, there are some of us, indeed, may say all of us, who are in the minority on this side of the body, who are conscious of the fact that the great majority of this country at the last elecwe represent, by the most overwhelming majority ever known in the history of the United States. We are not elated with that victory, but we are looking with seriousness at the condition of the country, recognizing that with our great political victory the conditions of this country are more serious than they have been at any time during my short life; that there are matters here which ought to be considered by all the members of both Houses, not as partisans but as patriots. I think I voice the sentiment of every member of the lemo-cratic party in both Houses of Congress when I say that we are perfectly prepared to day to lay aside all partisan measures, to forget that we are Democrais, and postpone all merely partisan measures that something may be done by this Congress which will stay the great calamity that so seriously threatens the American people.
We stand to day, Mr. President. volcano. But the Senator from Massachusetts brought forth his political measure on the second day of the session, and has continued to keep it before this body day by day and hour by hour, refusing even the usua time of adjournment from Friday to Monday, de priving every man in the minority of the oppor funity for want of time to go to your administration and to your leaders on that side of the Chamber and tender you our support in efforts to restore confidence in the commercial community. Those of us who have business interests who have the opportunity to feel the pulse and know what is noving, have given what short time we have had out of this body listening to these people.

Mr. President, I heard one delegation in the presence of my distinguished friend from Ohio and the senator from North Carolina representing the tobacco interest of the country, who came here to tell us that the fatal omission of a clause in the last Tariff bill, dropped out by a clerk, overlooked in our haste to leave the city, was about to wreck that great interest unless it is repaired. Instead of givng them attention we take the whole week ascertaining how we can restrict the rights of freemen and fall to do this act of justice to correct a state of things which if permitted to go on may wreck a great business interest of the country. Mr. President, read the great papers of the city of New York to-day. They tell you that the Secretary of the Treasury, taking the only action that is authorized within the law, has come again to the re-lief of the country by offering to buy \$5,000,000 of bonds; but that is a mere drop in the bucket. He has exhausted himself. He has paid out from the treasury \$100 000,000 for bonds, and the \$100,000,000 have disappeared. The banks have less money now than they had before the payment of the \$100,-000,000; and this action of his, this circular of yesterday or the day before, amounts to nothing, we are told, unless Congress shall take action; it will not stay the panic. But if the Senator from Massachusetts is to be followed, the answer must go to the country, "Let the business affairs take care or themselves; we urge and urge only as the panacea for all these troubles an election bill Mr. President, publicly, as I have said in private while I am not authorized to speak for anybody, I think I can safely say for every Democrat in Con

grees that we fully appreciate the great impending trouble. In the twelve weeks left of this session we showing 88 Republicans, 234 Democrats and 8 are prepared to join you in laying aside every measnre that is merely partisan in its character, and we will, as patriots, aid you in framing such legislation as may stop or tend to stop this trouble. It would not be fair to say that the trouble lies at your door altogether. There are possibly causes operating beyond party; I believe there are; but you are in the majority for the moment in both Houses of Congress and in the executive branch. The appeal comes up to us to meet this exigency. We are ready to do it, to join you unless you con-tinue to press, to the exclusion of these important matters, your merely partisan propositions. Now I beg of the Senator from Massachusetts to lay aside for the moment this bill which the country, as we think, has pronounced against; let it go and let us take up the matters that every class of our fellow citizens are looking for us to consider. If you do not, if you persist in the course that has been marked out by the distinguished Senator from Massachusetts, the responsibility must rest with the party in power. THE FARMERS' ALLIANCE. Its Financial Policy.

The National Farmers' Alliance, which was in session at Ocala, Florida, for about ten days, adjourned on the 8th inst. The following financial policy was adopted by a vote of 79

1st. We demand the abolition of national banks; demand that the government shall establish sub-treasuries or depositories in the several States which shall loan money direct to the people at a low rate of interest, not to exceed 2 per cent. per annum on non-perishable farm products and also upon real estate, with proper limitations upon the quantity of land and amount of money; we demand that the amount of the circulating medium be speedily increased to not less than \$50 per capita. We demand that Congress shall pass such laws as shall effectually prevent the dealing in itures on all agricultural and mechanical prod s, preserving a stringent system of procedure in trials such as shall secure the prompt conviction and imposition of such penalties as shall secure the most perfect compliance with the law. We condemn the silver bill recently passed by Congress, and demand in lieu thereof the free and unlimited coinage of silver. 4th. We demand the passage of laws prohibiting alien ownership of land, and that Congress take prompt action to devise some plan to obtain all lands now owned by aliens and foreign syndicates, and that all lands now held by railroads and other corporations in excess of such as is actually

used and needed by them be reclaimed by the government and held for actual settlers only. Believing in the doctrine of equal rights to all and special privileges to none, we demand that our national legislation shall be so framed in the future as not to build up one industry at the expense of another. We further demand a removal f the existing heavy tariff tax from the necessaries of life that the poor of our land must have.— We further demand a just and equitable system of graduated tax on incomes. We believe that the money of the country should be kept as much as ossible in the hands of the people, and hence we | demand that all national and State revenues shall be limited to the necessary expenses of the govern-We demand the most rigid, honest and just State and national governmental control and supervision of the methods of public communication and transportation, and if this control and supervision do not remove the abuse now existing we demand the government ownership of such means

GEORGE WASHINGTON'S PAPERS. The Recent Valuable Discovery of the Lewis Family-Memorials of the Father of His Country Found in an old Trunk-A Sale of These Effects the Past Week. Washingtoniana attracts so much attention now that the announcement of the discovery of the last effects of Gen. Washington and his

has occasioned the greatest interest. The sale was made by the order of H. L. D. Lewis, the administrator of Mrs. Lorenzo Lewis, as part of the estate of Major Lawrence Lewis, the favorite nephew of Washington, who married Nellie Custis, Washington's adopted daughter, and who was the son of Colonel Fielding Lewis, who married Washington's sister Bettie. Washington's private papers, deeds, leases, and drafts of his properties, a list of his negroes and the draft of his will, and his own hand writing. There are also a large folio volume the original ledger accounts of the Mt. Vernon distillery and fishery, in the year 1799, kept by his Secretary, Tobias Lear, two vouchers in the handwriting of Washington testifying to the correctness of the accounts of this volume several autograph letters of Washington, and all the rare documents and correspondence of the executors of Washington's estate, George Steptoe Washington and Lawrence Lewis, and later, upon the death of Lewis, Bushrod Wash-The greater portion of this most valuable

collection was unearthed not more than three weeks ago in a musty old trunk in the storeroom of "Audley," the county seat of the Lewises, in Virginia. The contents of this trunk had been entirely lost sight of by Mr. Lewis, and the discovery of these valuable Washington papers was a great surprise to him. PRIVATE MEMORANDUM-BOOK, General Washington's private memorandum-

book from September, 29th, 1794, to September 1787, which was found in this old trunk, is a valuable relic. It is composed of sixty closey-written pages in the handwriting of General Beorge Washington, and contains much matter of the greatest interest. WASHINGTON'S NEGROES. The "list of negroes belonging to Geo. Washington in his own right and by marriage, also those hired from Mrs. French," is an eightpage folio document of unique rarity. It is written by Washington, and gives the name of all the slaves employed on his various farms, their age, their occupation, and their relationship to each other, and how and by what manner he came in possession of each. His recapitulation shows that he owned 117 negroes. Another small memorandum book kept from September 1st 1797, to December 3d, 1799, in the handwriting of Washington is even more interesting than the one quoted from above.— Under date of July 4th, 1797, he writes: "By expenses for the celebration of the anniversary of the Independence in Alexandria, \$1.40."-On September 10th of the same year the fol lowing memorandum occurs: "Sent as a donation for the distressed inhabitants in Philadelphia to Mr. Jones, one of the managers, \$200.' This was the period of the yellow-fever epidemic. December 3d: "Charged Mr. Lawrence with cash, \$100, and with a check on the Bank of Alexandria, \$400. Credit the bank thereof, \$400." This is the last item Washing. ton made in this book, and it is noteworthy, as it was probably almost the last time he used a

pen, being written but a few days before his death. AUTOGRAPH LETTERS. There are two valuable autograph letters in the Lewis collection. One written at Mt. Vernon September 20th, 1799, to Major Lawrence Lewis informs him that by his will Washington has bequeathed to him and his wife the Dogul Run farm, upon which Lewis was very anxious to settle. Among some of the other autograph letters in the collection is one from S. W. Fairfax, dated Belvoir, November 16th, 1765, in referenco to lands. Washington has made a memorandum on the back of this letter. Upon another letter from Fairfax Washington has marked, "Letters from Honorable S. W. Fairbut he respectfully declined, and left. There'll fax." A letter to "His Excellency, Lieuten-

Two old music-books owned by Martha Parke Custis and signed by her who was later Mrs. Washington, contain some of the earliest pieces published in this country They were engraved in Philadelphia and New York. Among them is the "Battle of Trenton," a souata for the pianoforte, dedicated to General George Washington, New York, printed and sold by James Hewitt at his musical depository. Upon the title page of this music s to be found the scarcest engraved portrait of Washington known. Mr. Baker, of Philadelphia, whose tints on the portraits of Washington are well known, states that this engraving

was unknown to him. The portrait, however, he said, was after Wright. Another rare song is the "Chorus, sung before General Washington as he passed under the triumphal arch raised on the bridge at Trenton, April 21st, 1789. Set to music and dedicated by permission to Mrs. Washington author and sold by H. Rice, Market street." This chorus was sung by a number of young girls dressed in white, decked with wreaths

their hands. The chorus reads as follows: Welcome, mighty chief! Once more Welcome to this greatful shore; Now no mercenary foe Aims again the fatal blow. Virgins fair and matrons grave; Those thy conquering arm did save Build for thee triumphal bowers. Strew, ye fair, his way with flowers.

As they sung these lines they strewed the flowers before the General, who halted until the song finished. Another piece of music in this book is the 'Federal March," as performed in the grand procession in Philadelphia 4th of July, 1788, by Alexander Reinagle. Other pieces to be found in these old musicbooks are the "President's March" and "Lafay-

These pipes are exquisite pieces of Indian workmanship and are of the great interest apart from their relationship to Washington. A small Canton china tureen, which matches some other pieces of china now in possession of the Mount Vernon Society, should be secured y them to complete their set. It is decorated with the American eagle, by order of General Washington. Two silver-plated, on copper secretary caudiesticks, are of more than usual family, which were sold in Philadelphia, interest, as they were used by Washington frequently to furnish light for writing the many latters which he was accustomed to pen by early candlelight.

MARTHA WASHINGTON'S BIBLE. Because of the repugnance of the adminis tration to sell strictly family relic, Martha Washingthn's Bible does not appear in the catalogue of the sale. Mr. Lewis has at last, however, decided to dispose of this book, which will, therefore, become foremost amongst the many interesting objects in the sale. The volume is thick quarto, bound in plain calf, and is covered, probably by Mrs. Washington herself, with strong, unbleached linen cloth. apparently of household manufacture. It was published at Oxford in 1789, and loubtless one of the many Bibles which were hurried into the United States after the Revolution, thus destroying the sale of the American publications, which were put upon the market at about the same period. There are six large folded maps, including "plan of the city of Jerusalem and an impressive view of King Solomon's Temple" in this old Bible. It is also illustrated with nearly three hundred curious copper-colored engravings by John Sturt, "from designs of the greatest masters.'. These engravings do not prop erly belong to this book, as they were published in London in 1715, in a very singular work, now quite rare. They were probably inserted in the Bible by Mrs. Washington for the purpose of making it more attractive for children. The perfect condition of the Bible and plates

and absence of stains and other disfiguring marks on it plainly show, however, that Mrs. Washington never allowed its youthful readers to forget the homage due her cherished book. Five pages of the preliminary blank leaves are occupied with the family record of Lawrence Lewis, who married Miss Nellie Parke Custis. The first entry reads as follow: rence Lewis, born 4th April, 1767;" "Nellie Parke Custis, born 31st March, 1779;" "Married at Mount Vernon on Friday 22d February, 1799, in the presence of Gen. and Mrs. Martha Washington." We are told by this interesting record that "Major Lawrence Lewis died at Arlington House 20th November, 1839, in his 73d year," and his wife, "Mrs. Eleanor Parke (Custis) Lewis, died 15th July, 1852, at Audley. Editor JOURNAL:

NEW YORK, Dec. 9th, 1890.

This letter will conclude the correspondence on "Things in New York," and then, if you will permit, the slow, snail-like, lazy progress of Baltimore will be commented on.
