by stirring up of Sutes amongst them to aduance their fees for the production  
whereof for the future and for the quiett of the good people aforesaid Be it  
Enacted by the Right Hon<sup>ble</sup> The Lord Proprietary by and with the aduice and  
assent of the upper and lower house of this present Generall Assembly That from  
and after the end of this present Session of Assembly noe Clerke or other person  
that shall haue any thing to doe with the Records of the Provinciaall Court as  
a Clerke shall during the tyme as he shall be soe Clerke of the said Court  
or haue any thing to doe with the Records thereof p<sup>l</sup>ead in the Provinciaall Court  
as an attorney vnder the penalty of two thousand pounds of Tobacco for every  
Cause that he shall soe p<sup>l</sup>ead in the said Provinciaall Court two third partes  
thereof to be forfeited to the Lord Proprietary to be disposed of for the use of  
the Publick at the discretion of the Justices of the said Court and the other  
third part to the Informer or him or them that shall sue for the same The  
said fines to be Recouered in any Court of Record within this Province  
by Bill plaint or Information wherein noe Escoyne protection or waager  
of Law to be allowed. And be it further Enacted and ordeined by the  
Authority aforesaid by and with the aduice & assent aforesaid That from  
and after the End of this present Session of Assembly Noe Sheriffe Sub  
=sheriffe or Deputy Sheriffe of any County or Clerke Sub Clerke or Deputy  
Clerke of any County Court or other person that hath any thing whatsoeuer  
to doe with the Records of the said County Court shall in the said County Court  
where he is Sheriffe Subsheriffe or Deputy Sheriffe Clerke Sub Clerke or  
Deputy Clerke or hath any thing to doe with the Records as aforesaid p<sup>l</sup>ead  
as an attorney within the said County Court within this province for any person  
whatsoeuer That for every such Cause he shall soe p<sup>l</sup>ead in the said County  
Court within this Province of which County he is Sheriffe Subsheriffe or  
Deputy Sheriffe or of which County Court he is Clerke Subclerke or Deputy  
Clerke or hath any thing to doe with the Records of the said Court he shall  
forfeite for every such offence the sume of two thousand pounds of Tobacco two  
third partes thereof to be forfeited to the Lord Proprietary to be disposed on  
to the defraying the Charge of wolest heads and the poore of the County wherein  
the offence shall be committed by the order & at the discretion of the Commissioners  
of such County from time to time or the Major partes of them the other  
third part to the Informer or him or them that shall sue for the same the  
said fines to be Recouered in any Court of Record within this Province by  
Bill plaint or Information wherein noe Escoyne Protection or waager of  
Law to be Allowed -
