

Runaway to Reimburse the said County by Seruitude or otherwise as the
Justices of the Provinciall Court or County Court shall think fitt —

And Bee itt further enacted by the Authority aforesaid That at what
tyme soever any of the aforesaid persons runaways shall be soe seized by
any person or persons within this Province such person or persons soe seizing
or apprehending the same shall bring or cause him or them to be brought before
the next Magistrate or Justice of the County where such Runaway is
apprehended who is hereby Impowred to take into his Custody or otherwise
him her or them to secure & dispose as he shall think fitt untill such person
or persons seized or apprehended shall give sufficient Security to answer the
Promises the next Court that shall first Infuse in the said County who is alsoe
to secure such person or persons untill he or they can make Satisfaction to the
party that shall soe apprehend or seize such Runaway or other person
as by this Act is Required Except such person shall make Satisfaction as
aforesaid before such Court shall happen And that notice be conveniently
given to the master mistresse or Dame of any Runaways taken upp as
aforesaid the Justice of the Peace or Commissioner of the County shall forthwith
cause anoate of the Runaways name to be seized & apprehended as aforesaid
to be set upp at the County Court where such person is seized or apprehended
as aforesaid And alsoe cause anoate to be set upp at the next adjacent County
Courts & all the Provinciall Court or Secretaries offices that all persons may
view the same & see where such their servants are in whose Custody —

And furthermore for the better ascertaining of what each servant according
to the custome of the Country shall have all the Expiration of the tyme of their
Seruitude Bee itt enacted by the authority & advice and consent aforesaid That
Every man servant shall at such tyme of Expiration of his Seruitude aforesaid
have allowed and given him a good Coat such either of Kersy or Broad Coat
a. Theft of which Linen to be new one new pair of Stockes & Stockens two
hoods one axe & three barrells of Indian Corn all women servants all the tyme
of the Expiration of their Seruitude as aforesaid shall have allowed and given
her the like provision of Coathes & Corn as aforesaid —

And to the intent the many great mischiefs & inconveniences arising
& accruing to divers good people of this Province by the transporting
Carrying or Conveying away or causing to be transported Carried or Conveyed
away out of this Province any Inhabitant within this Province whether
master or freedman not therunto lawfully Licensed or any apprentices
hired or other servant or Slave may for the future be prevented —
Bee itt further enacted by the Authority aforesaid by and with the advice &
consent aforesaid That every person or persons that shall soe transport carry
or convey away or cause to be transported Carried and Conveyed away out
of this Province any Inhabitant of this Province as aforesaid that is or
shall be indebted or engaged here & not having a sufficient License or
passe according to the Law of this Province in that case made & provided
shall
