

Tobacco for every such servant for the use of the foots Company to Purchase Drums
and Colours and other Necessaries for the Company as the Comander shall think fit
where such default is made Provided that this Clause be not to Content any
officer or officers to provide Arms or Ammunition for any further Expedition or Service
than Traynings but that upon all such occasions they be supplied out of the County
Magazines or Store. All which forfeitures and forfeitures shall by such Colonel Major
or Captain be Certified to the Commissioners of the County Court for such County at the Court
then next ensuing who are hereby Authorized upon such Certificate (not sufficient
Excuse appearing to them) to award Execution against the goods & Chattels of such
person so refusing neglecting or failing as aforesaid and that upon Occasion
of all such Executions all every County Clerke & Sheriffe within this Province
respectively shall do what pertaineth to their office without any fee or Reward

And for that the Inhabitants of this Province are many of them unprovided of fixed
Guns and that they may have time to provide themselves with Arms & Ammunition
for Trayning according to this Act and not be surprized Be it enacted and ordained
by the Authority aforesaid by and with the Consent and advice aforesaid That any of the
said fines by virtue of this Act set or imposed upon any person or persons for default
of appearing at Mustering and Traynings as aforesaid the Levying thereof shall be
respected for eightene months to be computed from the end of this Session of assembly
And any person or persons that shall be soe fined as aforesaid that within the said terme
of eightene months shall appear in the field with Arms and Ammunition as aforesaid
bring his own proper goods all those fines that have been putt upon him & soe
respected as aforesaid shall never hereafter be Levied but Expunged out of the Roll
and list of fines and any person or persons that shall be soe fined as aforesaid that
within the said Terme of eightene months shall not be provided with Arms &
Ammunition of his own proper goods as aforesaid all those fines that have been putt
upon him & soe respected as aforesaid shall be forthwith Levied to the use aforesaid
For the Settlement of the Horse forces that each Captain of Horse in each respective
County shall for the making up his Troop select and enlist his number of
men out of the Inhabitants of the said County according to such instructions as he
shall from time to time Receive from the Lord Proprietary his heires and
Successors or his or their Lieutenant for the time being Provided allways that
such Troopers shall ride their own horses and that noe person shall be a Trooper
without he be owner of a good serviceable horse which shall passe muster And
That such Troopers in Consideration of their great pay hereafter to be allowed be
bound and obliged to find themselves with good able and sufficient Furniture for
their Horses and likewise to find themselves with Sword Carbins Pistols Holsters
Ammunition And if any Trooper shall neglect or Refuse upon notice given to this
